## INDEPENDENT AUDITOR'S REPORT

### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed an audit of the financial statements of U.S. Engine Valve Company 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. ## NOTES TO FINANCIAL STATEMENTS

### U.S. Engine Valve Company 401(k) Plan

#### **1 Description of Plan**

The following description of U.S. Engine Valve Company 401(k) Plan (“Plan”) provides only general information. Participants should refer to the Plan document for a complete description of the Plan’s provisions.

##### ***General:***

The Plan, which began July 1, 1988, is a defined contribution plan covering all employees of U.S. Engine Valve (“Company”) who meet the hour and age requirements. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Plan was previously amended to comply with all required regulatory changes.

##### ***Eligibility:***

All employees of the Company age twenty-one and older, except employees covered by a collective bargaining agreement and nonresident aliens who do not receive any earned income from the Company which constitutes United States source income, are eligible to participate in the Plan immediately upon hire.

##### ***Contributions:***

Each year, participants may contribute a pre-tax salary deferral contribution, as defined in the Plan. Any new hires or re-hired employees who have not already elected to participate in the Plan will be automatically enrolled, upon meeting eligibility requirements at a 3% pre-tax contribution rate. Participants who have attained age 50 before the end of the Plan year are eligible to make catch up contributions. Participants may also designate elective deferrals as Roth contributions to the Plan.

The Company may make a discretionary match. During 2024 and 2023, the Company contributed 50% of the employees’ elective contributions made, not to exceed 6% of the participants’ compensation.

The Company may also make a profit-sharing contribution in an amount determined each year by the Company. Each participant’s share of any such additional contribution shall be based upon the ratio which that participant’s salary bears to the salaries of all other participants receiving the contribution. In addition, the Company may also choose to contribute the same dollar amount for each participant. During 2024 and 2023, the Company made no profit-sharing contributions to the Plan.

Rollover contributions from other plans are also accepted, providing certain specified conditions are met.

Upon enrollment, a participant may direct employee and employer contributions to any of the Plan’s fund options. Participants may also transfer all or part of previously invested funds to another option or options at any time.

##### ***Participants’ Accounts:***

Each participant’s account is credited with the participant’s elective contributions, employer matching contributions, employer profit-sharing contributions, and earnings and losses thereon.

**1 Description of Plan, Continued**

***Vesting:***

All participants are 100% vested in elective deferrals, profit-sharing, and rollover contributions made to the Plan. All participants hired after September 1, 2010, are vested in both the non-elective employer contribution and matching contribution as follows:

***Forfeitures:***

As of December 31, forfeited non-vested accounts totaled \$78,039 (2024) and \$26,216 (2023). Future employer contributions will be reduced by these amounts. No forfeitures were used to reduce employer contributions in 2024 or 2023.

***Notes Receivable from Participants:***

Loans are permitted under certain circumstances and are subject to limitations. Participants may borrow from their fund accounts up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. Loans are repaid over a period not to exceed 5 years with exceptions for the purchase of a primary residence. Loans are valued at unpaid principal plus accrued unpaid interest. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent participant loans are recorded as distributions on the basis of the terms of the Plan agreement.

The loans are secured by the balance in the participant's account and bear interest at rates established by the Plan Administrator. Principal and interest are paid ratably through payroll deductions.

***Payment of Benefits:***

Upon termination of service by reason of separation of service, retirement, death or total and permanent disability, a participant may choose a full or partial payment, a monthly annuity for the duration of the participant's life, or a partial payment combined with an annuity. Benefit payments are recorded when paid.

***Hardship Withdrawals:***

Hardship withdrawals are permitted in accordance with Internal Revenue Service guidelines.

**2 Summary of Significant Accounting Policies**

***Basis of Accounting:***

The Plan's transactions are reported on the accrual basis of accounting.

## NOTES TO FINANCIAL STATEMENTS

#### **2 Summary of Significant Accounting Policies, Continued**

##### ***Valuation of Investments:***

Investments held in the Plan are stated at fair value. Marketable securities are reported at fair market value as of the balance sheet date. Fair market values represent quoted market prices, or, if quoted market prices are not available, estimated fair values as determined by the Plan's investment broker. The fair value of the common collective trust is calculated based on the underlying investments held in the portfolio and include: 1) discounting the related cash flows based on current yields of similar instruments with comparable durations, 2) pricing as reported by third party vendors or brokers, or 3) the closing net asset value.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments purchased and sold as held during the year.

##### ***Use of Estimates:***

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosures of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenue and expenses during the reporting period. Actual results could differ from those estimates.

##### ***Administrative Fees:***

Substantially all administrative fees are paid by the Company.

##### ***Plan Termination:***

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

##### ***Risks and Uncertainties:***

The Plan's investments include interests in mutual funds and a common collective trust fund holding investment contracts with varying degrees of risk, such as interest rate, credit, and overall market volatility risks.

Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect the amounts reported in the Statement of Net Assets Available for Plan Benefits.

##### ***Contributions:***

Contributions from plan participants and the employer matching contributions from the employer are recorded in the year in which the employee contributions are withheld from compensation.

#### **2 Summary of Significant Accounting Policies, Continued**

##### ***Subsequent Events:***

Management evaluates events occurring subsequent to the date of the financial statements in determining the accounting for and disclosure of transactions and events that affect the financial statements.

Subsequent events have been evaluated through September 29, 2025, which is the date the financial statements were available to be issued.

#### **3 Tax Status**

The Internal Revenue Service has determined and informed the Company by letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken uncertain tax positions that more-likely-than-not would not be sustained upon examination by applicable taxing authorities. The Plan Administrator has analyzed tax positions taken by the Plan and has concluded that, as of December 31, 2024, there are no uncertain tax positions taken, or expected to be taken, that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions. However, currently no audits for any tax periods are in progress.

#### **4 Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy under Topic 820 are described as follows:

Level 1: Inputs to the valuation methodology are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan can access at the measurement date.

Level 2: Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- \* Quoted prices for similar assets or liabilities in active markets;

- \* Quoted prices for identical assets or similar assets or liabilities in inactive markets;
- \* Inputs other than quoted prices that are observable for the asset or liability;
- \* Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs that are unobservable inputs for the asset or liability.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

***Mutual Funds:***

The fair value of the mutual funds are based on quoted market prices.

***Common Collective Trust:***

The fair value of the common collective trust is based on the net fair value of the underlying assets. The underlying investments are valued at fair value based on commercial quotation services. The fair value is allocated among the contract holders based on a unit value. These fall into the Level 2 category of the valuation hierarchy. Participant transactions (purchases and sales) may occur daily. In unusual market conditions, the Trustee may in its sole discretion, impose restrictions on issues and redemptions of units.

The following table sets forth by level, within the fair value hierarchy, the Plan's assets at fair value as of December 31, 2024 and 2023. Classifications within the fair value hierarchy table is based on the lowest level of any input that is significant to the fair value measurement.
