## INDEPENDENT AUDITOR'S REPORT

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the Financial Statements

We have performed audits of the accompanying financial statements of **Asian Americans Advancing Justice - Los Angeles 403(b) Plan** (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

### Note A – Description of Plan

The following description of the Asian Americans Advancing Justice - Los Angeles 403(b) Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

#### General

The Plan, established effective July 1, 2003 and most recently restated effective November 1, 2023, is a defined contribution 403(b) plan covering all employees of Asian Americans Advancing Justice - Southern California and its participating employers (the “Company” or the “Employer”), excluding those on loan from other non-profit organizations. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

#### Administration of the Plan

The accounting records are maintained by the Company. The Plan’s assets are held and managed by The Variable Annuity Life Insurance Company and Principal Trust Company (the “Custodians”). In July 2024, the Plan transferred approximately \$5,000,000 of participant funds to Principal Trust Company. Contributions are held by the Custodians who invest cash received, interest and dividend income, as directed by the participant, and make distributions to participants.

#### Contributions

Participants may contribute up to 100% of their compensation to their participant account subject to limitations imposed by the Internal Revenue Code (“IRC”). The maximum participant deferral for the year ended December 31, 2024 was \$23,000. A participant who has attained the age of 50 may also make catch up contributions, subject to IRS limitations of \$7,500 for the year ended December 31, 2024. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.

The Employer has the option to make discretionary matching contributions as a percentage of any salary deferrals, after-tax contributions, or as a uniform dollar amount. In order to qualify for the contribution, a participant must have completed a year of service with 700 hours worked during the computation period, as defined in the Plan documents.

The Employer contribution percentage was based on the participant’s years of service and was determined according to the following schedule:

Years of Services	Employer Contribution Percentage
Less than 1 year	0%
1 - 5	4%
6 - 10	5%
11 or more	6%

Participants direct the investment of their contributions and Employer contributions into various investment options offered by the Plan.

#### Participant Accounts

Each participant’s account is credited with the participant’s contributions and the Company’s matching contributions. Each participant’s account shall be allocated earnings, gains, expenses, and losses with respect to the investments of the participant’s account. Allocations of Plan earnings or losses are based on each participant’s investment fund balance in proportion to the total investment fund balance.

#### Vesting

Participants are immediately vested 100% in their voluntary contributions, after-tax contributions and Employer contributions plus actual earnings or losses thereon.

#### Notes Receivable from Participants

Participants may borrow from funds accumulated through participant elective deferrals a maximum equal to the lesser of \$50,000 or 50% of their account balance. These loans are collateralized by the balance in the participant's account and bear interest at prevailing rates as determined by the Plan Administrator. Loan transactions are treated as a transfer to (from) the investment fund from (to) the participant notes receivable. Loan terms can be up to five years, unless it is used to acquire a principal residence, in which case the repayment period may not extend beyond ten years from the date of the loan. Principal and interest are paid by payroll deduction in substantially equal payments over the life of the loan, with payments not less frequently than quarterly.

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Non-payment of the quarterly loan principal and interest due within 30 days after the due date will constitute default. The entire balance of the loan will be reported as a taxable distribution, subject to tax at ordinary income tax rates and possibly subject to a 10% early distribution tax. Participant account balances held as security for the loan will be foreclosed upon by the Trustee for the Plan after a distribution under the terms of the Plan and law are permitted. Repayment of the defaulted loan is permitted until the foreclosure date. Until foreclosure, the Trustee will pay an interest rate on the secured balance for the loan equal to the rate being charged. Thus, the total interest due on the defaulted loan will be paid in full at the date of foreclosure from the interest earned on the secured portion of the participant's account. Additional loans will not be granted prior to foreclosure of a defaulted loan.

#### Distribution of Benefits

On termination of service due to death, disability or retirement, or any other reason, a participant may elect to receive their distribution in the form of a qualified joint and survivor annuity, life annuity, qualified pre-retirement survivor annuity, or a lump-sum, as defined in the Plan agreement. The distribution of Plan benefits is made through the purchase of an annuity or in cash. Distribution of benefits begins within 60 days after the Plan year in which the latest of the following occurs: 1) participant reaches the age of 65 or normal retirement age, 2) the 10<sup>th</sup> anniversary of the year in which the employee became a participant, 3) termination of employment. Participants may also obtain distributions from their elective deferrals balances while still employed after the participant reaches age 59 ½. Participants may request a hardship withdrawal for qualifying expenses. Participants may also obtain in-service distributions from their after-tax balances accounts at any time.

#### Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, all appropriate accounting provisions of the Plan will continue to apply until the accounts of all participants have been distributed.

### Note B – Summary of Significant Accounting Policies

#### Basis of Presentation

The accompanying financial statements are presented on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("US GAAP").

#### Use of Estimates

The preparation of financial statements in conformity with US GAAP requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and the changes in net assets available for benefits and disclosure of contingent assets and liabilities during the reporting period. Actual results could differ from these estimates.

#### Valuation of Investments

The Plan's investments in mutual funds are stated at fair value, except for the fully benefit-responsive investment contracts, which are reported at contract value as described in Note G. Fair value is based on quoted market prices at year-end as reported by the Custodians.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

#### Payment of Benefits

Benefits are recorded when paid.

#### Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Employer. Expenses that are paid by the Employer are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

#### Fair Value Measurements

The FASB has established a framework for measuring fair value in ASC 820, *Fair Value Measurements*. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described below:

#### Fair Value Measurements (continued)

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### Note C – Certified Investments

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by The Variable Annuity Life Insurance Company and Principal Trust Company, qualified institutions. As of December 31, 2024 and 2023, and for the year ended December 31, 2024, the Plan Administrator instructed the auditors not to perform any auditing procedures with respect to the information certified by The Variable Annuity Life Insurance Company and Principal Trust Company, except for comparing such information to the related information included in the financial statements, as permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

### Note D – Income Tax Status

403(b) plans currently are not required to submit plans to the Internal Revenue Service for determination. However, the Plan Administrator believes that the Plan was designed and is being operated in compliance with the applicable requirements of the IRC.

The Plan Administrator evaluated the Plan's tax positions and concluded that the Plan had maintained its tax-exempt status and had taken no uncertain tax positions that require adjustment to the financial statements. Therefore, no provision or liability for income taxes has been included in the accompanying financial statements. The Plan is no longer subject to examination by taxing authorities for years prior to 2021.

### Note E – Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### Note F – Party-In-Interest Transactions

Section 3(14) of ERISA defines a party-in-interest to include, among others, fiduciaries or participants of the Plan, any person who provides services to the Plan, or an employer whose employees are covered by the Plan. Certain Plan investments are mutual funds and investment contracts managed by the Custodians. Transactions related to these investments qualify as party-in-interest transactions. Fees paid to parties-in-interest by the Plan for services amounted to approximately \$17,000 during the year ended December 31, 2024.

The Plan invests in guaranteed interest accounts ("the Funds") provided through group annuity contracts. Under the Funds, crediting rates are established and are credited with contributions and charged for participant withdrawals and administrative expenses charged by the Trustee of the Funds. The guaranteed interest account issuers are contractually obligated to repay the principal and a specific interest rate that is guaranteed to the Plan.

The Funds require that any transfer of the investment made by the Plan are restricted to annual 20% increments. The annuity contracts do not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.
