## INDEPENDENT AUDITOR'S REPORT

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

I have performed audits of the accompanying financial statements of Central Maintenance & Welding, Inc. 401(k) Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted, by ERISA Section 103(a)(3)(C), my audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### Opinion

In my opinion, based on my audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section –

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America



- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion**

I conducted my audit in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of my report. I am required to be independent of the Plan and to meet my other ethical responsibilities in accordance with the relevant ethical requirements relating to my audits. I believe that the audit evidence I have obtained is sufficient and appropriate to provide a basis for my ERISA Section 103(a)(3)(C) audit opinion.

### **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

My audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

I am required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

**NOTE 1 – PLAN DESCRIPTION**

*General:*

The following is a summary of major Plan provisions of the Central Maintenance & Welding, Inc. 401(k) Profit Sharing Plan (the “Plan”). Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

The Plan was established by Central Maintenance and Welding, Inc. (the “Company” or “Plan Sponsor”) as a defined contribution plan effective August 31, 1974, and was restated effective October 2022 in order to implement a change in the definition of eligible compensation and to include automatic enrollment provisions which become effective January 1, 2023. All other provisions of the Plan remained the same. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

On December 29, 2022, Congress passed the Consolidated Appropriations Act of 2023, which includes the package of retirement provisions referred to as “SECURE 2.0”. These provisions continue the themes and reforms that began with the 2019 SECURE Act, focusing on getting more participants into the retirement system, finding ways for them to accumulate more assets, and then ensuring they get connected with those assets when retirement comes. The provisions of the SECURE 2.0 include both required and optional elements and have various effective dates starting in 2023 and forward.

*Participation:*

All employees of the Company not subject to a collective bargaining agreement, who have completed at least 90 days of service, and have attained the age of 18 are eligible to participate. Participants are eligible to receive discretionary matching contributions and discretionary non-elective contributions after 1 year of service, provided they worked at least 1,000 hours during such year.

*Contributions:*

Participants may contribute up to 100% of eligible compensation, subject to certain limitations, on an annual basis. Employees who meet certain age requirements are also permitted to make catch-up contributions. Contributions to the Plan may be made as normal 401(k) pre-tax contributions or on an after-tax basis as Roth contributions. Participants who meet certain age requirements before the end of the Plan year are also eligible to make catch-up contributions. Additionally, the Plan permits rollovers from other qualified retirement plans. Participants direct the investment of their contribution into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% on a pre-tax basis of eligible compensation and contributions are automatically invested in a designated fund until changed by the participant. After each year of service, the deferral rate is raised by 1% until the deferral rate reaches 6%. Automatically enrolled participants may opt out of participating and withdraw amounts contributed within 90 days of the first automatic deferral.

The employer may make discretionary employer matching contributions, based on a percentage determined by management, which is computed based on the participants' elective contributions. For the year ending December 31, 2024, the Plan Sponsor made approximately \$185,000 in discretionary matching contributions.

The employer may also make discretionary non-elective contributions based on a percentage, as determined by management, of a participant's eligible compensation. For the year ending December 31, 2024, the Plan Sponsor made approximately \$5,500 in discretionary non-elective contributions funded by the allocation of forfeitures in 2025.

*Other Income:*

A portion of service fees may be returned to the Plan based on a revenue sharing arrangement. The revenue sharing amounts received are credited to an ERISA expense account, which is used to pay administrative expenses incurred by the Plan. During 2024, the Plan did not earn any fee income, and paid approximately \$42,000 in administrative expenses of which none were funded by the ERISA expense account. As of December 31, 2024 and 2023, the balance in the ERISA expense account was \$0.

*Participant Accounts:*

Each participant's account is credited with the participant's contribution, allocations of the employer's discretionary matching contributions and discretionary non-elective contributions, Plan earnings, and administrative expenses. Employer contributions are credited to participant accounts based on specific allocations as previously described in "Contributions". Allocations of Plan earnings and administrative expenses are based on the individual account balance as a percentage of total invested assets. The benefit to which a participant is entitled is the vested balance in the participant's account.

*Vesting:*

Participants are vested immediately in their contributions and actual earnings thereon. Participants become vested in employer matching and non-elective contributions as follows:

4 years	60%

6 years	100%

Additionally, participants become 100% vested upon normal retirement, death, permanent disability, or termination of the plan.

*Payment of Benefits:*

Upon termination of service due to death, disability, or retirement, a participant may elect to receive an amount not to exceed the value of the participant's vested interest in his or her account in either a lump-sum amount, annual installments over the life of the participant, or installments over a period of time not to exceed the assumed life expectancy of the participant or beneficiary. The beneficiary of a deceased participant may also elect to receive benefits over a period of time not exceeding the life expectancy of the beneficiary. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. The Plan permits in-service and hardship withdrawals under certain conditions.

*Forfeitures:*

Pursuant to the Plan document, the nonvested portion of discretionary non-elective contributions credited to the accounts of participants who withdraw from the Plan are forfeited and held as nonparticipant-direct investments. These amounts may be allocated to qualifying participants as an additional discretionary non-elective contribution. The Plan had approximately \$5,500 and \$30,000 of forfeitures available to be reallocated to eligible participants as of December 31, 2024 and 2023, respectively. The Plan Sponsor allocated approximately \$30,000 and \$5,500 of forfeitures as discretionary non-elective contributions effective for the 2023 and 2024 Plan years, respectively, which were funded in 2024 and 2025, respectively.

**NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

*Basis of Accounting*

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

*Investment Valuation and Income Recognition:*

The Plan's investments are reported at fair value (Note 3). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. The net appreciation in fair value of investments includes the Plan's realized gains and losses on investments bought and sold as well as unrealized gains and losses on investments held during the year.

*Payment of benefits:*

Benefits are recorded when paid.

*Uses of estimates:*

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions to and deductions from net assets during the reporting period. Actual results could differ from those estimates.

**NOTE 3 – FAIR VALUE MEASUREMENT**

The Plan’s investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values.

Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in different fair value measurement at the reporting date.

Fair value determinations are made based upon a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 Measurements).

The three levels of the fair value hierarchy are described as follows:

- Level 1 – Inputs to the valuation methodology are unadjusted quoted prices available in active markets for identical assets or liabilities as of the reporting date.
- Level 2 – Inputs to the valuation methodology are other than quoted prices in active markets that are either directly or indirectly observable as of the reporting date, and fair value can be determined through the use of models or other valuation methodologies.
- Level 3 – Inputs to the valuation methodology are unobservable inputs about which little or no market data exists for the asset or liability, therefore requiring an entity to develop its own assumptions

The asset or liability’s level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. The following are descriptions of the valuation methodologies used for instruments measured at fair value, including the general classification of such instruments pursuant to the valuation hierarchy. There have been no changes to methodologies used during 2024.

*Mutual Funds* – These investments are public investment vehicles valued using the net asset value (“NAV”) provided by the administrator of the fund. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded and classified within Level 1 of the valuation hierarchy.

*Fixed Account* – This investment is an investment contract valued using a discounted cash flow valuation methodology where the interest rate for the investment contract is reset at least as frequently as annually where fair value, prior to contract termination, equals contract value calculated as the sum of all contributions, deposits and interest credited to the fixed account less any distributions, transfers out of the fixed account, and expenses. The fixed account held by the Plan is classified within Level 2 of the valuation hierarchy.

The Empower Pre-Approved Plan is a qualified plan under Section 401(k) of the internal Revenue Code (“IRC”) and, as such, is exempt from federal income taxes under Section 501(a) of the IRC. The Empower Pre-Approved Plan obtained its latest determination Letter on November 14, 2022 in which the IRS stated that the Plan, as then designed, was in compliance with the applicable requirements of the IRC.

Plan management has analyzed the tax positions taken by the Plan, and has concluded as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 7 – ADMINISTRATIVE EXPENSES**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from the accompanying financial statements. Expenses relating to specific participant transactions are charged directly to the participant’s account and are included in administrative expenses in the accompanying financial statements. Investment related expenses are included in net appreciation in fair value of investments.

**NOTE 8 – PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are managed by Empower Annuity Insurance Company of America, a qualified institution, and, therefore, these transactions qualify as party-in-interest transactions. The services performed by Empower Annuity Insurance Company of America and Empower Trust Company, LLC, a Trustee as defined by the Plan, qualify as party-in-interest transactions. Fees paid during the year for recordkeeping and other services rendered by parties-in-interest were based on customary and reasonable rates for such services, as permitted under ERISA.

**NOTE 9 – RISKS AND UNCERTAINTIES**

The Plan provides for various investment options in investment securities. Investment securities, in general, are exposed to various risks, such as interest rate, credit and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

**NOTE 10 – PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan. In the event of Plan termination, participants would become 100% vested in the Plan Sponsor contributions in their accounts.

**NOTE 12 – SUBSEQUENT EVENTS**

There were no subsequent events that require adjustment to the financial statements or disclosure in the financial statements. Subsequent events have been evaluated through October 8, 2025 which is the date the financial statements were available to be issued.
