### 1. Description of Plan

The following brief description of Hughes Pittman & Gupton, LLP Retirement Savings Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### *General*

The Plan was a safe harbor defined contribution plan established May 1, 2001, by Hughes Pittman & Gupton, LLP (the "Company") and was amended and restated effective January 1, 2022. The Plan covered all employees of the Company who had completed 6 months of service and were age 21 or older other than union employees, non-resident aliens with no US source income, leased, and part-time, temporary, or seasonal employees who were regularly scheduled to work less than 1,000 hours per year. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Effective February 1, 2024, the Company merged with EisnerAmper, an accounting firm. On January 17, 2024, the Company decided to terminate the Plan with an effective date of January 31, 2024. All active participants were already 100 percent vested in their account balances, and all distributions were paid out by December 23, 2024.

#### *Contributions*

The following provisions were in place until the Plan was terminated. Each year, participants could contribute up to 100% of compensation subject to certain Internal Revenue Code ("IRC") limitations. Participants could also contribute amounts representing distributions from other qualified retirement plans. Participants who attained age 50 before the end of the Plan year were eligible to make catch-up contributions. The Company made an annual non-elective contribution of 3% of all eligible employees' compensation, as defined by the Plan. Contributions were subject to certain limitations.

#### *Participant Accounts*

Each participant's account was credited with the participant's contributions, employer safe harbor non-elective contributions, and Plan earnings (losses). Participants were also charged with an allocation of administrative expenses not paid by the Plan Sponsor. Allocations were based on participant earnings or account balances, as defined. The benefit to which a participant was entitled is the benefit that could be provided from the participant's vested account. Participants directed the investments of their contributions into various investment options offered by the plan. The Plan held unitized mutual funds and a fully benefit responsive investment contract.

#### *Notes Receivables from Participants*

The following provisions were in place until the Plan was terminated. Participants could borrow a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance, whichever was less, subject to some reductions for prior note balances as defined in the Plan document. Participants could only have one plan note outstanding at any one time. The notes receivable were secured by the balance in the participant's account and bore interest at a reasonable rate established by the Plan Administrator, which was the prime rate plus 1%. During the period from January 1, 2024 through December 23, 2024, interest rates ranged from 4.25% to 6.50%. Principal and interest were generally paid through payroll deductions.

### ***Vesting Requirements***

Participants were vested immediately in their elective deferral contributions, safe harbor Company contributions, and actual earnings thereon.

### ***Benefit Payments***

Upon termination of service due to death, disability, or retirement, a participant could have elected to receive a single lump-sum equal to the value of the participant's vested interest in his or her account. Partial payments and installments were only permitted for required minimum distributions. The Plan permitted early retirement at attainment of age 55. The Plan also allowed for hardship distributions, if certain criteria were met, as well as in-service withdrawals upon attainment of age 59.5. Involuntary distributions could be made by the Plan Sponsor for terminated participants with account balances less than \$5,000.

## **2. Summary of Significant Accounting Policies**

### ***Basis of Accounting***

As the Plan has been terminated, these financial statements are prepared on the liquidation basis of accounting. The change from accrual basis to liquidation basis has not had an impact to the financial statements.

### ***Use of Estimates***

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### ***Investment Valuation and Income Recognition***

Investments were reported at fair value except for the fully benefit responsive contract, which was reported at contract value. Fair value of a financial instrument is the amount that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (the exit price). See Note 4 for discussion of fair value measurements.

Purchases and sales of securities were recorded on a trade-date basis. Dividends were recorded on the ex-dividend date. Interest income was recorded on the accrual basis. Net appreciation/depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the period.

### ***Notes Receivable from Participants***

Notes receivable from participants were measured at their unpaid principal balance plus accrued but unpaid interest. Interest income was recorded on the accrual basis. Delinquent notes receivable from participants were recorded as distributions based upon the terms of the plan document. No participant loans defaulted during the period from January 1, 2024 through December 23, 2024.

### ***Benefits Paid to Participants***

Benefits paid to participants were recorded when paid.

### ***Plan Expenses***

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants and the processing of distributions are charged directly to the participant's account and are included in administrative expenses. Additionally, administrative fees paid to the third-party administrator and custodian are included in plan expenses. Investment related expenses are included in net appreciation/depreciation of the fair value of investments.

### **3. Unaudited Information**

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-5(c) of the Department of Labor Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Nationwide Trust Company, FSB, ("Nationwide"), the certifying entity of the Plan, has certified that the following data included in the accompanying financial statements is complete and accurate.

The Plan's independent accountants did not perform auditing procedures with respect to this information, except for comparing such information to related information in the financial statements.

### **4. Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

**Level 1:** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets.

**Level 2:** Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3:** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes to the methodologies used at December 23, 2024 and December 31, 2023.

*Mutual Funds:* These investments are public investment vehicles valued using the Net Asset Value ("NAV") provided by the administrator of the fund. They are valued at the closing price reported in the active market in which the individual mutual funds are traded. These mutual funds are unitized which results from the funds being pooled, then subtracting the liabilities and dividing by the number of units outstanding. As such they are considered level 2 investments.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

There were no remaining assets in the Plan as of December 23, 2024. The following tables set forth by level, within the fair value hierarchy, the Plan's investments at fair value as of December 31, 2023:

## 5. Guaranteed Investment Contract with Nationwide Life Insurance Company

The Plan had a fully benefit responsive guaranteed investment contract with Nationwide Life Insurance Company ("Nationwide Life"). Nationwide Life maintained the contributions in a general account. The account was credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer was contractually obligated to repay the principal and a specified interest rate that was guaranteed to the Plan.

Contract value, as reported to the Plan by Nationwide Life, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Until termination, participants could ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There were no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate was based on a formula agreed upon with the issuer, but could not be less than 1.50%. Such interest rates were reviewed on a quarterly basis for resetting.

There were no remaining assets in the Plan as of December 23, 2024. The value of the Nationwide Life Fixed Select Option was \$209,519 at December 31, 2023.

### **6. Tax Status**

The Internal Revenue Service ("IRS") has determined and informed the Plan document sponsor by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). The Plan provisions were amended from time to time; however, the Plan Administrator and the Plan's counsel believe that the Plan was designed and was operated in compliance with the applicable requirements of the IRC and had no income subject to unrelated business income tax and therefore, the Plan and related trust continued to be tax-exempt through termination.

### **7. Risks and Uncertainties**

The Plan invested in various investments. Investments were exposed to various risks such as interest rate, market, and credit volatility. Market risks include U.S. and global events that could impact the value of Plan investments. Such events may include public health emergencies, as well as international conflicts, cybersecurity attacks, supply chain disruptions, global monetary policy decisions, inflation, significant economic influences, and other adverse credit and market events and conditions.

### **8. Plan Termination**

The Company has terminated the Plan with an effective date of January 31, 2024. Due to the termination, the Plan provided that the assets be allocated among the participants and beneficiaries in the amounts credited to each participant's respective account. All plan assets were paid out by December 23, 2024.

### **9. Related Party Transactions and Party-In-Interest Transactions**

Plan investments were managed by Nationwide. The Plan paid direct asset fees to Nationwide. Pension Financial Services, Inc. ("PFS") was the third party administrator. The Plan paid per capita fees and loan and distribution fees to PFS. Transactions with these parties qualified as party-in-interest transactions. Notes receivable from participants also qualified as party-in-interest transactions.

### **10. Subsequent Events**

The Plan has evaluated subsequent events through October 10, 2025, the date the financial statements were available to be issued.
