## **Independent Auditors' Report**

To the Plan Administrator of

- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## ***Basis for Opinion***

We conducted our audit in accordance with auditing standards generally accepted in the United States of America (GAAS). Their report dated October 15, 2024 indicated that (a) the amounts and disclosures in the 2023 financial statements, other than those agreed to or derived from the certified investment information, were presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America, and (b) the information in the 2023 financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C). Their report also indicated that the form and content of the 2023 supplemental schedule, other than the information in the 2023 supplemental schedule that agreed to or is derived from the certified investment information, was presented, in all material respects, in conformity with the DOL Rules and Regulations for Reporting and Disclosure under ERISA; and the information in the 2023 supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determines meets the requirements of ERISA Section 103(a)(3)(C).

**NOTE 1 - DESCRIPTION OF THE PLAN**

The following description of the Acme United Corporation 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

***GENERAL***

The Plan is a defined contribution 401(k) profit sharing plan. The Plan was established by Acme United Corporation (Company or Plan Sponsor) on January 1, 1960 and restated on June 3, 2016, and has been amended to credit service to certain predecessor employers and to allow participant notes receivable to be transferred into the Plan from certain predecessor employer plans. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Company is responsible for the oversight of the Plan and determines the appropriateness of the Plan's investment offerings and monitors investment performance.

***EMPLOYEE CONTRIBUTIONS***

Participants may make salary deferral contributions to the Plan up to 50 percent of their taxable compensation, with a minimum salary deferral contribution of 1 percent up to the annual limit prescribed by the Internal Revenue Code (IRC) (\$23,000 for 2024). Participants who have attained age 50 by the end of the year are eligible to make additional catch up contributions up to the annual limit prescribed by the IRC (\$7,500 for 2024). Participants may also make certain rollover contributions from other qualified plans. Participants direct the investment of their contributions into various investment options offered by the Plan.

***COMPANY CONTRIBUTIONS***

The Company may make a discretionary matching contribution to the Plan equal to a percentage of the participant's salary deferral. There was \$528,156 in matching contributions made to the Plan by the Company during the year ended December 31, 2024.

The Company may make a discretionary contribution to the Plan. The contribution will be allocated to each eligible participant in accordance with the Plan agreement. The Company made no discretionary contributions during the year ended December 31, 2024.

***COMPANY CONTRIBUTIONS (CONTINUED)***

In addition to the discretionary matching contributions and the discretionary contributions, the Company may make a discretionary contribution called a qualified nonelective contribution (QNEC). If a QNEC contribution is made, the participant will automatically vest 100% in that QNEC contribution. The Company made no QNEC contributions during the year ended December 31, 2024.

***ELIGIBILITY***

All employees of the Company are eligible to become a participant in the Plan on the first day of the month following the date the eligibility requirements are satisfied. In order to be eligible to elect deferrals, the employee must be at least the age of 21 and have completed a month of service. In order to be eligible to receive discretionary matching contributions, and discretionary contributions, the employee must be at least the age of 21 and have completed a year of service, defined as at least 1,000 hours during the plan year.

***PARTICIPANT ACCOUNTS***

Each participant's account is credited with the employees' voluntary contributions, transfer contributions, Company's discretionary matching contribution and rollover contributions and an allocation of (a) the Company's discretionary contributions; (b) forfeitures of terminated participants' non-vested accounts; and (c) Plan earnings. The participant accounts are charged for any withdrawals, distributions, and administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

***VESTING***

The participant is vested in the Company's discretionary matching contributions and discretionary contributions depending on the number of years of service as follows:

*NOTES RECEIVABLE FROM PARTICIPANTS*

Notes receivables from Participants are not permitted by the plan.

*PAYMENT OF BENEFITS*

Participants, or their beneficiaries, are entitled to receive the entire amount of their interest in the Plan upon retirement, death, total or permanent disability, employment termination, or upon reaching the age of 59½.

*HARDSHIP WITHDRAWALS*

The Plan allows for hardship withdrawals in accordance with the Internal Revenue Service (IRS) regulations as specified within the Plan document.

*FORFEITURES*

Forfeitures result from non-vested Company discretionary matching contributions remaining in the Plan for terminated employees. Forfeitures are available to reduce the Company's discretionary contributions and/or its discretionary matching contributions. Forfeitures of \$25,736 were used to reduce the Company's discretionary matching contributions for the year ended December 31, 2024. The balance in the forfeiture account at December 31, 2024 and 2023 was \$91,970 and \$65,177, respectively.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

*BASIS OF ACCOUNTING*

The financial statements of the Plan are prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

*USE OF ESTIMATES*

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect certain reported amounts of net assets available for benefits at the date of the financial statements, the changes in net assets available for benefits during the reporting period and, when applicable, disclosures of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

***PAYMENT OF BENEFITS***

Benefits are recorded when paid.

***EXCESS CONTRIBUTIONS PAYABLE***

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to employee contributions revenue. The Plan distributed the excess contributions to the applicable participants in the year subsequent to the year in which these contributions occurred.

***ADMINISTRATIVE EXPENSES***

The Plan pays administrative expenses to the extent that the Company does not pay them. Personnel and facilities of the Company have been used by the Plan for its accounting and other activities at no charge to the Plan. Plan expenses paid by the Company are not included in these financial statements. Fees related to the administration of notes receivables are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments in the statement of changes in net assets available for benefits.

***INVESTMENT VALUATION AND INCOME RECOGNITION***

The Plan's investments are stated at fair value, as determined by management based on information provided by the Capital Bank and Trust Company, the Plan's trustee. Fair value is the price that would be received to sell an asset or paid to transfer a liability (an exit price) in an orderly transaction between market participants at the measurement date. See Note 4 for further discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend basis. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

***CONTRIBUTIONS***

Contributions from Plan participants and the matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

***RISK AND UNCERTAINTIES***

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the statements of net assets available for benefits.

**NOTE 3 - INVESTMENTS**

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments and interest and dividends for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Capital Bank & Trust Company, the Plan's trustee. This information has not been audited by the Plan's independent auditors.

**NOTE 4 - FAIR VALUE MEASUREMENT**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1    Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2    Inputs to the valuation methodology include
- quoted prices for similar assets or liabilities in active markets;
  - quoted prices for identical or similar assets or liabilities in active markets;
  - inputs other than quoted prices that are observable for the asset or liability;
  - inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Money market fund:* Valued at the quoted net asset value (“NAV”) of shares held by the Plan at year end.

*Mutual fund:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**NOTE 5 - PARTY-IN-INTEREST TRANSACTIONS**

During the year ended December 31, 2024, party-in-interest transactions, as defined in Section 3(14) of ERISA, included administrative services provided by the trustee. These transactions are exempt from the prohibited transactions rules. Additionally, the Company provides certain accounting, administrative and investment management services to the Plan for which no fees are charged.

**NOTE 6 - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100 percent vested in their accounts.

**NOTE 7 - TAX STATUS**

The Plan has received an opinion letter from the IRS dated June 30, 2020, stating that the Plan is qualified under Section 401(a) of the IRC and therefore the related trust is exempt from taxation. Subsequent to this opinion by the IRS, the Plan was amended. The Plan is required to operate in conformity with the IRC to maintain its qualified status. The plan administrator believes the Plan is being operated in compliance with the applicable requirements of the IRC and therefore believes the Plan, as amended, is qualified and the related trust is tax-exempt.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the taxing authorities. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods pending or in progress.

**NOTE 8 - SUBSEQUENT EVENTS**

The Plan has evaluated all subsequent events through October 13, 2025, the date the accompanying financial statements were available to be issued. Other than as disclosed below and in Note 9, no events have been identified that would require adjustment to, or disclosure in, the financial statements.

On January 1, 2025, the Plan document was amended and restated to amend the Company's matching contributions. Effective January 1, 2025, the Company will make safe harbor matching contributions equal to 100% of elective deferrals that do not exceed 3% of participant's eligible compensation, plus 50% of elective deferrals between 3% and 5% of participant's eligible compensation.

**NOTE 9 – DELINQUENT PARTICIPANT CONTRIBUTIONS**

For the year ended December 31, 2024, the Plan Sponsor did not remit certain participant contributions to the Plan on a timely basis as defined by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Untimely remittances identified on the Schedule of Delinquent Participant Contributions totaled \$102 in 2024. Such untimely remittances were corrected outside of the Department of Labor Voluntary Fiduciary Correction Program ("VFCP") subsequent to December 31, 2024, and prior to issuance of these financial statements. Additionally, the Plan Sponsor has compensated participants for lost earnings resulting from the delay in contributions.
