### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

**1. Plan Description**

The following description of Old Second National Bank Pooled Employer Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

**General**

The Plan is a pooled employer plan established and administered by Old Second National Bank, the Pooled Plan Provider (PPP). The Plan was established under the Setting Ever Community Up for Retirement Enhancement Act of 2019 (SECURE Act) on July 1, 2022. The Plan is a defined contribution plan covering eligible employees of the Participating Employers, and is intended to qualify as a Pooled Employer Plan as described in Internal Revenue Code (IRC), as amended, Sections 401(a) and 501(a). The Plan allows any affiliated or unaffiliated employer, as defined, to participate in the Plan. Each Participating Employer elects their own provisions related to eligibility, contributions, notes receivable from participants, and payments of benefits. The Plan is subject to applicable provisions of the Employee Retirement Income Act of 1974 (ERISA).

The Plan’s PPP is responsible for the oversight of the Plan. The PPP also serves as the Plan’s custodian, processes and maintains the participants records and holds the Plan’s investment assets.

**Contributions**

Each year, participants may contribute up to 100% of pretax annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contributions plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds and an collective trust fund as investment options for participants. Contributions are automatically invested in a designated balance fund until changed by the participant. Contributions are subject to certain statutory limitations.

An employer may make a match or discretionary contribution each year as determined by the formula specified in the adoption agreement, if so elected in the adoption agreement.

**Participant Accounts**

Each participant’s account is credited with the participant’s contribution and allocations of (a) the employer’s contribution, (b) Plan earnings (losses), (c) forfeitures of terminated participants’ non-vested accounts and charged with an allocation of any administrative expenses paid by the Plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

**Vesting**

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the participating employer’s contribution portion of their accounts plus actual earnings thereon is based on the years of continuous service. The vesting schedules are determined in accordance with the option selected by the participating employer in its adoption agreement.

**Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at 2% over prime. Principal and interest is paid ratably through payroll deductions over a period not longer than five years unless loan proceeds were used to acquire a primary residence.

**Payment of Benefits**

Upon termination of services due to death, disability, or retirement, a participant may elect to take a lump-sum distribution or a series of equal installments over a participant's assumed life expectancy. On termination of service a participant may elect to receive their vested account balance as a lump sum payment. However, if a participant's vested balance is less than \$5,000 at termination of service, it may only be distributed in a single lump-sum distribution. Rollover contribution and allocable rollover earnings are not taken into account when determining the \$5,000 threshold.

**Forfeited Accounts**

At December 31, 2024, forfeited nonvested accounts totaled \$0. These accounts will be used to either (1) reduce future employer contributions or (2) pay administrative expenses from the respective participating employer. In December 31, 2024, \$0 were used to reduce employer contributions.

**2. Summary of Accounting Policies**

**Basis of Accounting**

The financial statements of the Plan have been prepared under the accrual method of accounting.

Investments held by a defined contribution plan are required to be reported at fair value.

**Investments Valuation And Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis and dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued by unpaid interest. Delinquent notes receivable from participants are recorded as a distribution based upon the terms of the Plan document.

**Payment of Benefits**

Benefits are recorded when paid.

**Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP") requires the Plan Administrator to make estimates and assumptions that affect the reported amounts and disclosure. Actual results could differ from those estimates.

**Administrative Expenses**

Certain expenses of maintaining the Plan are paid by the Company. Loan administrations fees are charged directly to the participant's account and are included in administrative expenses. The costs incurred for the administration of the Plan are paid by the sponsors. Investment related expenses are included in net appreciation of fair value of investments.

**Subsequent Events**

The Plan monitors significant events occurring after the balance sheet date and prior to the issuance of the financial statements to determine the impacts, if any, of events on the financial statements to be issued. The Plan has evaluated subsequent events through the date which the financial statements are issued. There were no material subsequent events that required recognition or additional disclosure in these financial statements.

**Corrective Distributions**

Corrective distributions are made when Highly Compensated Employees disproportionately participate in the Plan. During 2024 and 2023, participants contributed \$0 and \$3,462, respectively that was in excess of contribution limits. These excess contributions were returned to participants prior to March 15, 2025 and 2024, respectively.

**3. Fair Value Measurements**

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no Plan assets requiring the use of Level 3 inputs for the periods presented.

**Level 1 Fair Value  
Measurements**

The fair value of mutual funds is based on quoted net asset values of the shares as reported by the fund. The mutual funds held by the Plan are open-end mutual funds registered with the U.S. Securities and Exchange Commission. The funds must publish their daily net asset value and transact at that price. The mutual funds held by the Plan are considered to be actively traded. The fair values of common stocks are based on the closing price reported on the active market where the individual securities are traded.

Common collective trusts are valued using the Net Asset Value (“NAV”) as a practical expedient and are not categorized in the fair value hierarchy. NAV is provided by the trustee and is based on the fair value of the underlying investments held by the fund less its liabilities. In the event the Plan were to initiate a full redemption of a common collective trust, the investment advisor reserves the right to temporarily delay withdrawal from the common collective trust in order to ensure that securities liquidations will be carried out in an orderly business manner. The common collective trusts have no unfunded commitments, other redemption restrictions, or redemption notice periods. The underlying portfolios of the common collective trusts are comprised of a mix of bonds and cash.

The Plan’s investments are reported at fair value in the accompanying statements of net assets available for benefits.

The Plan’s policy is to recognize transfers between Levels 1 and 2 and into and out of Level 3 as of the date of the event or change in circumstances that caused the transfer. For the year ended December 31, 2024, there were no significant transfers between Levels 1 and 2 and no transfers into or out of Level 3.

**4. Plan Termination**

Although it has not expressed any interest to do so, the Company has the right

under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

**5. Income Tax Status**

The Internal Revenue Service (IRS) has determined and informed the Company by a letter dated March 31, 2014, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC).

In line with generally accepted accounting principles in the United States of America, the Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; there are currently no audits for any tax periods in progress.

**6. Summary of Information Certified by Plan Trustee**

**7. Parties-in-Interest**

Certain plan investments, which are shares of registered investment companies, and notes receivable from participants are managed by Newport Trust Company, the custodian and, therefore, these transactions qualify as party-in-interest transactions. Certain employees of the Company provide administrative services to the Plan. These employees are not paid by the Plan for their services.

**8. Plan Transfers**

During the years ended December 31, 2024 and 2023, 2 and 6, respectively adopting plan sponsor elected to begin their participation in the Plan, resulting in investments and notes receivable from participants totaling \$2,424,665 and \$11,410,261, respectively, being transferred into the Plan.

During the years ended December 31, 2024 and 2023, 2 and 0, respectively adopting plan sponsor elected to end their participation in the Plan, resulting in investments and notes receivable from participants totaling \$3,200,624 and \$0, respectively, being transferred out of the Plan.
