## Report of Independent Auditors

To the Board of Directors  
Vanderbilt University Medical Center Retirement Plan

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of Vanderbilt University Medical Center Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes (collectively referred to as the “financial statements”).

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### **Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditor’s Responsibilities for the Audit of the Financial Statements section

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the

## Notes to Financial Statements

December 31, 2024

### **1. Description of Plan**

The following description of the Vanderbilt University Medical Center Retirement Plan (the Plan) provides only general information. Vanderbilt University Medical Center (Medical Center or Plan Sponsor) is the Plan Sponsor. Participants should refer to the plan document and summary plan description for a more complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution plan, which was adopted on April 30, 2016 to provide retirement benefits for employees of the Medical Center. The assets of the active employees of the Medical Center were transferred into the Plan from the pre-existing Vanderbilt University Retirement Plan. The Plan is comprised of two sub-plans, the Vanderbilt University Medical Center Retirement Plan (VUMC Plan) and the New Faculty Plan. The VUMC Plan covers substantially all employees except for post-doctoral fellows or trainees performing services that are exempt from social security taxes, employees who work less than 20 hours per week, nonresident aliens, and those employees who are eligible for the New Faculty Plan. The New Faculty Plan covers all newly hired faculty who are not highly compensated. Eligible employees will cease to be eligible to participate in the New Faculty Plan once he or she ceases to be a faculty employee, ceases to be a non-highly compensated employee, or has completed one year of eligibility service. At that time they will be rolled into the VUMC Plan. No employee may participate in the VUMC Plan and the New Faculty Plan at the same time. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

#### **Contributions**

Eligible retirement plan contributions to the Plan are deductible by the participants for federal income tax purposes under Section 403(b) of the Internal Revenue Code (IRC). Participants may also contribute amounts representing distributions from other qualified retirement plans. Participants may elect to contribute their voluntary contributions as either pre-tax deferrals or after-tax Roth deferrals. Participant contributions are permitted up to the maximum amount allowed by the IRC.

## Notes to Financial Statements (continued)

### 1. Description of Plan (continued)

Eligible employees in the Plan that have completed one year of service must make mandatory deferrals of 3% of compensation (6.47% for employees of Vanderbilt Medical Group). The Medical Center makes mandatory matching contributions on mandatory deferrals of 100% up to 3%. The following employees are not required to make mandatory deferrals or receive mandatory matching contributions:

- Employees who are not yet age 21
- Employees in a collective bargaining unit who participate in a union-sponsored plan
- Full-time temporary faculty members
- Part-time faculty members
- Employees of Vanderbilt Temporary Services or the temporary nurse registry staff
- Certain faculty members, as shown in the Plan document

Eligible employees in the Plan can make elective deferrals. Once eligible for the elective deferrals, employees will receive a match of 100% of the employee's elective deferrals up to 2%, (or up to 3% for the Vanderbilt Medical Group). For eligible employees with one year of service in a collective bargaining unit who have elected not to participate in the union-sponsored plan, the match is 100% of elective deferrals up to 5% of their compensation. Plan Sponsor contributions may not exceed the maximum amount allowable for federal income tax purposes.

### Participant Accounts

Each participant's account is credited (charged) with the participant's contributions, an allocation of Plan Sponsor contributions, investment earnings (losses), and administrative expenses. Allocations are based on the participant's compensation or account balances as defined in the plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### Vesting

Participants are immediately vested in their elective and mandatory salary deferral and Plan Sponsor's contributions plus actual earnings (losses) thereon.

### 1. Description of Plan (continued)

#### Notes Receivable From Participants

Participants who have account balances with Fidelity Management Trust Company (Fidelity) may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their Fidelity account balance. The notes receivable are secured by the balance in the participant's account and bear interest at a fixed rate of 4.25% to 9.50%, which is commensurate with local prevailing rates as determined quarterly by the plan administrator. Principal and interest are paid directly by the participant to the Plan.

Participants who have account balances with Teachers Insurance and Annuity Association of America (TIAA) and College Retirement Equity Fund (CREF) or The Variable Annuity Life Insurance Company (VALIC), a wholly owned subsidiary of Corebridge Financial Inc, may borrow amounts directly from those providers in amounts ranging from \$1,000 up to the lesser of \$50,000 or 50% of their account balances held by those providers. Adequate security is required, and a portion of the participant's account is held as collateral in case of default. Collateral held in the Plan was \$1,129,687 and \$1,270,080 as of December 31, 2024 and 2023, respectively. Principal payments increase the amount of funds available for the participant's use. A fixed or variable interest rate is charged to each participant with an outstanding loan. A portion of that interest is paid directly to the provider, and the remaining interest is credited to the participant's account.

#### Payment of Benefits

On termination of service due to death, permanent disability, retirement or termination of service due to other reasons, or when a participant reaches age 59½, a participant may elect to receive either a lump-sum payment, periodic payments over a specified period, or a lifetime monthly payment that may continue to a designated beneficiary if the participant dies after retirement equal to his or her entire account balance.

#### Hardship Withdrawals

The Plan permits distributions in the event of a hardship, as defined in the plan document. These distributions are taxable and subject to a tax penalty equal to 10% of the hardship distribution amount if the participant is younger than age 59½. Hardship withdrawals are limited to the participant's elective account balance.

### **1. Description of Plan (continued)**

#### **Administrative Expenses**

Certain expenses of maintaining the Plan are paid directly by the Plan Sponsor and are excluded from these financial statements. Certain fees incurred by the Plan for the investment management services are included in net appreciation in fair value of investments. Recordkeeping fees and Plan level advisory fees are included in administrative expenses.

#### **Plan Termination**

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

### **2. Summary of Significant Accounting Policies**

#### **Basis of Accounting**

The accompanying financial statements have been prepared on the accrual basis of accounting.

#### **Payment of Benefits**

Benefits are recorded when paid.

#### **Notes Receivable From Participants**

Notes receivable from participants represent participant loans that are recorded at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when it is earned. Related fees are recorded as administrative expenses and are recorded when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

### **2. Summary of Significant Accounting Policies (continued)**

#### **Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein, and disclosure of contingent assets and liabilities and the supplemental schedule. Actual results could differ from those estimates.

#### **Investment Valuation and Income Recognition**

Investments are stated at fair value (except for the fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Board of Trustees determines the Plan's valuation policies utilizing information provided by the investment advisers, investment providers, and insurance companies. See Notes 4 and 5 for further discussion of investment valuation.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### **3. Investments**

Certain information related to investments and notes receivable from participants reported and disclosed in the accompanying financial statements and supplemental schedule, including the fair value and contract value of investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividend income, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by VALIC, Fidelity, or TIAA-CREF.

### 4. Fair Value Measurements

Accounting Standards Codification (ASC) 820, *Fair Value Measurements*, provides the framework for measuring fair value. The fair value framework establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The fair value hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below.

Level 1 – Unadjusted quoted prices in active markets that are accessible to the reporting entity at the measurement date for identical assets and liabilities.

Level 2 – Inputs other than quoted prices in active markets for identical assets and liabilities that are observable either directly or indirectly for substantially the full term of the asset or liability. Level 2 inputs include the following:

- Quoted prices for similar assets and liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in markets that are not active
- Observable inputs other than quoted prices that are used in the valuation of the assets or liabilities (e.g., interest rate and yield curve quotes at commonly quoted intervals)
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

Level 3 – Unobservable inputs for the asset or liability (i.e., supported by little or no market activity). Level 3 inputs include management’s own assumption about the assumptions that a market participant would use in pricing the asset or liability (including assumptions about risk).

The level in the fair value hierarchy within which the fair value measurement is classified is determined based on the lowest level input that is significant to the fair value measurement in its entirety.

Following is a description of the valuation techniques and inputs used for each general type of investment measured at fair value by the Plan. There have been no changes to the methodologies used at December 31, 2024 and 2023.

#### 4. Fair Value Measurements (continued)

- (i) Money market funds: Valued at the net asset value (NAV) of shares held by the Plan at year-end determined using quoted market prices in an active market.
- (ii) Registered investment company shares: Valued at the NAV of shares held by the Plan at year-end determined using quoted market prices in an active market.
- (iii) TIAA Real Estate Fund: Valued at NAV, which is based on the market value of the underlying investments held by the pooled separate account at year-end. The NAV is not a publicly quoted price in an active market. The fair market value of the TIAA Real Estate Fund (pooled separate account) is updated daily and readily available on the TIAA-CREF website. TIAA Real Estate Fund is not redeemable daily; transfers out of the fund can be executed on any business day but are limited to once per calendar quarter.
- (iv) Pooled separate accounts: The VALIC pooled separate accounts are invested primarily in mutual funds and are valued at the NAV of shares held by the Plan at year-end.
- (v) Fixed annuity contracts: Valued at fair value which approximates contract value. The fair value is based on a quantitative model using assumptions of future interest rates and related discounted cash flows that are not observable in the market. See Note 5 for additional information on the fixed annuity contracts.
- (vi) Self-directed brokerage accounts: Self-directed accounts are invested primarily in mutual funds and are valued at the NAV of shares held by the Plan at year-end determined using quoted market prices in an active market.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan's management believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### 5. Fixed Annuity Contracts With Insurance Companies

The Plan holds fixed annuity contracts, which are investment contracts, with three insurance companies, Principal Life Insurance Company (Principal), VALIC, and TIAA-CREF during 2024 and 2023. The insurance companies maintain the Plan's contributions in their respective general accounts which are credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Because they do not meet the definition of fully benefit-responsive, the VALIC Loan Collateral and Escrow Funds and the TIAA Traditional Non-Benefit-Responsive contract are included in the financial statements at fair value, which approximates contract value as reported to the Plan by VALIC and TIAA. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

#### **5. Fixed Annuity Contracts With Insurance Companies (continued)**

The TIAA Traditional Benefit-Responsive contract, the TIAA Plan Loan Default Fund, the Principal Fixed Account, the VALIC Fixed Account Plus, and the VALIC Short Term Fixed Account meet the fully benefit-responsive investment contract criteria and therefore are reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Fidelity (who is the Third-Party Administrator of the Principal contract), TIAA-CREF, and VALIC, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

For the fixed annuity contracts with TIAA-CREF, the crediting interest rate is reset annually and is based on a formula agreed upon with the issuer, but may not be less than 1% to 3%, depending on the sub-contract. The fixed annuity contracts with TIAA-CREF are offered through a variety of sub-contracts which determines the applicability of certain account features, such as the degree of liquidity of the participant's account and the options for receiving income upon retirement, thus some of the TIAA-CREF annuity contracts are fully benefit-responsive and some are not. The Retirement Annuity (RA) sub-contract does not allow lump-sum cash withdrawals from the fixed annuity contracts and transfers must be spread over a period of 10 annual installments. For the Group Retirement Annuity (GRA) sub-contract, lump-sum withdrawals are available from the fixed annuity contract only within 120 days after termination of employment and are subject to a surrender charge. All other withdrawals and transfers from the RA or GRA fixed annuity sub-contract to other investment options available to the Plan must be spread over a period of 10 annual installments (or five annual installments for withdrawals after termination of employment). For the Retirement Choice (RC) sub-contract, participant withdrawals and transfers must be taken in 84 monthly installments, except that a lump sum distribution is available, if permitted under the Plan, in the 120-day period following termination of employment subject to a surrender charge. The RA, GRA, and RC sub-contracts are non-fully benefit-responsive. The Supplemental Retirement Annuity (SRA), Group Supplemental Retirement Annuity (GSRA), and Retirement Choice Plus (RCP) sub-contracts have no liquidity restrictions and are fully benefit-responsive.

For the fully benefit-responsive insurance contracts with VALIC, the crediting interest rate is based on a formula agreed upon with the issuer but may not be less than 3% if the participant's account was set up before December 1, 2003, and 2% if the participant's account was set up after this date but before December 31, 2013. Such interest rates are reviewed on a monthly basis for resetting. Effective January 1, 2012, contracts issued to new participants have an indexed guaranteed interest rate which was between 1% and 3% for 2024.

### **5. Fixed Annuity Contracts With Insurance Companies (continued)**

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the plan document (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers or that would limit the ability of the Plan to transact at contract value with the participants.

### **6. Risks and Uncertainties**

The Plan utilizes various investment instruments. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

### **7. Related-Party and Party-in-Interest Transactions**

Certain Plan investments in money market funds, registered investment company shares, pooled separate accounts, and fixed annuity contracts are managed by the custodians of the Plan and, therefore, these transactions qualify as party-in-interest transactions. As discussed in Note 1, the Plan pays fees to various service providers and holds notes receivable from participants, which also qualify as party-in-interest transactions under ERISA. These transactions are in the ordinary

### **8. Tax Status**

The Plan has been designed to qualify under Section 403(b) of the IRC. The Plan has not received a determination letter from the Internal Revenue Service (IRS). The Plan is required to operate in conformity with the IRC to maintain its qualification under Section 403(b). The plan administrator believes that the Plan is operating in accordance with the applicable requirements of Section 403(b) of the IRC and, therefore, believes the Plan is qualified and the related accounts are tax-exempt.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Plan management has analyzed the tax positions taken by the Plan and has concluded that there are no uncertain positions taken or expected to be taken. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### **9. Subsequent Events**

Management evaluated subsequent events for the Plan through October 13, 2025, the date the financial statements were available to be issued.
