**NOTE 1 - DESCRIPTION OF PLAN**

The following description of the Seidel, Inc. 401(k) Retirement Plan (the "Plan"), sponsored by Seidel, Inc. provides general information only. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

**General** - The Plan is a defined contribution plan covering substantially all full-time non-union employees of MRX Holdings, Inc. and its wholly owned subsidiaries Seidel, LLC (the successor to Seidel, Inc.), MEC, LLC (which was formed to acquire the assets of Eyelet Crafters, Inc.), MEDI, LLC (which was formed to acquire the assets of Eyelet Design, Inc.), and is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA"). MRX and its subsidiaries are collectively referred to as "the Company". In December 2021, MQuest, LLC (which was formed to acquire Quest Plastics, Inc.), a company acquired by the owner of MRX Holdings, Inc., became a participating employer in the Plan. The following brief description of the Plan is provided for general information purposes only. Participants should refer to the "summary plan description" for a more complete description of the Plan's provisions.

**Plan Sponsor, Administrator, and Custodian** - The Plan is sponsored by Seidel, Inc. Fidelity Management Trust Company is the Trustee for the Plan (the "Trustee"). Fidelity Workplace Services, LLC is the Custodian for the Plan ("Custodian") and acts at the direction of the Plan Administrator. Participants have the option to invest in certain Custodian maintained funds in accordance with the provisions of the Plan document. Participants may elect to change their investment options daily.

**Participant Accounts** - Participants may elect to invest in one or more of the aforementioned investment options in 1% increments and may change their contribution rate during any payroll period. Transfers of existing investments between funds are also permissible upon election. Each participant's account is credited with that participant's contribution, a discretionary Company matching contribution, if any, allocated fund earnings, and is charged with an allocation of administrative expenses, if any. Allocations are based on the proportion of each participant's account balance to the corresponding investment fund balance. The benefit to which a participant account is entitled is the benefit that can be provided from a participant's vested account.

**Eligibility** - Employees are eligible to enroll upon completing three months of service.

**Contributions** - Participants may elect to defer up to 90% of pretax annual compensation, not to exceed the limits established by Internal Revenue Code ("the Code") Section 402(g) ("voluntary contributions"). Participants, subject to the approval of the plan administrator, can also contribute amounts representing distributions from other qualified defined benefit or contribution plans ("rollover contributions"). For each plan year, Seidel, LLC and the other participating employers may contribute on behalf of each participant, a percentage of the participant employee's pretax contributions for the plan year to be determined by the employer.

*Contributions* (Continued) - The contribution is allocated among funds based on the participant's most recent allocation percentages. In addition, the participant must fulfill certain requirements with respect to length of service in order to vest with regard to these matching contributions.

*Vesting* - Each 12 consecutive months of completed service during which participants have completed 1,000 hours of service, shall constitute a year of vested service. Participants have a vested right to receive payment of 100% of their participant pretax contributions, rollover contributions and earnings thereon whenever their service terminates. In addition, they shall have a vested right to receive payment of 100% of the Company profit sharing contributions standing to their credit upon:

- The individual's completion of five years of service (see table below);
- The individual's attainment of age 65;
- The individual becoming permanently disabled or;
- The individual's death.

If participants terminate employment before the completion of five years of service they shall have a vested right to receive payment of a percentage of their employer matching contributions and related earnings based on years of continuous service as follows.

<u>Years of Service for Vesting</u>	<u>% of Vesting in Employer Contributions</u>
One Year	20%
2 Years	40%
3 Years	60%
4 Years	80%
5 Years	100%

*Forfeitures* - Participants who terminate employment but have not become fully vested forfeit the unvested balances in their accounts. Forfeitures can be used for paying Plan expenses and/or offsetting employer contributions. The balance of the forfeiture account at December 31, 2024 and 2023 is \$8,935 and \$0, respectively, which can be used to pay plan expenses or reduce future Company matching contributions. During 2024, no forfeitures were used.

*Payment of Benefits* - Upon death, retirement, total and permanent disability or termination of employment, the participant shall be entitled to the vested amount of his/her account in accordance with the provision and payment method elections specified in the Plan. If the participant leaves and returns to the Plan within a defined period of time, the non-vested portion is reinstated upon meeting certain criteria. Participants who meet the Plan provisions may take in-service withdrawals. For accounts with less than \$5,000, the Plan can pay the participant in a lump sum at any time after the participant leaves the Company or its participating employers.

*Notes Receivable from Participants* - Participants have the ability to borrow up to 50% of their vested account balance up to a maximum of \$50,000 upon application and approval by the Plan Administrator, as defined in the Plan. The loans are collateralized by the balance in the participant's account. The interest rate charged to participants is two percent above the prime interest rate established by commercial lending institutions. Principal and interest are paid ratably through payroll deductions. The participant has the option to apply for a general purpose loan repayable within five years or a loan to purchase a primary residence which is repayable within a term fixed by the Plan Sponsor.

*Hardship Withdrawals* - The Plan allows for "hardship" withdrawals in accordance with the Internal Revenue Service regulations as specified in the Plan summary.

*Administrative Expenses* - Investment management fees of the Plan are funded directly by the Plan. All other administrative expenses (audit and legal fees) are paid by the Company on the Plan's behalf and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Personnel and facilities of the Company have been used by the Plan for its accounting and other activities at no charge to the Plan.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

*Basis of Presentation* - The Plan financial statements have been prepared on the accrual basis of accounting.

*Use of Estimates* - The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

*Payment of Benefits* - Benefits are recognized when paid.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)**

*Investment Valuation and Income Recognition* - The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

*Notes Receivable from Participants* - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

*Risks and Uncertainties* - The Plan provides the participants with various investment options in any one or a combination of mutual funds which invest in stocks, bonds, fixed income securities and other investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

*Fair Value Measurements* - ASC Topic 820 *Fair Value Measurements* defines fair value, establishes guidelines for measuring fair value, and expands disclosure regarding fair value measurements. The Plan follows the guidance in ASU 2015-07 which removed the requirement to categorize within the fair value hierarchy all investments for which fair value is measured using the net asset value ("NAV") per share as quoted on a private market that is not active.

*Disclosure of Subsequent Events* - Management has evaluated subsequent events through October 10, 2025, the date the financial statements were available to be issued.

**NOTE 4 - FAIR VALUE MEASUREMENTS**

ASC Topic 820 provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under ASC Topic 820 are described as follows:

*Level 1* - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

*Level 2* - Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets, inputs other than quoted prices that are observable for the asset or liability, or inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual and money market funds:* Valued at the net asset value ("NAV") of shares held by the Plan at year-end. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Collective trust:* The Great Gray Trust Galliard Retirement Income Fund, held in a collective trust fund, primarily invests in investment contracts and security backed investment contracts. The objective of the stable value fund is to preserve principal while generating earnings at rates competitive over time with short-term high quality fixed income investments. The investment is valued at NAV as a practical expedient to estimate fair value where NAV is based on the total assets of the fund, less its liabilities, divided by the number of units outstanding at the time of such computation. Participant transactions (purchases and sales) may occur daily. There are currently no redemption restrictions or unfunded commitments on this investment.

**NOTE 5 - TERMINATION PRIORITIES**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, all participants will become 100 percent vested in their accounts.

**NOTE 6 - TAX STATUS**

The Plan adopted a Fidelity Volume Submitter Plan which received a favorable opinion letter dated June 30, 2020 from the Internal Revenue Service. The Plan itself has not received a determination letter from the IRS.

Plan management is required to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. Plan management believes it is no longer subject to income tax examination for years prior to 2020.
