Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the accompanying financial statements of Consolidated Precision Products Corp Retirement and Savings Plan ("the Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audits of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audits of the Financial Statements section of our report. We are required to be independent of the Plan and to

meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audits does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audits of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audits section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of ERISA Section 103(a)(3)(C) audits is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audits, significant audit findings, and certain internal control-related matters that we identified during the audits.



NOTE 1 – DESCRIPTION OF THE PLAN

The following brief description of the Consolidated Precision Products Corp Retirement and Savings Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan agreement for more complete information.

General

The Plan is a 401(k) savings plan covering substantially all nonunion employees of Consolidated Precision Products, Corp. (“CPP Corp”), Consolidated Foundries, Inc. (“CFI”), Cast Parts, Inc. (“CPI”), PACFoundries, Inc. (“PAC”), PAC-Rancho, Inc. (“PAC-Rancho”), Hitchcock Industries, Inc. (“Hitchcock”), Magparts, Inc. (“Magparts”), Wollaston Alloys, Inc. (“Wollaston”), CPP-Cleveland (“Cleveland”), CPP-Syracuse, Inc. (“Syracuse”), CPP-Steel Treaters, Inc. (“CPP Steel”), Superior Metals Manufacturing Co. (“SMM”), Poly6 Technologies, Inc. (“Poly6”), Selmet, Inc. (“Selmet”), and Pacific Cast Technologies, Inc. (“Pacific”) (collectively, the “Company”). The Plan also covers Wollaston employees who are members of Local 9431. Employees are eligible to participate in the Plan immediately upon hire. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). During April 2022 Prudential Bank & Trust, FSB (“Prudential”) was acquired by Empower Annuity Insurance Company of America (“Empower”). The Plan was moved onto the Empower platform during the 2023 year. Empower is the trustee and recordkeeper of the Plan.

Employee Contributions

Each year, participants may contribute up to 75% of their annual compensation up to the statutory limits determined annually by the Internal Revenue Code (IRC). Participants may also contribute amounts representing rollover distributions from other qualified defined benefit or defined contribution plans. Participants will be automatically enrolled in the Plan with a deferral rate of 3% of their annual compensation and have the option to make after-tax Roth contributions to the Plan.

Employer Contributions

CPP Corp, CFI, CPI, PAC, PAC-Rancho, Hitchcock, Cleveland, Syracuse, CPP Steel, SMM, Poly6, and Magparts may make discretionary matching contributions up to a maximum of 6% of eligible participant compensation individually, as they adopted the Plan separately under a control group arrangement. In the current year, all of the above-named employers elected to make a discretionary employer matching contribution equal to 50% of each 1% of participants’ contributions to the Plan, up to a maximum of 6%. The discretionary match is allocated each pay period to eligible participants who have completed at least one hour of service during the Plan year. These employers also have the option to make discretionary profit-sharing contributions to the Plan. There were no discretionary profit-sharing contributions made during the year ended December 31, 2024.

The employer matching and profit-sharing contributions, if any, are allocated each pay period to eligible employees who have completed at least one hour of service during the Plan year.

Participant Accounts

Each participant's account is credited with the participant's voluntary contributions and allocations of (1) the employer's matching contributions, (2) the employer profit sharing contributions, (3) the employer's discretionary matching contributions, (4) Plan earnings and (5) administrative expenses. Allocations are based on participant compensation, participant-deferred percentages or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

Investment Options

Participants must direct contributions into various investment options as made available and determined by the Plan Administrator, which are more fully described in the Plan's literature. Participants may change their investment options any time throughout the year via telephone and/or Internet access to Empower.

Vesting

Participants are immediately vested in their voluntary contributions. Vesting in the Company's matching, discretionary matching and profit-sharing contributions is based on years of continuous service. A participant is 25% vested after one year of service, 50% vested after two years of service and fully vested after three years of service.

Forfeitures

The Plan provides for forfeitures of terminating participants' non-vested accounts to be used to pay any administrative expenses or to offset employer contributions. For the year ended December 31, 2024, approximately \$136,200 of forfeitures were used to reduce employer contributions. At December 31, 2024 and 2023, there were approximately \$290,700 and \$69,700 of unallocated forfeitures, respectively.

Payment of Benefits

Upon termination of employment with the Company due to death, disability, retirement or other reasons, a participant, or their designated beneficiary, will receive a lump-sum amount equal to the value of the participant's vested interest.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000, up to a maximum equal to the lesser of 50% of their vested account balance or \$50,000. Notes bear interest at a rate based on the prime rate as of the date of the loan request. Note payments are to be made at least quarterly over a period not to exceed five years or, in the event the note is used to acquire a principal residence, the repayment period may be extended up to 30 years. Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes are treated as distributions based upon the terms of the Plan document.

Administrative Expenses

The Plan's administrative expenses are paid by either the Plan or the Company. The Plan's trustee agrees to make quarterly allowance payments on behalf of the Plan in an amount equal to a percentage of Plan assets and is netted against administrative expenses on the statement of changes in net assets available for benefits. This allowance will be used to pay reasonable and incurred Plan administrative expenses.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting. Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Use of Estimates

The preparation of financial statements requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions to and deductions from assets during the reporting period. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements. Purchases and sales of investments are recorded on a trade-date basis. Interest income is accrued daily. Dividends are recorded on the ex-dividend date. In the statement of changes in net assets available for benefits, the Plan presents the net appreciation in fair value of its investments, which consists of the realized gains or losses and unrealized appreciation or depreciation on those investments.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits. Approximately 10% and 12% of the Plan's investments are held in the guaranteed income fund with Empower at December 31, 2024 and 2023, respectively.

Subsequent Events

The Plan has evaluated subsequent events through October 13, 2025, the date the financial statements were available to be issued.

NOTE 3 – FINANCIAL DATA CERTIFIED BY THE TRUSTEE

The following is a summary of the Plan's asset information as of December 31, 2024 and 2023, and for the year ended December 31, 2024, included throughout the Plan's financial statements and supplemental schedule, that was prepared by or derived from information provided by Empower and furnished to the Plan Administrator. The Plan Administrator has obtained certifications from Empower that information provided to the Plan Administrator by Empower related to the following assets is complete and accurate. Accordingly, as permitted by 29 CFR 2520.103-8 of the U.S. Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to information that appears throughout the financial statements and supplemental schedule related to the following assets.

NOTE 4 – FAIR VALUE MEASUREMENTS

The Plan’s investments are participant-directed accounts that are held by Empower.

Fair value is a market-based measurement that is determined based on assumptions that market participants would use in pricing an asset or liability. As a basis for considering such assumptions, the Company uses a three-tier fair value hierarchy, which prioritizes the inputs used in measuring fair value as follows:

- Level 1 – Valuation is based upon quoted prices for identical assets or liabilities in active markets;
- Level 2 – Valuation is based upon quoted prices for similar assets or liabilities in active markets, or other inputs that are observable for the asset or liability, either directly or indirectly for substantially the full term of the financial instrument; and
- Level 3 – Valuation is based upon other unobservable inputs that are significant to the fair value measurement.

The classification of fair value measurements within the hierarchy is based upon the lowest level of input that is significant to the measurement. The valuation methodologies used for assets and liabilities measured at fair value are as follows:

Registered investment companies: Valued at the daily closing price as reported by the fund.

Pooled separate account: Valued daily based on the market value of the underlying net assets in each separate account.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5 – TRANSACTIONS WITH PARTIES IN INTEREST

Certain Plan investments are shares of a guaranteed income fund managed by an affiliate of Empower, and therefore, these transactions qualify as party-in-interest transactions. Empower also makes quarterly allowance payments on behalf of the Plan in an amount equal to a percentage of Plan assets. This allowance is used to pay reasonable and incurred administrative expenses. For the year ended December 31, 2024, allowance payments of \$165,159 were used to pay Plan expenses.

Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Certain other administrative expenses for the Plan are paid directly by the Company.

NOTE 6 – TAX STATUS OF THE PLAN

The Plan adopted a non-standardized form of a pre-approved plan sponsored by Empower. The prototype plan has received an opinion letter, dated September 16, 2022, from the Internal Revenue Service as to the prototype plan's qualified status. The prototype plan opinion letter has been relied upon by this Plan. The Plan has been amended since the issuance of the opinion letter; however, the Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by taxing authorities. Management has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require the recognition of a liability or disclosure in the financial statements.

NOTE 7 – GUARANTEED INCOME FUND

The Plan entered into a traditional investment contract with Empower. The contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals, and administrative expenses. The contract value of the investment contract at December 31, 2024 and 2023 was \$16,999,932 and \$18,029,993, respectively. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The traditional investment contract held by the Plan is a guaranteed investment contract. The contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting interest rate is based on a formula agreed upon with the issuer, but it may not be less than 1.5%. Such interest rates are reviewed on a semiannual basis for resetting.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Examples of such events include the following:

1. The Plan's failure to qualify under Section 401(a) of the Internal Revenue Code or the failure of the trust to be tax-exempt under Section 501(a) of the Internal Revenue Code;
2. Premature termination of the contract;
3. Plan termination or merger;
4. Changes to the Plan's prohibition on competing investment;
5. Bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spinoffs of a subsidiary) that significantly affect the Plan's normal operations.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contracts with the Plan and settle at an amount different from contract value. Examples of such events include the following:

1. An uncured violation of the Plan's investment guidelines;
2. A breach of material obligation under the contract;
3. A material misrepresentation;
4. A material amendment to the agreement without the consent of the issue.
