### INDEPENDENT AUDITOR'S REPORT

To the Board of Directors

#### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of the MMG Insurance Company 401(k) Retirement Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits (modified cash basis) as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits (modified cash basis) for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

#### ***Opinion***

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with the modified cash basis of accounting as described in Note 2.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### ***Basis for Opinion***

We conducted our audit in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### ***Emphasis of Matter – Basis of Accounting***

We draw attention to Note 2 of the financial statements, which describes the basis of accounting. The financial statements and supplemental schedule are prepared on the modified cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America. Our opinion is not modified with respect to this matter.

### ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with the modified cash basis of accounting described in Note 2, and for determining that the modified cash basis of accounting is an acceptable basis for the preparation of the financial statements in the circumstances. Management is also responsible for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the MMG Insurance Company 401(k) Retirement Savings Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgement made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of the modified cash basis of accounting.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with the modified cash basis of accounting.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

NOTES TO FINANCIAL STATEMENTS

(1) DESCRIPTION OF PLAN

MMG Insurance Company (“the Company”) sponsors the MMG insurance Company 401(k) Retirement Savings Plan (“the Plan”). The following brief description provides only general information. Participants should refer to the Plan agreement for a more complete description.

The Plan is administered by the Benefits Committee, which is a committee appointed by the Company’s board of directors.

- a. **GENERAL** - The Plan is a defined contribution plan sponsored by MMG Insurance Company (“the Company”) and is subject to the Employee Retirement Income Security Act of 1974 (ERISA). The Plan is administered by the Benefits Committee, which is a committee appointed by the Company’s board of directors.
- b. **ELIGIBILITY** - Current and former employees of the Company who have reached the age of twenty-one and completed a six consecutive month period of employment or one year of participation service are eligible for participation in the Plan. A six consecutive month period means the initial six consecutive month period beginning with the date the employee is hired by the Company and each successive six consecutive month period beginning thereafter. A year of participation service means an eligibility computation period during which the employee has completed one thousand or more hours of service during the twelve months beginning with the date he/she is hired.
- c. **EMPLOYEE CONTRIBUTIONS** - Each year, current employee participants may elect to contribute from 1% to 75% of their pay up to the maximum amount allowable by law (\$23,000 and \$22,500 for 2024 and 2023, respectively). Participants who have obtained age 50 before the end of the plan year are eligible to make catch up contributions of \$7,500 for 2024 and 2023. At the beginning of each plan year, an employee’s deferral will increase automatically by 1% up to a maximum of 8% for 2024 and 2023, unless the employee elects otherwise. Eligible employees who do not make an election to contribute will be automatically enrolled to contribute 6% of their pay. The Plan also allows employees to make Roth contributions and in-plan Roth transfers.
- d. **EMPLOYER CONTRIBUTIONS** – Each year, the Company will make the following contributions to the Plan:
  - a nonelective contribution of 3% of each eligible employee’s eligible compensation, plus
  - a matching contribution of 100% of the employee’s elective contributions up to 2% of their eligible compensation, plus
  - a matching contribution of 50% of the employee’s elective contributions in excess of 2% and not exceeding 6% of their eligible compensation, plus
  - a discretionary contribution of a percent of each employee’s pay at the option of the Company.

There were no discretionary contributions made in 2024 or 2023.

Total contributions for each participant cannot exceed \$69,000 and \$66,000 for 2024 and 2023, respectively. Contributions to the Plan are made in a timely manner in accordance with ERISA regulations.

(1) DESCRIPTION OF PLAN (cont'd.)

- e. **ROLLOVERS** - The assets of another qualified retirement plan may be transferred directly to the Plan with the consent of the Benefits Committee.
- f. **PARTICIPANT ACCOUNTS** - Each participant's individual account is credited with the participant's contribution, rollover contributions, the Company's contributions and an allocation of the Plan's realized and unrealized investment gains or losses and net income. Participants direct the investment of all contributions, both employer and employee, into various investment options offered by the Plan. If a participant does not make an investment direction or an investment direction is not received by the Plan administrator (or by the person or persons specified by the Plan administrator) before the participant commences participation, the contributions on behalf of such participant shall be invested in the age-appropriate Target Date Retirement Fund or such other investment fund designated by the Plan administrator for such purpose. The Target Date Retirement Funds are closest to the year the employee will turn age 65.

The Company's contributions are allocated based on the participant's elected allocation. Allocation of the Plan's investment gains or losses and net income is based on the participant's particular investment mix. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

- g. **VESTING** – All contributions allocated to a participant's account, plus earnings thereon, are 100% vested at all times.
- h. **NOTES RECEIVABLE FROM PARTICIPANTS** - Participants may borrow from their participant account balance. The loan must be for a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms will not exceed five (5) years unless used for the purpose of acquiring a principal residence of the participant. The loans are secured by the balance in the participant's account and currently bear interest at 4.25%-9.5%. Rates are based on the WSJ Prime Rate plus 1%. Principal and interest are paid through bi-weekly payroll deductions.
- i. **PAYMENT OF BENEFITS** - Payment of benefits is available upon the participant's retirement, termination of employment, the normal retirement age of 65, death or permanent and total disability. If the participant's account does not exceed \$1,000 it will be distributed in a single lump-sum amount. Accounts in excess of \$1,000 can be distributed as substantially equal annual installment payments or as one lump-sum payment. Required minimum distributions (RMD) begin at age 72 (73 if the participant reaches age 72 after December 31, 2022).
- j. **IN-SERVICE DISTRIBUTIONS** – A participant who reaches age 59 ½ may withdraw his or her vested balance (reduced by the outstanding loan balance of any loans made to the participant from such account) at any time. Any participant may withdraw his or her rollover contributions at any time and may withdraw their matching and discretionary contributions after they have been held for two years with five years of service.

(1) DESCRIPTION OF PLAN (cont'd.)

- k. **HARDSHIP WITHDRAWALS** - A participant may withdraw from his or her elective contributions account, matching contributions account, discretionary contributions account, and transition non-elective contributions account to satisfy an immediate and heavy financial need as defined by the Plan and subject to Internal Revenue Service (IRS) and 401(k) regulations (hardship distribution). There were no hardship distributions in 2024 or 2023.
- l. **ADMINISTRATIVE EXPENSE** – The Plan allows certain administrative expenses to be paid from the Plan assets.
- m. **FORFEITURES**- As of December 31, 2024 and 2023, forfeited non-vested accounts totaled \$0. These accounts may be used to pay reasonable plan expenses and the remaining balance is to be allocated to the participant accounts in the following plan year.

(2) SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

*Basis of Accounting*

The accompanying financial statements of the Plan have been prepared using the modified cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America, but is an acceptable method of reporting under Department of Labor regulations. Under the modified cash basis, investments are reported at fair value and participant loans and employer contributions are recorded as receivables. However, receivables are not recorded for participant contributions withheld but not yet received and for net investment gains/losses earned but not yet received by the Plan.

*Use of Estimates*

The preparation of financial statements in accordance with the modified cash basis of accounting requires the plan administrator to make estimates and assumptions that affect the reported amounts and disclosure. Accordingly, actual results may differ from those estimates.

*Investment Valuation and Income Recognition*

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability. Plan management determines the Plan's valuation policies utilizing information provided by the trustee. (See Note 6). Investment transactions are recorded on the trade-date basis. Dividends are recorded when received. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Interest income is recorded when received.

*Notes Receivable from Participants*

Loans are recorded at their unpaid principal balance plus accrued but unpaid interest. Defaulted loans can be offset against the balance of the participant accounts and may be treated as a taxable distribution. No allowance for doubtful accounts is necessary since the loans are fully secured by the participant accounts.

(2) SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (cont'd.)

*Payment of Benefits*

Benefits are recorded when paid.

*Subsequent Events*

Management evaluated subsequent events through October 7, 2025, the date the financial statements were available to be issued.

(3) TAX STATUS

On November 18, 2010, the Plan applied for a determination letter from the IRS on the amended and restated Plan document effective January 1, 2010 and received a favorable determination letter on August 11, 2011. Effective January 1, 2015 and January 1, 2021, the Plan document was amended and restated in its entirety onto the Downeast Pension Services, Inc. Defined Contribution Volume Submitter Plan (an IRS approved plan). Although the Plan has been amended since receiving the determination letter, the Company believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

The modified cash basis of accounting requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Company has taken an uncertain tax position that, more likely than not, would not be sustained upon examination by the IRS or DOL. The plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain tax positions taken by the Plan that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by the IRS and the DOL; however, there are currently no audits in progress.

(4) EXPENSES

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participants' account and are included in administrative expenses. Investment related expenses are included in the net appreciation of the fair value of investments. A portion of the investment related expenses are refunded to the Plan through a plan expense reduction account (PERA) and a separate credit account. Those amounts were \$27,961 and \$23,769 for 2024 and 2023, respectively. Fees paid from the PERA were \$20,075 and \$14,245 for the years ended 2024 and 2023, respectively. Any remaining PERA credits at year end are allocated to the accounts of plan participants during the following plan year.

(6) FAIR VALUE MEASUREMENTS

The Plan's investments are reported at fair value. The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows.

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in active markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The following is a description of the valuation methods used for assets measured at fair value. There have been no significant changes in the methodologies used on December 31, 2024 as compared to 2023.

(6) FAIR VALUE MEASUREMENTS (cont'd.)

Registered investment companies: The fair values of these investments are based on observable market quotations for identical assets and are priced on a daily basis at the close of business.

Common/collective trust: The collective trust funds are public investment vehicles valued using a Net Asset Value (NAV) provided by the manager of each fund. The NAV is based on the underlying net assets owned by the fund, divided by the number of shares outstanding. The NAV's unit price is based on the fair value of the underlying securities within the fund, which are traded on an active market, and valued at the closing price reported on the active market on which those individual securities are traded. The significant investment strategy is preservation of capital and is further described in the financial statements provided by each fund. There are no restrictions on redemptions from these funds.

The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. The Plan believes its valuation methods are appropriate and consistent; however, the use of different valuation methodologies or assumptions could result in a different fair value determination.

(7) PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions and to terminate the Plan subject to the provisions of ERISA. In the event of a termination, participant account balances would be distributed to them as soon as practicable after such event.

(8) RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amount reported in the statement of net assets available for benefits.

(9) RELATED PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

Certain administrative functions are performed by officers and employees of the Company. No officer or employee receives compensation from the Plan for these services.

Some Plan investments are invested in mutual funds managed or sponsored by John Hancock Advisers, LLC. John Hancock Trust Company LLC is the trustee of the Plan assets, and therefore, these transactions as well as notes receivable from participants, qualify as related party and party-in-interest transactions. Various fee arrangements with these parties are described in Note 4.

(10) CLASSIFICATION DIFFERENCES

The Form 5500 has certain income and expense items that differ from amounts shown on the accompanying financial statements. These differences related to classification only and have no effect on the net assets available for benefits for either period.
