### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of IMCMV Holdings, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). **Note 1 – Description of the Plan**

The following description of IMCMV Holdings, Inc. 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more comprehensive description of the Plan’s provisions.

*General* – The Plan is a multiple-employer defined contribution plan covering employees of IMCMV Holdings, Inc. and participating affiliates (collectively referred to as the “Company”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”) and was established effective January 1, 2014, and was restated effective February 1, 2022, to comply with the Internal Revenue Service (“IRS”) regulations for periodic plan restatement.

*Eligibility* – The Plan covers employees of the Company who have completed one year of service and are age twenty-one or older. A year of service is defined by the Plan as a year in which an employee is credited with 1,000 hours of service. The Plan permits for entry dates on the first day of each quarter coinciding with or following the date the requirements are met.

*Contributions* – Participants may, through salary deferrals, make regular 401(k) and Roth 401(k) contributions up to the maximum allowed under Section 402(g) of the Internal Revenue Code (“IRC”). A participant’s deferral cannot exceed 90% of their compensation. The Company contributes safe harbor matching contributions of 100% of participants’ salary deferrals up to 3% of their compensation, and 50% of participants’ salary deferrals in excess of 3%, up to 5% of their compensation. The Company may also make discretionary non-elective profit sharing contributions. The Company did not make any non-elective profit sharing contributions during 2024.

*Participant accounts* – Each participant’s account is credited and/or reduced with the participant’s contributions and withdrawals, employer safe harbor matching and profit sharing contributions, allocations of the Plan earnings and losses, and an allocation of administrative fees. Allocations are based on participant earnings, participant elective contributions, or account balances, as defined by the Plan. The benefit to which a participant is entitled is vested balance in the participant’s account.

*Vesting* – Participants are immediately 100% vested in their salary deferral contributions, the Company’s safe harbor matching contribution and actual earnings thereon. Vesting in the Company’s non-elective profit sharing contributions and actual earnings thereon is based on years of continuous service. Participants vest 20% in the Company’s non-elective profit sharing contributions after two years of service and vest an additional 20% each year thereafter until fully vested after six years of service.

*Termination* – Although it has not expressed an intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

**Note 1 – Description of the Plan (Continued)**

*Payment of benefits* – Distribution of a participant's vested account balance to the participant or his or her beneficiary may commence upon the earlier of retirement, death, disability, or separation from service. A participant may elect to receive an amount equal to the value of the vested interest in his or her account in a single lump-sum payment, installment or direct rollover. Distributions are subject to the applicable provisions of the Plan document.

The Plan allows participants to withdraw amounts from their account balances while actively employed. A participant experiencing financial hardship, as defined in the Plan document, may, with sufficient evidence, withdraw a portion of their account. The amount of the withdrawal may not be greater than the immediate financial need. These hardship withdrawals are subject to IRC restrictions and penalties. The Plan also allows for actively employed participants to withdraw from all account balances once the age of fifty-nine and a half has been reached.

*Note receivables from participants* – Participants may borrow from their accounts a minimum of \$1,000, up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Participants may not have more than one loan outstanding at any given time. Principal and interest are paid ratably through payroll deductions over a period not to exceed five years, unless the loan was used to acquire a principal residence, in which case the repayment period may exceed five years. Notes are secured by the vested balances in participants' accounts.

*Forfeitures* – Any non-vested portion of employer profit-sharing contributions credited to the accounts of participants who withdraw from the Plan are forfeited and used for either payment of eligible administrative expenses or to reduce the payment of employer contributions. The Plan had forfeiture balances as of December 31, 2024 and 2023, of approximately \$35 and \$6,600. Approximately \$12,500 of forfeitures were used during the year ended December 31, 2024 to decrease employer contributions.

**Note 2 – Summary of Significant Accounting Policies**

*Basis of accounting* – The accompanying financial statements have been prepared on the accrual basis of accounting.

*Use of estimates* – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires plan management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions to and deductions from net assets during the reporting period. Actual results could differ from those estimates.

*Notes receivable from participants* – Notes receivable from participants are recorded at the unpaid principal balance plus any accrued but unpaid interest. Delinquent participant notes are deemed distributions based upon the terms of the Plan document. The interest rate on loans outstanding as of December 31, 2024, ranged between 4.25% and 9.5%.

*Benefits paid to participants* – Benefits are recorded when processed and paid by the Plan.

**Note 2 – Summary of Significant Accounting Policies (Continued)**

*Investments, investment valuation, and income recognition* – Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value determinations, other than those measured using the net asset value (“NAV”) as a practical expedient, are made based upon a fair value hierarchy that prioritizes the inputs to valuation techniques. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of inputs that may be used to measure fair value:

Level 1 – Inputs to the valuation methodology are quoted prices available in active markets for identical investments as of the reporting date;

Level 2 – Inputs to the valuation methodology are other-than-quoted prices in active markets, which are either directly or indirectly observable as of the reporting date, and fair value can be determined through the use of models or other valuation methodologies; and,

Level 3 – Inputs to the valuation methodology are unobservable inputs in situations where there is little or no market activity for the asset or liability and the reporting entity makes estimates and assumptions related to the pricing of the asset or liability including assumptions regarding risk.

A financial instrument’s level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. The following is a description of the valuation methodologies used for instruments measured at fair value, including the general classification of such instruments pursuant to the valuation hierarchy:

Pooled separate accounts – These investments are public investment vehicles valued using the NAV provided by the administrator of the fund. The NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. The NAV is a quoted price in an active market; however, the investments are in pooled separate accounts through the subaccounts of the trustee and, therefore, are classified within Level 2 of the valuation hierarchy.

Fixed annuity contract – The fair value of the fixed annuity contract is based on the contract value less contract surrender charges and market value adjustments, if any. The contract value equals the accumulated cash contributions, interest credited to the contract, and transfers, if any, less any withdrawals and transfers, if any. These investments are classified within Level 3 of the valuation hierarchy.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

*Investments, investment valuation, and income recognition (Continued)* – Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

*Administrative expenses* – Administrative expenses paid by the Plan are recorded when incurred. The Company absorbs a significant amount of the cost of plan administration.

**Note 5 – Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statement of net assets available for benefits.

**Note 6 – Income Tax Status**

The Plan is a pre-approved profit-sharing plan (“Pre-Approved Plan”) sponsored by Southern Pension Services. (“SPS”), the third-party administrator of the Plan. SPS obtained its latest opinion letter dated June 30, 2020, in which the IRS stated that the Pre-Approved Plan, as then designed, was in compliance with the applicable requirements of the IRC. Although the Plan has been amended since receiving the opinion letter, the plan administrator believes that the Plan is currently designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, as the related trust is tax-exempt. Therefore, no provision for income taxes has been included in the Plan’s financial statements.

**Note 7 – Party-in-Interest Transactions**

Certain Plan investments are managed by Voya, therefore, the investment transactions qualify as party-in-interest transactions. Additionally, the Plan’s group fixed annuity contract was issued by Voya, therefore, the investment transactions qualify as party-in-interest transactions. Notes receivable from participants are also considered to be party-in-interest transactions because they are transacted with Plan participants. Fees paid during the year for services rendered by parties-in-interest were based on customary rates for such services. While these transactions qualify as party-in-interest activity, they are expressly exempted from prohibited transactions rules (ERISA, Tittle 1, and Section 408 (b)).
