Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of the Boys and Girls Clubs of Metro Denver, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). December 31, 2024 and 2023

(1) General Description of the Plan

The following description of the Boys and Girls Clubs of Metro Denver, Inc. 401(k) Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for more complete description of the Plan's provisions.

(a) General

The Plan is a defined contribution plan that covers all employees of the Boys and Girls Clubs of Metro Denver (BGCMD) who are age 21 or older and are not non-permanent employees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

(b) Contributions

Participants are allowed to make pre-tax and Roth voluntary contributions to the Plan beginning with the first pay period following their date of hire. Each year, participants may contribute up to the maximum amount permitted by law. Participants age 50 or older are eligible to make catch-up contributions. Participants may also contribute rollover amounts from other qualified plans.

Participants direct the investment of their contributions among various investment options offered by the Plan, which currently include twenty-one pooled separate accounts and one guaranteed annuity fund. If a participant does not make an investment election, their contributions and any employer contributions are automatically invested in the American Century One Choice Investments A based on the participant's date of birth.

Effective January 1, 2024, the Plan was amended to expand eligibility by reducing service requirements to the three months and to set the first day of each plan quarter as the entry date for Employer Safe Harbor Matching contributions. Effective the same date, BGCMD makes employer contributions equal to 100% of employee contributions up to 5% of compensation. BGCMD may also make discretionary matching contributions not to exceed 4% of a participant's compensation. Employer contributions are invested according to the participant's investment elections.

(c) Participant Accounts

Each participant's account is credited with the participant's, BGCMD's, and rollover contributions and participant earnings. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

If a participant terminates employment, the participant may elect to receive a distribution of some or all of the participant's vested account balance.

(1) General Description of the Plan, Continued

(d) Vesting

Effective January 1, 2024, participants are fully (100%) vested in their Elective Deferral Account, Rollover Contribution Account, Qualified Non-Elective Contribution Account, Employer Matching Contribution Account, and Safe Harbor Matching Contribution Account, plus actual earnings thereon.

(e) Notes Receivable from Participants

Participants may borrow from their fund account a minimum of \$1,000 up to a maximum amount of the lesser of 50% of the participant's vested account balance or \$50,000 minus the highest total outstanding Plan loan balance in the 12 months immediately before the date of the participant's new loan. The loans are secured by the balance in the participant's account and bear interest rates of Prime + 2% which are similar to loans from commercial lending institutions. Loans must be repaid in substantially level, amortized payments over a period not exceeding 5 years, except in the purchase of a primary residence, in which case the term is 30 years. Total loans outstanding at December 31, 2024 and 2023 were \$72,714 and \$76,856, respectively.

(f) Payment of Benefits

On termination of service due to death, a single lump-sum cash payment or annuity options will be made to the participant's designated beneficiary. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution, an annuity option or a direct rollover to an individual retirement account or to another employer's tax qualified plan. In those cases, a participant whose account balance does not exceed \$1,000 will receive a distribution in cash. For account balances greater than \$1,000 but less than \$5,000, a participant's vested balance will be distributed from the Plan, either via cash distribution or a direct rollover to an individual retirement account or to another employer's qualified plan. If a participant's vested account balance exceeds \$5,000, the participant must consent to any distributions of those funds unless the participant has attained the normal retirement age of 65. Participants who are age 59 ½ and still employed by BGCMD may withdraw all or a portion of their respective vested account balance.

(g) Forfeited Accounts

During 2024 and 2023, forfeitures of non-vested accounts totaled \$2,107 and \$2,830, respectively. Forfeitures are used to pay certain Plan expenses or to reduce BGCMD's contributions to the Plan. Forfeited balances were used to offset employer contributions in 2024 and 2023.

(1) General Description of the Plan, Continued

(h) Hardship Distributions

The Plan permits the withdrawal of a hardship distribution by a participant to satisfy immediate and heavy financial needs. A hardship distribution may be made only for certain needs, including medical expenses, costs related to the purchase of a principal residence, costs to prevent eviction from a principal residence, burial or funeral expenses, expenses for the repair of damage to a participant's personal residence, or certain education expenses for post-secondary education. Furthermore, the distribution cannot be more than the amount of the participant's immediate and heavy financial need. The distribution can be made only from the participant's salary deferrals (including catch-up contributions) and rollover contributions.

(i) Expenses

Plan administration fees are paid from the assets of the Plan to the extent permitted. Expenses may be allocated among all Plan participants or charged directly against individual account balances. Fees charged directly to individual account balances include general recordkeeping fees and expenses related to processing distributions or loans, qualified domestic relations orders, and directing the investment of the participants' account balance. Other expenses incurred to manage, administer, and audit the Plan are paid by BGCMD.

(2) Summary of Significant Accounting Policies

(a) Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

(b) Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires the Plan's administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

(c) Investments

Investments are stated at fair value, except for the guaranteed fixed annuity account, which is valued at contract value, (see note 6). Fair value is determined as more fully described in note 2(d). The market values for the separate accounts represent the Plan's pro-rata interest in the net assets of each investment and are based on the fair value of the underlying assets.

These investments are not publicly traded on national security market exchanges and may be valued differently than if readily available markets existed for such investments. Management is responsible for the fair value measurement of investments reported in the financial statements and believes that the reported values are reasonable.

(c) Investments, Continued

Investment return consists of the Plan's distributive share of any interest, dividends, capital gains and losses, generated from investments, as well as the change in fair value of the investments. Gains and losses attributable to investments are realized and reported upon a sales or disposition of the investments. Unrealized gains and losses are included in the change in net assets available for benefits.

(d) Fair Value Measurements

Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. U.S. GAAP establishes a fair value hierarchy that prioritizes investments based on the assumptions market participants would use when pricing an asset. The fair value hierarchy gives the highest priority to quoted prices in active markets (observable inputs) and the lowest priority to an entity's assumptions (unobservable inputs). The Plan groups assets at fair value in three levels based on the markets in which the assets and liabilities are traded, and the reliability of the assumptions used to determine fair value. In addition, the Plan reports certain investments using the "practical expedient" method. The practical expedient allows net asset value per share or its equivalent to represent fair value for reporting purposes when the criteria for using this method are met. Investments valued using net asset value per share or its equivalent are not categorized within the hierarchy.

These levels are:

- Level 1 Unadjusted quoted market prices for identical assets or liabilities in active markets as of the measurement date.
- Level 2 Other observable inputs, either directly or indirectly, including:
 - Quoted prices for similar assets/liabilities in active markets;
 - Quoted prices for identical or similar assets in non-active markets;
 - Inputs other than quoted prices that are observable for the asset/liability; and,
 - Inputs that are derived principally from or corroborated by other observable market data.
- Level 3 Unobservable inputs that cannot be corroborated by observable market data.

In certain cases, the inputs used to measure fair value may fall into different levels of the fair value hierarchy. In such cases, an investment's level within the fair value hierarchy is based on the lowest level of input that is significant to the fair value measurement. These classifications (Level 1, 2 and 3) are intended to reflect the observability of inputs used in the valuation of investments and are not necessarily an indication of risk or liquidity.

Market price is affected by a number of factors, including the type of instrument and the characteristics specific to the instrument, as well as the effects of market, interest and credit risk. Instruments with readily available active quoted prices or for which fair value can be measured from actively quoted prices generally will have a higher degree of market price observability and a lesser degree of judgment used in measuring fair value. It is reasonably possible that change in values of these instruments will occur in the near term and that such changes could materially affect amounts reported in the Plan's financial statements.

(e) Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Participant loans are placed on nonaccrual status at the time a participant terminates employment and makes no further payments on the loan. A participant loan is considered delinquent as of the last day of the calendar quarter following the quarter in which an unpaid installment payment was due, at which time the entire balance of principal and interest is due. A terminated employee is required to repay the entire balance of principal and interest by the last day of the calendar quarter following the quarter in which termination occurs. If unpaid, these participant loans for terminated participants are reclassified as distributions based upon the terms of the Plan document; therefore, there is no allowance for doubtful accounts.

Because all loans are secured in full by the balance in the participant's account, management believes these loans are very likely to be collected and any amount that would be written-off is considered insignificant.

(f) Payment of Benefits

Benefits are recorded when paid.

(g) Participant Accounting Records

The Plan's custodian maintains individual participants' accounting records. Contributions and income are allocated by the custodian to the participants' accounts on all business days, and statements are prepared and sent to all participants quarterly.

(h) Subsequent Events

Management has evaluated subsequent events through October 13, 2025, the date the financial statements were available to be issued.

(3) Plan Termination

Although it has not expressed any intent to do so, BGCMD has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their accounts.

(4) Tax Status

The Plan has been informed by its contract administrator that the adopted volume submitter profit sharing plan is designed in accordance with applicable sections of the Internal Revenue Code. The Plan has been amended since its adoption. BGCMD is of the opinion that the Plan fulfills the applicable requirements of a qualified plan. Accordingly, no provision for federal or state taxes has been provided.

(4) Tax Status, Continued

Generally accepted accounting principles require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by taxing authorities. The Plan administrator has analyzed the tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements and determined there are none. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan files Form 5500, and the three previous tax years remain subject to examination.

(5) Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

(6) Guaranteed Fixed Annuity Contract

The Plan invests in the AUL Stable Value Account, a fully benefit-responsive fixed annuity contract issued by American United Life Insurance Company (AUL). AUL maintains the contributions in a general account. The account is credited with earnings on underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed fixed annuity contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is established at the beginning of each calendar year that will never be less than 0% with no upper limits. This plan has a 90-day window for transferring money out of the account. Under the 90-day option, plan participants can transfer any amount from the account but no money may be transferred back into the account until 90 days have elapsed since the date of the last transfer from the account. Under certain circumstances, AUL may terminate the contract prior to the scheduled maturity date with 90 days written notice.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by AUL, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

(6) Guaranteed Fixed Annuity Contract, Continued

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, and (4) a material amendment to the agreement with the consent of the issuer.

(7) Investments

Pooled separate accounts are invested in underlying funds that primarily consist of equity securities, fixed-income instruments and other mutual funds and short-term instruments. Investments are valued daily and can be redeemed with a one-day notice period.

(8) Related Party Transactions

Investment products, custodial and trustee services are provided by American United Life Insurance Company and third-party administrative services are provided by TPA Services, Inc. Transactions with American United Life Insurance Company and TPA Services, Inc. qualify as party-in-interest transactions. Fees paid by the Plan for administrative services were \$13,892 in 2024 and \$2,751 in 2023.

(9) Financial Data Certified by the Plan Trustee

The Plan administrator has elected the method of compliance permitted by Section 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the Plan trustees have certified all financial data from which the Plan investment balances and activities reported on the statement of net assets available for benefits, the statement of changes in net assets available for benefits and the supplemental schedule of assets held for investment purposes have been prepared.
