Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of CommentSold, LLC 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

NOTE 1 – DESCRIPTION OF THE PLAN

The following description of the CommentSold, LLC 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General

The Plan is a participant-directed defined contribution plan established on January 1, 2020 by CommentSold, LLC (the “Company”, “Employer”, or “Plan Sponsor”) to provide benefits to eligible employees as defined in the Plan document. The Plan is currently designed to be qualified under the applicable requirements of the Internal Revenue Code (“IRC”) and the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). It also provides certain benefits in the event of death, disability, or other termination of employment. Matrix Trust Company (“Matrix”) was the Plan’s Trustee for the year ended December 31, 2023 and from the period of January 1, 2024 to January 23, 2024 and Principal Life Insurance Company and Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company, (collectively referred to as “Principal”) is the Plan’s Trustee for the period of January 24, 2024 to December 31, 2024 (collectively, the “Trustees”).

Transfers to the Plan

On January 24, 2024 the Plan’s former trustee, Matrix, transferred all Plan assets to Principal in the amount of \$6,302,641.

Plan Administration

The Company is the administrator of the Plan and, as such, carries out the duties imposed by ERISA. The Company has appointed the Administrative Committee to oversee the operation and administration of the Plan. Matrix Trust Company was the Plan’s former directed trustee and asset custodian. Principal currently serves as the Plan’s directed trustee and asset custodian and an affiliate of Principal provides record-keeping services and manages participant accounts and participant-related transactions.

Contributions

Participants may contribute to the Plan, on a pre-tax up to 100% of eligible compensation and/or Roth basis up to 50% of eligible compensation each pay period, subject to statutory and regulatory limitations. Pre-tax contributions are excluded from the participant’s federal taxable income until received as a withdrawal or distribution from the Plan. Roth deferral contributions are included in the participant’s federal taxable income. Participants may also contribute amounts representing rollover distributions from other qualified plans. During 2024, the maximum annual 401(k) pre-tax contribution limit was \$23,000 and the maximum annual catch-up contribution for participants aged 50 and older was \$7,500. The Plan provides for discretionary employer matching contributions for all eligible participants. The employer matching contributions are calculated as 100% of participant deferrals up to a maximum of 3% of eligible wages. The employer matching contributions totaled \$300,158 for the year ended December 31, 2024. The Company may make qualified non-elective contributions (“QNECs”) in addition to discretionary employer matching contributions. For the year ended December 31, 2024, there were no discretionary employer matching contributions or QNEC’s made.

Participant Accounts

Each participant's account is credited or charged with the participant's contribution and allocations of (i) employer's 401(k) matching contributions and (ii) the participant's share of earnings or losses on contributions and administrative expenses. Each participant directs all amounts credited into their account into one or more of the investment options available under the Plan. Accordingly, as a participant-directed plan, each participant's investments determine their share of earnings or losses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions, rollovers, qualified non-elective contributions and non-elective contributions plus actual earnings thereon. Vesting in employer's matching and discretionary contributions plus actual earnings thereon is based on years of continuous service. A participant is 100% vested in employer contributions and earnings thereon after one year of credited service.

Investment Options

Participants direct the investment of their contributions into various investment options offered by the Plan. Participants may change their contribution investment options daily and may transfer part or all of past investments to other investment options daily. Participants may elect to change their salary deferrals on a daily basis.

Participants may borrow from their vested fund account balance at a minimum of \$1,000 and up to a maximum equal to the lesser of \$50,000 minus the difference between the highest outstanding loan balance during the one-year period ending on the date the loan is made or 50% of the vested interest of the participant in the Plan. A participant may have no more than two loan outstanding at any time. The maximum payment term allowed for any loan will be five years. The loans are secured by the balance in the participant's account and bear interest at rates based on similar loans available from commercial lending institutions, as determined by the Plan Administrator, as of the date of the loan. Participant's notes are valued at the outstanding loan balance, plus any accrued but unpaid interest. Principal and interest are paid ratably through weekly payroll deductions. Loans mature through April 2029 with interest rates ranging from 4.25% to 10.50%.

Hardship and In-Service Withdrawals

Plan participants may take hardship withdrawals from the vested portion of their account. The distribution is limited to the amount necessary to meet the financial need created by the hardship. Participants may withdraw all or a portion of any rollover contributions, plus earnings thereon, for any reason. Participants who have reached age 59 ½ may withdraw all or a portion of the vested portion of their account for any reason.

NOTE 1 – DESCRIPTION OF THE PLAN (Continued)

Deemed Distributions

When a participant fails to make loan repayments under the terms of the loan agreement, the loan is considered to be in default. Deemed distributions on defaulted loans are recorded in the calendar quarter following the calendar quarter during which the loan was defaulted. These amounts are no longer included in net assets available for benefits and are recorded as benefits paid to participants. There were no deemed distributions for the year ended December 31, 2024.

Benefit Payments

Upon termination of service due to death, disability or retirement, as defined in the Plan, participants are entitled to a fully vested lump sum payment of their account balance. For termination of service due to other reasons, participants are entitled to the value of the vested interest in their account. As of December 31, 2024, all employees who elected to withdraw from the Plan had been paid. As of December 31, 2023 there were \$5,048 of distributions that were traded from participant accounts but not paid until after December 31, 2023.

Forfeited Accounts

When certain terminations of participation in the Plan occur, the nonvested portion of the participant's account, as defined by the Plan, represents a forfeiture. However, if the participant is re-employed and fulfills certain requirements as defined by the Plan, the participant's account will be reinstated. Unused forfeitures may be used to reduce future employer matching contributions. During the year ended December 31, 2024, \$752 of forfeitures were used to reduce employer matching contributions.

Expenses of the Plan

Certain expenses of maintaining the Plan are paid by the Plan, unless paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation of fair value of investments. Certain administrative functions are performed by officers or employees of the Plan Sponsor. No such officer or employee receives compensation from the Plan.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The Plan's financial statements are prepared in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Use of Estimates

The preparation of the Plan's financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Investment Valuation and Income Recognition

All Plan investments are held by the Trustees. The Plan's investments, except the Principal Guaranteed Option ("PGO") are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex dividend date. The Plan presents, in the Statement of Changes in Net Assets Available for Benefits, the net appreciation or depreciation in the fair value of its investments, which consists of the realized gains or losses and the unrealized appreciation or depreciation on those investments. Pooled separate accounts are valued at quoted market prices, which represent the net asset value ("NAV") of shares held by the Plan at year end.

The PGO is a stable value investment with a guaranteed rate of return that is set in advance for a six-month period and a guarantee of principal. It is provided through a group annuity contract issued by Principal.

In general, issuers may terminate the contract and settle at other than contract value if there is a change in the qualification status of a participant, Employer, or Plan; a breach of material obligations under the contract and misrepresentation by the contract holder; or failure of the underlying portfolio to conform to the pre-established investment guidelines.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

Payment of Benefits

Benefits are recorded when paid.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Subsequent Events

The Plan has evaluated subsequent events for recognition or disclosure through the date these financial statements were available for issuance, October 10, 2025.

NOTE 3 – INFORMATION CERTIFIED BY THE TRUSTEES

The Plan Administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor (“DOL”)’s Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Matrix and Principal, the Trustees of the Plan have certified to the completeness and accuracy of:

- Investments, cash, and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023;
- Net appreciation in the fair value of the investments and interest and dividends reflected on the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024; and
- Investments reflected on the schedule of assets (held at end of year) as of December 31, 2024.

NOTE 4 – FULLY BENEFIT-RESPONSIVE GUARANTEED INVESTMENT CONTRACT

The Plan has a fully benefit responsive investment contract with the Principal Life Insurance Company (“PLIC”). PLIC maintains the contributions in a general account that is comprised of a guaranteed investment contract (“GIC”). This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals, and administrative expenses.

The traditional investment contract held by the Plan is a guaranteed investment contract. The contract issuer is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer. As of December 31, 2024, the crediting rate was 4.85%. The crediting rate is reviewed on a quarterly basis for resetting. The contract cannot be terminated before the scheduled maturity date.

Certain events may limit the Plan’s ability to transact at contract value with the contract issuer. These events may be different under each contract. Examples of such events include the following: (i) the Plan’s failure to qualify under Section 457 of the IRC or the failure of the trust to be tax-exempt under Section 510(a) of the IRC, (ii) premature termination of the contract, (iii) Plan termination or merger, (iv) changes to the Plan’s prohibition on competing investment options, and (v) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that significantly affect the Plan’s normal operations. The Plan Administrator does not believe that any events would limit the Plan’s ability to transact at contract value with Plan participants are probable of occurring. In addition certain events allow the issuer to terminate the contracts with the Plan and settle at any amount different from contract value. These events may be different under each contract. Examples of such events include the following: (i) an uncured violation of the Plan’s investment guidelines, (ii) a breach of material obligation under the contract, (iii) a material misrepresentation, and (iv) a material amendment to the agreements without the consent of the issuer.

As of December 31, 2024 the Plan maintained one GIC related investment option, the Principal Guaranteed Option. The contract value of the investment in the Principal Guaranteed Option was \$854,364 which approximates fair value, as of December 31, 2024.

NOTE 5 – FAIR VALUE MEASUREMENTS

The Financial Accounting Standards Board (“FASB”) authoritative guidance establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Pooled Separate Accounts (“PSAs”): Valued at fair value based on the NAV of underlying investments (i.e., common stock, mutual funds, short term securities). While the majority of the underlying assets values are based on quoted prices, the NAV of the pooled separate account is not publicly quoted. The NAV is reported by the fund managers as of the financial statement date based on recent transaction prices. The PSAs held by the Plan provide for daily redemptions by the Plan at reported NAV with no advance notice requirement. The Plan is permitted to redeem investment units at NAV on the measurement date.

Mutual funds and money market funds: Valued at the quoted market prices of shares or units held by the Plan.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 6 – EXEMPT PARTY-IN INTEREST

At December 31, 2024, all Plan investments were in investment funds managed by Principal. and therefore, these transactions qualify as party-in-interest transactions. Administrative fees paid by the Plan to the Trustees were \$51,909 for the year ended December 31, 2024. Notes receivable from participants also qualify as party-in-interest transactions.

NOTE 7 – PLAN TERMINATION

Although it has not expressed any intention to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA.

NOTE 8 – TAX STATUS

Effective January 1, 2020, the Company adopted a Non-Standardized Pre-Approved Profit Sharing Plan with Cash or Deferred Arrangement (“CODA”) sponsored by Principal Life Insurance Company which received an opinion letter from the Internal Revenue Service (“IRS”), dated June 30, 2020, as to the Plan’s qualified status. The Plan Administrator believes that the Plan is designed and is being operated in compliance with the applicable provisions of the IRC, and accordingly no provision for income taxes has been included in the Plan’s financial statements.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the DOL. The Plan’s management does not believe that there are uncertain tax positions.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan’s administrator believes it is no longer subject to tax examinations for years prior to 2021.

NOTE 9 – PROHIBITED TRANSACTIONS

During 2024, the Plan Sponsor inadvertently failed to deposit \$113,193 of participant contributions and loan repayments within the required time frame as stated by the DOL regulations. The Plan Sponsor has undertaken the necessary procedures to calculate and reimburse the affected participants for lost earnings due to these late contributions under the DOL’s Voluntary Fiduciary Correction Program (“VFCP”). As of December 31, 2024, corrections for lost earnings and interest thereon, have not been fully restored to the participants’ accounts for the late contributions made in the year December 31, 2024. The Plan Sponsor intends to file Form 5330 and intends to pay the applicable excise tax to the IRS. The correction will be made from the Plan Sponsor’s assets and not from assets of the Plan.

During 2023, the Plan Sponsor inadvertently failed to deposit \$572,551 of participant contributions and loan repayments within the required time frame as stated by the DOL regulations. The Plan Sponsor corrected lost earnings due to the late contributions for \$117,235 in 2023. Lost earnings and interest thereon have not been fully restored for the remaining \$455,316 as of December 31, 2024. The Plan Sponsor intends to file Form 5330 and intends to pay the applicable excise tax to the IRS. The correction was made from the Plan Sponsor’s assets and not from assets of the Plan.

During 2022, the Plan Sponsor inadvertently failed to deposit \$460,799 of participant contributions and loan repayments within the required time frame as stated by the DOL regulations. As of December 31, 2024, corrections for lost earnings and interest thereon, have been fully restored to the participants’ accounts for the late contributions in the year ended December 31, 2022. The Plan Sponsor filed Form 5330 and paid the applicable excise tax to the IRS. The correction was made from the Plan Sponsor’s assets and not from assets of the Plan.
