## Independent Auditors' Report

To the Plan Administrator of

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of Princess House, Inc. Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 (in liquidation), the related statement of changes in net assets available for benefits for the year then ended (in liquidation), the statement of net assets available for benefits as of December 31, 2023 (ongoing), and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Princess House, Inc. Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

### **Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Princess House, Inc. Retirement Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### ***Emphasis-of-Matter—Plan Termination and Liquidation Basis of Accounting***

As discussed in Note 8 to the financial statements, effective March 31, 2024, the Plan was amended so that termination of the Plan occurred as of March 31, 2024, and management determined liquidation is imminent. As a result, the Plan has changed its basis of accounting from the going concern basis used in presenting the 2023 financial statements to the liquidation basis used in presenting the 2024 financial statements. Our opinion is not modified with respect to that matter.

### ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### ***Auditors' Responsibilities for the Audit of the Financial Statements***

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

#### Note 1. Description of the Plan

The following description of the Princess House, Inc. Retirement Plan (the "Plan") provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

**General:** The Plan is a noncontributory defined benefit plan for the employees of the plan sponsor, Princess House, Inc. (the "Company"), who were not leased employees, independent contractors, employed at the warehouse facility in North Carolina (except for three employees who started their employment in Massachusetts and were relocated to North Carolina, as noted in the plan document), or members of any bargaining unit. Annual contributions to the Plan were made by the Company based on information provided by the Plan's actuary. These contributions became part of a trust fund that is administered by a trustee for the benefit of employees participating in the Plan. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Management of the Company and the Plan's Investment Committee are responsible for the operation and administration of the Plan, determine the appropriateness of the Plan's investments, and monitor investment performance. Principal Trust Company is the Plan's trustee, holds the Plan's investment assets, and executes investment transactions.

On November 1, 2002, the Company amended the Plan so that effective January 1, 2003, no additional benefits would accrue under the Plan. As discussed in Note 8, effective September 27, 2023, the Company's board of directors resolved unanimously to authorize management to take the necessary and appropriate actions in order to terminate the Plan. The Plan was terminated effective March 31, 2024.

**Eligibility:** Employees who completed at least 1,000 hours of service during a plan year through December 31, 2002, were eligible to participate in the Plan as of the beginning of the plan year.

**Funding policy:** The Plan's funding policy was for the Company to contribute an amount which would meet or exceed the annual ERISA minimum funding requirement. The Company did not make any contributions for the year ended December 31, 2024. There was no minimum funding requirement for 2024.

The Company has the right under the Plan to discontinue its contributions at any time and terminate the Plan subject to the provisions set forth in ERISA. The Plan was terminated effective March 31, 2024; see Note 8.

**Pension benefits:** Any participant who had attained his or her normal retirement date was eligible for a normal retirement benefit. The normal retirement date was the earliest first day of the month on or after the date the participant reached age 65.

Participants who retired early, having attained age 55 and completed at least five years of service, may have received either a benefit commencing at age 65 or an actuarially reduced amount commencing upon early retirement.

The annual retirement benefit for participants retiring on their normal retirement age was equal to the sum of (i) 1% of average earnings for 1980 through 1984 plus 1% of the average earnings in excess of \$12,840, the sum of which is then multiplied by years of service prior to January 1, 1985, (ii) the sum of 1% of annual compensation up to the Social Security Taxable Wage Base and 2.4% of annual compensation in excess of the Social Security Taxable Wage Base for each plan year of participation starting after December 31, 1984, and prior to January 1, 1989, and (iii) the sum of 1% of annual compensation up to the Social Security Taxable Wage Base and 1.35% of annual compensation in excess of the Social Security Taxable Wage Base for each plan year of participation starting after December 31, 1988, and before January 1, 2003.

Participants were eligible for benefits under the disability provisions of the Plan, and the spouses of deceased participants were eligible for benefits under certain circumstances as defined in the Plan.

#### Note 2. Summary of Significant Accounting Policies

**Vesting:** All benefits have become fully vested because all participants have completed five years of service with the Company.

**Basis of accounting:** The accompanying financial statements have been prepared using the accrual method of accounting.

**Use of estimates:** The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein; disclosure of contingent assets and liabilities; and the actuarial present value of accumulated plan benefits at the date of the financial statements, and changes therein. Actual results could differ from those estimates.

**Investment valuation and income recognition:** The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the trustee. See Note 5 for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Benefit payments:** Benefit payments to participants are recorded upon distribution.

**Administrative expenses:** Substantially all expenses incurred in the administration of the Plan are paid directly by the Plan and are recorded as deductions in the accompanying statement of changes in net assets available for benefits. Certain investment related expenses are included in net appreciation (depreciation) in fair value of investments presented in the accompanying statement of changes in net assets available for benefits. Expenses that are paid by the Company are excluded from these financial statements.

#### Note 3. Actuarial Present Value of Accumulated Plan Benefits

Accumulated plan benefits are those future periodic payments, including lump-sum distributions, that are attributable under the Plan's provisions to the service employees have rendered. Accumulated plan benefits include benefits expected to be paid to (a) retired or terminated employees or their beneficiaries, (b) beneficiaries of employees who have died, and (c) present employees or their beneficiaries. Benefits under the Plan are based on employees' compensation, as defined in the agreement and frozen at 2002 levels. The accumulated plan benefits for active employees are based on their earnings through December 31, 2002, with a maximum includable compensation of \$200,000. Benefits payable under all circumstances such as retirement, death, disability, and termination of employment are included, to the extent they are deemed attributable to employee service rendered through December 31, 2002.

The actuarial present value of accumulated plan benefits is determined by an independent actuary and is that amount that results from applying actuarial assumptions to adjust the accumulated plan benefits to reflect the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as for death, disability, withdrawal, or retirement) between the valuation date the expected date of payment.

No adjustments are made for administrative expenses, either through a reduction in the discount rate or by calculating a present value of future expenses, as the plan sponsor may change its administrative expense handling at any time.

The foregoing actuarial assumptions are based on the presumption that the Plan will continue. Were the Plan to terminate, different actuarial assumptions and other factors might be applicable in determining the actuarial present value of accumulated plan benefits. See Note 8. The computations of the actuarial present value of accumulated plan benefits were made as of December 28, 2024, and January 1, 2024. Had the valuations been performed as of December 31, there would be no material differences.

#### Note 5. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy are described as follows:

**Level 1** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2** Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Pooled separate accounts:* Valued at NAV of units held. The NAV is based on the fair value of the underlying securities within the pooled separate accounts. The unit price is based on the underlying investments that are traded on an active market. The investment in the pooled separate accounts is carried at fair value based on closing market prices.

#### Note 6. Summary of Financial Information Certified by the Plan's Trustee (Unaudited)

Certain information related to investments included in the accompanying financial statements and supplemental schedules, including investments held at December 31, 2024 and 2023, and net appreciation (depreciation) in fair value of investments and dividends for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Principal Trust Company (the trustee of the Plan).

The Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information with the related information included in the financial statements and supplemental schedules.

#### Note 7. Related Party and Party in Interest Transactions

Certain Plan investments are units of pooled separate accounts managed by Principal Trust Company. Principal Trust Company is the trustee of the Plan and, therefore, these transactions qualify as party in interest transactions. Fees paid by the Plan to Principal for administrative services during 2024 amounted to \$111,200.

#### Note 8. Plan Termination

In the event the Plan terminates, the net assets of the Plan will be allocated, as prescribed by ERISA and its related regulations, generally to provide the following benefits in the order indicated:

Annuity benefits that former employees or their beneficiaries have been receiving for at least three years, or that employees eligible to retire for that three-year period would have been receiving if they had retired with benefits in the normal form of annuity under the Plan. The priority amount is limited to the lowest benefit that was payable (or would have been payable) during those three years. The amount is further limited to the lowest benefit that would be payable under Plan provisions in effect at any time during the five years preceding Plan termination.

Other vested benefits insured by the Pension Benefit Guaranty Corporation (PBGC) (a U.S. government agency) up to the applicable limitations.

All other vested benefits (that is, vested benefits not insured by the PBGC).

#### **Note 8. Plan Termination (Continued)**

Certain benefits under the Plan are insured by the PBGC if the Plan terminates. Generally, the PBGC guarantees most vested normal age retirement benefits, early retirement benefits, and certain disability and survivor's pensions. However, the PBGC does not guarantee all types of benefits under the Plan, and the amount of benefit protection is subject to certain limitations. Vested benefits under the Plan are guaranteed at the level in effect on the date of the Plan's termination.

Effective September 27, 2023, the Company's board of directors resolved unanimously to authorize management to take the necessary and appropriate actions in order to terminate the Plan. Effective March 31, 2024, the Plan was amended so that termination of the Plan occurred as of March 31, 2024. Substantially all of the Plan's assets were distributed in June 2025, through lump-sum payments to participants and purchases of annuities from an insurance company.

Effective March 31, 2024, the Plan was amended so that residual assets will be allocated to individuals who were active or inactive participants on the day before March 31, 2024.

Administrative costs related to liquidation totaling \$65,000 have been accrued in the statement of net assets available for benefits as of December 31, 2024 (in liquidation), and have been paid by the Plan during the year ending December 31, 2025.

#### **Note 9. Tax Status**

The Plan has adopted Principal Financial Group Defined Benefit Volume Submitter Plan. The Internal Revenue Service has determined and informed Principal Life Insurance Company by a letter dated March 30, 2018, that the volume submitter plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The volume submitter plan has been amended since receiving the letter. However, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **Note 10. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities, in general, are exposed to various risks such as interest rate, credit, and market risks. Due to the risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.
