Opinion on the 2024 Financial Statements

Note 1. Description of Plan

The following description of the R&K Solutions, Inc. Employee Stock Ownership Plan (Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General Description

The Plan was formed on January 1, 2005, as an employee stock ownership plan (ESOP). The Plan covers all eligible employees of R&K Solutions, Inc. (Company).

The Plan is designed to comply with Section 4975(e)(7) and the regulations thereunder of the Internal Revenue Code of 1986, as amended, (Code) and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Plan is administered by the ESOP Administrative Committee, as appointed by the Company's Board of Directors, who hold and invest the Trust assets.

Eligibility

All employees of the Company are eligible to participate in the Plan upon receiving any compensation during the Plan year. The Plan excludes employees covered by a collective bargaining agreement (unless specifically included), nonresident aliens, independent contractors, and leased employees.

Contributions

The Company may make a discretionary cash or stock contribution as determined annually by the Company's board of directors. During 2024, the Company contributed 8,142 shares of common stock with an estimated fair value of \$1,215,717. In addition, the Company contributed \$300,000 which was recorded as a receivable at December 31, 2024. Contributions are subject to certain limitations. Contributions are allocated to eligible participants as of the last day of the Plan year using a ratio based on the participant's eligible compensation to the total eligible compensation. Participants are not permitted to make contributions to the Plan.

Participant Accounts

Each participant's account reflects their portion of the Company's contributions and allocations of shares of Company stock, income or loss from Plan investments, and forfeitures, and charged with an allocation of administrative expenses. Allocations are based on compensation, account balances, or Company stock shares, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

A participant becomes 100% vested if the participant is employed by the Plan Sponsor on or after their 65th birthday, incurs a disability while employed by the Plan Sponsor, or dies while employed by the Plan Sponsor. If a participant leaves the Plan Sponsor for any reason other than retirement, disability or death, the participant becomes vested in accordance with the schedule below:

Less than 2 years	0%
2 years	20%
3 years	40%
4 years	60%
5 years or more	100%

Payment of Benefits

Participants are eligible for retirement benefits upon attaining normal retirement age. Upon termination of service for reasons other than death, disability or retirement, distribution of the participant's vested account may commence no later than the end of the sixth Plan year following the Plan year during which the participant terminates service. Upon termination of service due to death, disability or retirement, distributions will begin no later than one year after the last day of the year in which the participant's normal or early retirement, disability or death occurs. The Plan's Board of Trustees may elect to distribute an amount equal to the value of the participant's vested interest in his or her account in either a lump-sum amount or installments over a period not to exceed five years. Benefit payments are recorded when paid.

Voting Rights

Each participant is entitled to exercise voting rights attributable to the shares allocated to his or her account and is notified by the Trustee prior to the time that such rights are to be exercised. Participants can only vote on those matters required by ERISA, otherwise the Trustee votes in their best interest. The Trustee is not permitted to vote for any allocated share for which instructions have not been given by a participant. The Trustee is required, however, to vote on any unallocated shares on behalf of the collective best interest of plan participants and beneficiaries.

Put Option

Under Federal income tax regulations, the employer stock that is held by the Plan and its participants and is not readily tradeable in an established market, or is subject to trading limitations, includes a put option. The put option is a right to demand that the Company buy any shares of its stock distributed to participants for which there is no market. The put price is representative of the fair market value of the stock. The Company can pay for the purchase with interest over a period of five years. The purpose of the put option is to ensure that the participant has the ability to ultimately obtain cash.

Diversification

Diversification is offered to participants close to retirement so that they may have the opportunity to move part of the value of their investment in Company stock into investments which are more diversified. Participants who are at least age 55 with at least 10 years of participation in the Plan may elect to diversify a portion of their account. Diversification is offered to each eligible participant over a six-year period. In each of the first five years, a participant may diversify up to 25% of the number of shares allocated to his or her account, less any shares previously diversified. In the sixth year, the percentage changes to 50%.

Eligible participants may elect to diversify a portion of their Company Stock account during an annual election period, which begins on the first day of the Plan Year and ends 90 days after the valuation is communicated, but no later than the last day of the Plan Year. Distributions may be made in Company Stock, cash, or a combination thereof, at the discretion of the Company. As an S Corporation, any Company Stock distributed under a diversification election is subject to immediate resale to the Company pursuant to the Plan's put option provisions. As of December 31, 2024, 14 participants were eligible to diversify their account balances.

Forfeitures

Forfeited nonvested accounts will be reallocated to eligible participants based on compensation. During 2024, 412 shares of stock were reallocated to eligible participants. There were no unallocated forfeited shares or cash at December 31, 2024 or 2023.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America (“GAAP”).

Use of Estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of net assets, changes in net assets, and the disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan’s valuation policies utilizing information provided by the trustee. See Note 3 for discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest and dividend income is recorded when received. Net appreciation includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded upon distribution.

Administrative Expenses

The Plan’s administrative expenses are paid by either the Plan or the Company, as provided by the Plan document. Certain administrative functions are performed by employees of the Company. No such employee receives compensation from the Plan.

Subsequent Events

In preparing these financial statements, the Plan has evaluated events and transactions for potential recognition or disclosure through October 9, 2025, the date the financial statements were available to be issued.

Note 3. Fair Value Measurements

Fair value as defined under the modified cash basis of accounting is an exit price, representing the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. There is a three-tier fair value hierarchy, which prioritizes the inputs used in measuring fair value. These tiers include:

- Level 1** Observable inputs such as quoted prices in active markets.
- Level 2** Inputs other than quoted prices in active markets that are either directly or indirectly observable.
- Level 3** Unobservable inputs about which little or no market data exists, therefore requiring an entity to develop its own assumptions.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future values. Furthermore, although the Plan believes its valuation methods are appropriate and consist with other market participants, the use of different methodologies or assumptions to determine the fair value measurement at the reporting date.

Note 5. Plan Termination

The Company reserves the right to terminate the Plan at any time, subject to Plan provisions. Upon such termination of the Plan, the interest of each participant in the trust fund will be distributed to such participant or his or her beneficiary at the time prescribed by the Plan terms and the Code. Upon termination of the Plan, the Trustee will be directed to pay all liabilities and expenses of the trust fund and to sell shares of financed common stock held in the loan suspense account to the extent it determines such sale to be necessary in order to repay the loan.

Note 6. Tax Status

The Plan has received a determination letter from the Internal Revenue Service dated October 10, 2017, stating that the Plan and related trust, as then designed, were in compliance with the applicable requirements of the Internal Revenue Code and therefore not subject to tax. The Plan has been amended since receiving the determination letter. However, the Plan Administrator believes that the Plan and related trust are currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, they believe that the Plan was qualified, and the related trust was tax-exempt as of the financial statement date.

Accounting principles in accordance with GAAP require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 7. Terminated Participants

Amounts allocated to terminated participants with vested balances in the Plan, and which were still included in net assets available for benefits at December 31, 2024 and 2023, were \$3,556,735 and 2,729,812, respectively.

Note 8. Risks and Uncertainties

The Plan invests in the Company's common stock. There are certain business risks with the industry in which the Company operates; therefore, it is at least reasonably possible that changes in the fair value of the Company's common stock may occur in the near term and that such changes could materially affect the participants' account balance and the amounts reported in the statements of net assets available for benefits.
