**Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed an audit of the financial statements of 128 Plumbing & Heating, Inc. 401(k) Plan (“the Plan”), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (“ERISA”), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of 128 Plumbing & Heating, Inc. 401(k) Plan’s financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. NOTES TO FINANCIAL STATEMENTS**

## **1. DESCRIPTION OF PLAN**

The following description of the 128 Plumbing & Heating, Inc. 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

### **General**

The Plan is a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and the Internal Revenue Code (IRC). The Plan was established in January 2022. A Summary Plan Document outlining the Plan, its benefit provisions and vesting requirements is provided to each Plan participant. The Plan is administered by 128 Plumbing & Heating, Inc. (known as the Company).

### **Eligibility Requirements**

All employees who have completed 2 months of service, as defined, are eligible to participate, provided they are at least 18 years of age and not a part-time, seasonal, or temporary employee. However, if a part-time, seasonal, or temporary employee completes one year of service in any year of employment (where the employee completes at least 1,000 hours of service) or three consecutive years of service (where the employee completes at least 500 hours of service), they will no longer be part of this excluded class.

### **Contributions**

Participants may elect to contribute up to ninety percent (90%) of eligible compensation as defined in the Plan document. The Plan includes an automatic deferral provision requiring 4% of participant compensation to be withheld as participant deferral unless the employee elects to change the deferral percentage or not to participate. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company provides safe harbor contributions and may, in its sole discretion, make nonelective contributions. Safe harbor contributions are one hundred percent (100%) of participants' salary deferrals that do not exceed 4% of participants' compensation. In 2024 and 2023, no more than \$345,000 and \$330,000, respectively, of compensation may be taken into account in determining safe harbor contributions. In 2024 and 2023, the Company contributed safe harbor contributions of \$590,324 and \$507,169, respectively. There were no nonelective contributions in 2024 or 2023.

All contributions are subject to certain IRC limitations.

### **Participant Accounts**

Each participant's account is credited with the participant's contributions and Company safe harbor contributions, as well as allocations of non-elective contributions and Plan investment earnings. Allocations are based on participant compensation, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### **Vesting**

Participants are always one hundred percent (100%) vested in amounts attributable to their salary deferrals, rollover contributions and Company safe harbor contributions. Participants' vested percentage in their account attributable to discretionary Company non-elective contributions is determined under the following schedule and is based on vesting periods of service. A period of service is based on completing a twelve-month period from the date of employment until the date of employment termination. Participants will always, however, be one hundred percent (100%) vested if they are employed on or after their normal retirement age or die or become disabled.

**Payment of Benefits**

Upon termination of employment, death, disability, or normal retirement, a participant or designated beneficiary may elect to receive the participant's vested interest in his or her account in the form of a lump-sum, installment, partial withdrawal, or direct rollover to another qualified retirement plan or IRA. Participants who terminate employment with an aggregate vested account balance of \$7,000 or less will be paid in a single lump-sum. Participants may also withdraw their vested account balance upon attaining age 59 ½. Hardship withdrawals are also permitted by the Plan.

**Secure 2.0 Act**

The Secure 2.0 Act of 2022 was signed into law on December 29, 2022. This legislation includes a vast array of provisional changes to retirement plans, that became effective beginning January 1, 2023. Plan management evaluated the impact of the adoption and implementation of this legislation on the Plan and there was no material impact to the Plan for the years ended December 31, 2024 and 2023.

**2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The accompanying financial statements are presented on the accrual basis of accounting.

**Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation / (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

**Contributions Receivable**

Receivables are recorded when amounts have been withheld from participants' compensation.

**Benefits Paid**

Benefits paid to participants and their beneficiaries are recorded when paid.

**Administration Expenses**

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Investment related expenses are included in net appreciation / (depreciation) in fair value of investments.

**Subsequent Events**

The Plan has evaluated subsequent events through October 9, 2025, the date the financial statements were available to be issued. No subsequent events were noted that could have a material impact on the financial statements.

**3. INFORMATION PREPARED AND CERTIFIED BY PLAN'S TRUSTEE**

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the Trustee (Reliance Trust Company) has certified to the completeness and accuracy of all investments reflected on the accompanying Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023, the related investment activity reflected on the Statements of Changes in Net Assets Available for Benefits for the years then ended, and Schedule H, Line 4(i)- Schedule of Assets (Held at End of Year), as of December 31, 2024.

**4. FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

**Level 1**

Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2**

Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3**

Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

**4. FAIR VALUE MEASUREMENTS (CONTINUED)**

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes to the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Common/Collective Trust Fund:* The fair value of the investments in common/collective trust funds is determined by each fund's trustee based on the fair value of the underlying securities within the fund, which represent the net asset value (NAV) of shares held by the Plan at year end. The investment in the trust is a public investment security valued using the NAV provided by the Trustee. The NAV is quoted on a private market that is not active; however, the unit price is based on the underlying investments that are traded on an active market. Unit values are determined by dividing the fund's net assets at fair value by its units outstanding at the valuation dates. Units are only redeemable by the issuer.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**5. EXEMPT PARTIES-IN-INTEREST TRANSACTIONS**

Plan investments are shares of mutual funds and a common/collective trust managed by Reliance Trust Company. Reliance Trust Company is the trustee as defined by the Plan and, therefore, these transactions qualify as exempt party-in-interest transactions.

The Plan's recordkeeping and management are provided by Automatic Data Processing, Inc. (ADP), the third-party administrator and broker-dealer as defined by the Plan. Therefore, these transactions qualify as exempt party-in-interest transactions.

Certain administrative expenses for accounting and other services are rendered by parties-in-interest and are paid by the Company. The Company also provides certain administrative services to the Plan for which it receives no compensation.

**6. TAX STATUS**

The Plan operates under a prototype plan of Automatic Data Processing, Inc. (ADP). On October 6, 2020, the Internal Revenue Service issued an opinion letter stating that the form of the Plan was acceptable under section 401 of the IRC. Although the Plan has been amended since receiving the opinion letter, the Plan administrator believes that the Plan is designed and is currently operating in compliance with the applicable requirements of the IRC and therefore believes that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan administrator believes it has no uncertain tax positions as of and for the years ended December 31, 2024 and 2023. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**7. PLAN TERMINATION**

Although the Company has not expressed any intent to do so, it reserves the right to terminate the Plan at any time subject to the provisions of ERISA. In the event of a Plan termination, participants would become 100% vested in their Company contributions.

**8. RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.
