## INDEPENDENT AUDITORS' REPORT

To the Board of Trustees and Management of the  
Blue Mountain Construction Services 401(k) Plan

### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the Financial Statements***

We have performed audits of the financial statements of Blue Mountain Construction Services 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C)" audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### ***Opinion on the Financial Statements***

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### ***Basis for Opinion on the Financial Statements***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (“GAAS”). Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

### **Note 1: Description of plan**

The following description of the Blue Mountain Construction Services 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

The Plan also covers employees of participating affiliates including:

- Blue Mountain Homes, LLC
- Blue Mountain Realty, Inc.
- National Home Investors, LLC
- Portentous Properties, LLC

**General:** The Plan is a defined contribution plan established on January 1, 2005, amended and restated with an effective date of July 21, 2021, and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Plan provides benefits for all eligible employees of the Plan Sponsor and participating affiliates, collectively the “Company”.

The Plan Sponsor is the Plan administrator and the trustee. The Plan Sponsor retains the services of a third party to assist in the administration of the Plan. Through May 19, 2024, the Plan’s custodian was Minnesota Life Insurance Company (“Minnesota Life”), and the Plan’s third party administrator was Securian Financials’ Participant Recordkeeping (“Securian), the parent of Minnesota Life Insurance Company. As of May 20, 2024, the third-party administration was transferred to Standard Retirement Services, Inc. (“The Standard”). Through December 31, 2024, the Plan’s custodian was The Standard, as a result of The Standard acquiring Securian. The Plan’s third party administrator was The Standard Insurance Company, the parent of Standard Retirement Services, Inc.

In August 2025, subsequent to year end, the plan transferred its assets and third-party administration to Principal Retirement Services.

**Eligibility:** All employees of the Company are eligible to participate upon attaining the age of 18 and completing three months of service, except for certain members of a collective bargaining agreement, non-resident aliens, leased employees, and temporary or seasonal employees. Upon meeting eligibility requirement, participants may enter the Plan on the first day of the following month.

### **Notes to Financial Statements**

December 31, 2024

**Employee contributions:** Participants are eligible to contribute up to 100% of pre-tax annual compensation, as defined by the Plan, subject to the maximum allowed under section 401(k) of the Internal Revenue Code (“IRC”). Participants are also permitted to deposit into the Plan distributions received from other qualified plans (rollovers). Participants direct the investment of their account balances into various investment options offered by the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Plan includes an automatic enrollment provision, whereby all existing employees without affirmative elections to participate in the Plan, and newly hired employees, are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rates set initially at 3% of eligible compensation and their contributions are invested in a balanced fund until changed by the participant. Additionally, the Plan has an escalation clause that increases the automatically enrolled participants deferral rate annually by 1% until a deferral rate of 5% is reached unless they affirmatively elect not to. A participant may elect to increase or decrease the percentage contribution each pay period. Employees may elect not to participate in the Plan.

**Employer contributions, net of forfeitures:** The Company has approved safe harbor matching contributions in the amount equal to 100% of the first 3% of the participant’s eligible compensation and 50% of the next 2% of the participant’s eligible compensation for the year ended December 31, 2024. The Company made safe harbor matching contributions for the year ended December 31, 2024 of approximately \$589,000, net of forfeitures. Participants that have completed one year of service and are employed at year-end are eligible to receive discretionary profit sharing contributions. There were no discretionary profit sharing contributions during 2024.

**Participant accounts:** Each participant’s account is credited with the participant’s contribution, allocations of: (a) the Company’s contributions, and (b) Plan earnings, and is charge with an allocation of administrative expenses. Allocations are based on participant compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account at the date immediately preceding the commencement of processing the distribution.

**Investment options:** The Plan provides for investments to be directed by participants into a number of investment options held by the custodians. Participant investment options include a variety of pooled separate accounts and a guaranteed investment contract. Participants may change their elections at any time.

**Vesting:** Participants are immediately vested in their contributions, including rollovers of funds from other qualified retirement plans and earnings thereon, and in safe harbor matching contributions. Employer contributions vest based upon completed years of service ratably over a four year period. Participants terminated between February 1, 2014, and May 1, 2016, were subject to a three year vesting schedule where upon completion of three or more years of service the employer contributions became 100% vested. Participants separated from service prior to February 1, 2014 remain on the six year graded vesting effective during that time period.

**Notes receivable from participants:** Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested balance. The notes are secured by the balance in the participant's account and bear interest at market financing rates. Note terms range from one to five years, but may not exceed five years, except for notes used for a purchase of a primary residence, which may be repaid over a longer period. Principal and interest are paid ratably through payroll deductions.

**Payment of benefits:** The Plan provides for the payment of benefits to the participant (or, if applicable, the beneficiary) at retirement, disability, death, financial hardship (as defined in the Plan), or termination of employment. In-service distributions of a participant's vested account balance are permitted providing the participant has attained the age of 59 ½. Upon termination, the participant may elect to leave their account balance in the Plan, or receive their total benefits in a lump sum amount equal to the value of the participant's vested interest in their account. Unless otherwise instructed by the participant, participants with vested account balances of \$1,000 or less upon separation will receive a lump sum cash payout and participants with vested account balances ranging from \$1,000 to \$5,000 will automatically be rolled over to an individual retirement account ("IRA").

**Forfeited accounts:** Forfeitures are used to reduce employer contributions and to pay for Plan expenses. Forfeitures used to reduce Plan expenses were approximately \$7,000 for the year ended December 31, 2024. Forfeitures used to reduce employer contributions were approximately \$108,000 for the year ended December 31, 2024. At December 31, 2024 and 2023, forfeited non-vested accounts totaled approximately \$46,000 and \$140,000, respectively.

**Investment management fees and operating expenses:** The Company pays the cost of administering the Plan such as recordkeeping, accounting, legal and trustee services. Investment fees are generally assessed as a percentage of assets invested, and are deducted directly from investment returns. Transaction-based fees that are associated with optional services offered under the Plan are charged directly to the account of the participant, who takes advantage of such a feature, like a participant note.

**Administrative expenses:** Substantially all administrative expenses of the Plan are paid by the Plan. Separate fees for loan processing and certain investments as specified in the service agreement, are charged to individual participant's accounts.

### **Note 2: Summary of significant accounting policies**

**Basis of accounting:** The accompanying financial statements of the Plan have been prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP"). Contributions from participants are recorded when withheld from the participant. Benefit payments to participants are recorded when paid.

**Use of estimates:** The preparation of financial statements in conformity with GAAP requires the Plan administrator to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes and schedule. Actual results could differ from those estimates.

**Investment valuation and income recognition:** The Plan's pooled separate accounts and guaranteed investment contract are stated at their fair value. Shares of registered investment companies are valued at quoted market prices which represent the net asset value of shares held by the Plan at year-end. The trustee has concluded that the guaranteed investment contract is not fully benefit responsive and therefore should be reported at fair value. Additionally, the trustee has determined the fair value of the guaranteed investment contract is calculated by discounting the related cash flows based on current yields of similar instruments with comparable durations. Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date.

**Fair value measurements:** The Plan performs fair value measurements in accordance with Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820, Fair Value Measurements and Disclosures. Refer to Note 3 for the fair value measurement disclosures associated with the Plan's investments.

**Net appreciation (depreciation) in fair value of investments:** The earnings, expenses, realized gains and losses, and unrealized appreciation (depreciation) in registered investment companies and other investments are recorded in the accompanying financial statements as net appreciation (depreciation) in fair value of investments.

**Subsequent events:** The Plan has evaluated subsequent events through the date that the financial statements were available to be issued which is the date of the independent auditors' report.

### **Note 3: Fair value measurements**

The Plan performs fair value measurement in accordance with ASC 820 which defines fair value as the price that would be received from selling an asset in an orderly transaction between market participants at the measurement date. The accounting guidance for fair value measurement requires an entity to maximize the use of observable inputs and minimize the use of unobservable inputs when measuring fair value. The standard establishes a fair value hierarchy based on the level of independent, objective evidence surrounding the inputs used to measure fair value. A financial instrument's categorization within the fair value hierarchy is based upon the lowest level of input that is significant to the fair value measurement.

- Level 1: quoted prices in active markets for identical assets or liabilities;
- Level 2: inputs other than Level 1 that are observable, either directly or indirectly, such as quoted prices in active markets for similar assets or liabilities, quoted prices for identical or similar assets or liabilities in markets that are not active, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities; or
- Level 3: unobservable inputs that are supported by little or no market activity and that are significant to the fair value of the assets or liabilities.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### **Note 4: Investments**

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the Plan administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the following information certified by The Standard Insurance Company, the custodian of the Plan, except for comparing such information to the related information included in the financial statements and supplemental schedule.

#### **Note 5: Investment contract with insurance company**

In 2016, the Plan entered into a non-benefit-responsive investment contract with Minnesota Life. Minnesota Life maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

As described in Note 2, the guaranteed investment contract is not fully benefit responsive, and is therefore reported at fair value. Fair value, as reported to the Plan by Minnesota Life, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. Transfers at the Plan level are restricted in any 12 month period from movements out of the guaranteed investment contract of the greater of \$2,000 or 20% of the guaranteed investment contract assets.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. During 2024, the average yield and crediting interest rate was approximately 0.00%.

#### **Note 6: Party-in-interest transactions**

At December 31, 2024 and 2023, the Plan held investments available for benefits of approximately \$12,682,000 and \$10,765,000, respectively, in The Standard funds. The Standard is the Plan's investment broker and has custodial responsibility for investments held in The Standard's investment accounts.

### **Note 7: Plan termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

### **Note 8: Income tax status**

The prototype plan adopted by the Plan Sponsor obtained its latest opinion letter on June 30, 2020, in which the Internal Revenue Service stated that the prototype plan, as designed, was in compliance with the applicable requirements of the Internal Revenue Code. Subsequent to receiving this opinion letter, the prototype plan was amended. The Plan administrator believes that the amended prototype plan, as adopted by the Company, is operating in compliance with the requirements of the Internal Revenue Code. Therefore, no provision for incomes taxes has been included in the Plan's financial statements.

### **Note 9: Risks and uncertainties**

The Plan provides for investments in various investment securities which, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statement of net assets available for benefits and participant account balances.
