### 1. Description of the Plan

The following description of Czarnowski Display Service, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

#### *General*

Czarnowski Display Service, Inc. (the Company) established the Plan, effective January 1, 1991, to provide retirement, disability, and death benefits for eligible employees and their beneficiaries. The Plan covers substantially all full-time employees of the Company who do not participate in a collective-bargaining unit. Participants become eligible to participate in the Plan on the first day of the month following his or her date of hire. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan is administered by the Czarnowski Display Service, Inc. 401(k) Plan Committee (the Committee) that serves at the discretion of the Company's Board of Directors. The Committee is responsible for all matters, including, but not limited to, determining eligibility, rights to benefits, interpreting Plan documents, and directing the Plan's trustee.

#### *Contributions*

Each year, participants may contribute up to 100% of their pretax annual compensation, as defined in the Plan document, subject to the Internal Revenue Code (IRC) limits. Participants who have attained age 50 before the end of the Plan-year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). The Plan allows participants to designate all or a portion of their deferrals as Roth contributions to the Plan on an after-tax basis.

The Plan provides for a non-discretionary Company-matching contributions to the Plan based on a percentage of participant contributions. A participant must have completed 1,000 hours of service and worked one year for the Company to receive any Company-matching contributions. Effective January 1, 2023, the Plan was amended to provide for a fixed 3% non-discretionary matching employer contribution to all eligible participants.

The Company may also elect to make discretionary non-elective contributions. In order to receive any Company discretionary non-elective contributions, a participant must have completed 1,000 hours of service, worked one year for the Company, and be employed on the last day of the Plan-year. The Company made an additional discretionary non-elective contribution of approximately \$67,000 for the year ended December 31, 2024.

Contributions are subject to certain IRC limitations.

Participants may direct all their contributions among one or more funds offered by the Plan (including self-directed brokerage accounts). Changes in allocation of future contributions and transfers among funds of presently invested contributions are permitted pursuant to the Plan's provisions. The Plan also allows for participants to self-direct and manage their own Plan investments rather than invest in the fund choices provided. Such investments are referred to as self-directed brokerage accounts in these financial statements.

### ***Participant Accounts***

Each participant's account is credited with the participant's contributions and discretionary Company-matching contributions, as well as allocations of (a) any additional discretionary non-elective Company contributions, and (b) Plan earnings or losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### ***Notes Receivable from Participants***

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at the prime rate plus 1%. Interest rates on outstanding loans currently range from 4.25% to 9.50%. Principal and interest are paid ratably through payroll deductions over a term not exceeding five years, or a term not to exceed ten years for loans used for the purchase of a primary residence.

### ***Payments of Benefits***

Upon termination of service due to retirement, death, permanent disability, separation from service, or attainment of age 59½, a participant may elect to receive the value of their vested interest in his or her account in the form of a lump-sum amount, installment payments, partial payments, annuities, or a rollover to another entity. If the participant's vested interest in the Plan is less than \$1,000, a mandatory lump-sum distribution may be made to the participant. Withdrawals from the Plan may also be made upon circumstances of financial hardship, in accordance with provisions specified in the Plan document.

### ***Vesting and Forfeitures***

Participants are immediately vested in their contributions plus actual earnings thereon. Non-discretionary matching employer contributions plus actual earnings thereon also vest immediately. Vesting in the additional discretionary non-elective contributions plus actual earnings thereon, is based on years of continuous service. A participant becomes 20% vested after two years of service, 40% vested after three years of service, 60% vested after four years of service, 80% vested after five years of service, and 100% vested after six years of service.

Forfeitures resulting from non-vested portions of participant accounts are used to reduce any Company contributions and pay any Plan administrative expenses. At December 31, 2024 and 2023, approximately \$16,000 and \$39,000 respectively, of forfeitures were available to pay Plan expenses or to reduce future Company contributions. During 2024, forfeited non-vested accounts amounting to approximately \$64,000 were used to reduce Company contributions.

## **2. Summary of Significant Accounting Policies**

### ***Basis of Accounting***

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

### ***Use of Estimates***

The preparation of financial statements in conformity with GAAP requires Plan management to make estimates and assumptions that affect the reported amounts of assets and liabilities at the date of the financial statements and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### ***Investment Valuation and Income Recognition***

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability (an exit price) in an orderly transaction between market participants at the measurement date in the principal or most advantageous market for the asset or liability. The Committee determines the Plan's valuation policies, utilizing information provided by the investment advisors and the trustee. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net depreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

### ***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

### ***Benefit Payments***

Benefit payments are recorded when paid.

### ***Administrative Expenses***

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable and distribution requests from participants are charged directly to the participant's account and are included in administrative expenses.

### ***Risks and Uncertainties***

The Plan provides for various investment options with various investment objectives. Investment securities are exposed to various risks, such as interest risk, market risk, and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### 3. Fair Value Measurements

Accounting Standards Codification (ASC) Topic 820, *Fair Value Measurements and Disclosures*, establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

*Level 1* - Inputs are unadjusted quoted prices in active markets for identical assets or liabilities that the reporting entity has the ability to access at the measurement date. An active market for the asset or liability is a market in which transactions for the asset or liability occur with sufficient frequency and volume to provide pricing information on an ongoing basis.

*Level 2* - Inputs are other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, including:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* - Inputs are unobservable for the asset or liability (including the entity's own assumptions about the assumptions that market participants would use in pricing the asset or liability) and significant to the fair value measurement.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Shares of Registered Investment Companies* - These assets are valued at the daily closing prices, as reported by the fund. Registered investment companies held by the Plan are open-ended funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The shares of registered investment companies held by the Plan are deemed to be actively traded.

*Self-Directed Brokerage Accounts* - The self-directed brokerage accounts hold investments in securities that have publicly quoted pricing inputs. These accounts have shares of registered investment companies and corporate stocks as the underlying assets. Corporate stocks are valued on the basis of the closing price per unit on each business day, as reported on the active market.

*Common Collective Trust* - These assets are valued using the NAV provided by the administrator of the fund. The NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. The NAV's unit price is quoted on a private market that is not active; however, the unit price is based on underlying investments that are traded on an active market.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### 4. Certified Investment Information

The Plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the Plan's trustee, Fidelity Management Trust Company (Fidelity), has certified that the following data included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments, at fair value and notes receivable from participants, as shown in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023.
- Net investment gain and interest income on notes receivable from participants, as shown in the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Schedule H (Form 5500), Line 4i - Schedule of Assets (Held at End of Year) as of December 31, 2024.

At the request of the Plan administrator, the Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such certified information provided by the trustee to the related information included in the financial statements and ERISA-required supplemental schedule.

### 5. Tax Status

The Plan adopted a volume-submitter plan document from Fidelity Management & Research Company, which received an opinion letter from the Internal Revenue Service (IRS) on June 30, 2020, stating that the volume-submitter plan document, as then-designed, was in compliance with the applicable requirements of the IRC. Although the Plan has been amended since the date of the opinion letter, the Plan administrator believes that the Plan is designed and currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and that the related trust is tax-exempt.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### 6. Related Party and Party-in-Interest Transactions

Certain Plan investments are managed by Fidelity or its affiliates. Fidelity is the trustee, as defined by the Plan; therefore, these transactions qualify as party-in-interest transactions. Notes receivable from participants qualify as party-in-interest transactions. Certain employees of the Company provide administrative services to the Plan. These employees are not paid by the Plan for their services.

### **7. Plan Termination**
