Management is also responsible for maintaining a current Plan instrument, including all Plan amendments; administering the Plan; and determining that the Plan's transactions are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit* section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and, therefore, is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control related matters that we identified during the audit.

Supplemental Schedule Required by ERISA

The supplemental schedule, Schedule of Assets (Held at End of Year) – Form 5500, Schedule H, Part IV, Line 4i, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by DOL’s Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with DOL’s Rules and Regulations for Reporting and Disclosure under ERISA.

- The form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, is presented, in all material respects, in conformity with DOL’s Rules and Regulations for Reporting and Disclosure under ERISA.
- The information in the supplemental schedule related to assets held by and certified to by a qualified institution agrees to or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Note 1—Description of the Plan

The following description of Human Technologies, Inc. Employees Savings Trust (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General – The Plan is a defined contribution plan covering all employees of Human Technologies, Inc. (the “Company”) except for nonresident aliens not receiving any earned income constituting United States source income and leased employees. Employees will be eligible to participate in the Plan upon reaching age 21 and completing one year of service. The Plan is a safe harbor 401(k) plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). Plan entry dates for eligible employees are the first day of each quarter. The Plan was converted and restated effective October 11, 2018, due to a change to Fidelity Management Trust Company (the “Trustee”).

Contributions – Eligible participants may elect to contribute up to 100% of their compensation to the Plan, subject to the Internal Revenue Code (“IRC”) limitations for 401(k) plans. Participants direct the investment of their contributions into various investment options offered by the Plan. Participants may also contribute amounts representing distributions from other qualified plans. Such contributions, if any, are recorded as rollover contributions in the accompanying financial statements. Rollovers from other qualified retirement plans are accepted by the Plan as long as the employee meets all legal requirements of the Plan. The Company matches 100% of the first 3% of base compensation a participant contributes to the Plan and 50% in excess of 3% not to exceed 5% to fulfill the basic requirements of a safe harbor plan. All investments in the Plan are directed by the participants including employer contributions. Deferral amounts may be changed as of the beginning of each payroll period. Under the Plan agreement, the company may also make discretionary non-elective contributions. However, during 2024, no such contributions were made.

The Plan allows for Roth elective deferrals. The Roth deferrals are included in an employee’s ordinary taxable income and are maintained in a separate account from pre-tax deferrals. Earnings on a participant’s Roth account accumulate on a tax-free basis. Plan participants may elect all pre-tax, all Roth, or a combination of elective deferrals each pay period.

Investment Options – Participants may direct their accounts into various mutual funds, a money market fund, and a stable value fund that have been provided as investment options.

Participant Accounts – Each participant’s account is credited with (a) the participant’s contributions, (b) the Company’s contributions, and (c) an allocation of the Plan’s earnings (losses). Each participant’s account is charged with participant withdrawals and an allocation of the Plan’s expenses. Allocations of Plan earnings and administrative expenses are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting – Participants are immediately vested in their voluntary contributions and employer safe harbor contributions to the Plan, plus investment earnings thereon. Vesting in the Company’s discretionary nonelective employer contributions plus actual earnings thereon is based on years of credited service. A year of service is credited on each anniversary of a participant’s employment with the Company. Participants also become fully vested upon attainment of normal retirement age or upon termination of employment due to disability or death. Participants are 100% vested after four years of credited service as summarized as follows:

Payment of Benefits – On termination of service due to death, disability, or retirement, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. In addition, a participant may elect to receive withdrawals upon reaching the age 65.

Hardship Withdrawals – The Plan allows participants to make hardship withdrawals to satisfy certain immediate and heavy financial needs. A participant may request a hardship withdrawal for certain qualifying expenses as defined by the Plan document, and within what the Internal Revenue Service (“IRS”) deems an immediate and financial need of the participant.

Forfeitures – Forfeitures of nonvested accounts are used to reduce the contribution or to pay the Plan administrative expenses. Forfeitures of \$195 and \$4 were used to reduce the employer contribution for the years ended December 31, 2024 and 2023, respectively. The ending balance for forfeitures was \$132 and \$-0- for the year ended December 31, 2024, and 2023, respectively.

Note 2—Summary of significant accounting policies

Basis of Accounting – The financial statements of the Plan are prepared in accordance with accounting principles generally accepted in the United States of America (“U.S. GAAP”).

Use of Estimates – The preparation of financial statements in conformity with U.S. GAAP requires the Plan administrator to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein and disclosure of contingent assets and liabilities. Such estimates include those regarding fair value. Actual results could differ from those estimates.

Contributions – Employee contributions are recorded in the period during which the Company makes payroll deductions from the participants' earnings.

Contributions Receivable – The amount of participant-related contributions that have been deducted from the participant's payroll as of the end of the year, but have not been deposited with the Plan until after the end of the year is reflected as participant contributions receivable in the Plan's financial statements. In addition, any contributions due and payable by the Company are reflected as Employer contributions receivable in the Plan's financial statements.

Investment Valuation and Income Recognition – The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan management determines the Plan's valuation policies utilizing information provided by Fidelity Management Trust Company. See Note 4 for discussion of fair value measurements.

Net appreciation in fair value of investments is comprised of realized, as well as unrealized, gains or losses resulting from investment transactions. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded when earned. Dividends are recorded on the ex-dividend date.

Payment of Benefits – Benefits are recorded when paid.

Risks and Uncertainties – The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes would materially affect participants' account balances, and the amounts reported in the statements of net assets available for benefits.

Administrative Expenses – Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of certain transactions from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

Fair Value Measurements – The Plan follows the *Fair Value Measurements* topic of the Financial Accounting Standards Board Accounting Standards Codification ("ASC") 820 which defines fair value as the exchange price that would be received for an asset or paid to transfer a liability (an exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction value hierarchy which requires an entity to maximize the use of observable inputs when measuring fair value.

The standard describes three levels of inputs that may be used to measure fair value:

Level 1 – Inputs to the valuation methodology are quoted prices available in active markets for identical investments as of the reporting date.

Level 2 – Inputs to the valuation methodology are other than quoted prices in active markets, which are either directly or indirectly observable as of the reporting date, and fair value can be determined through the use of models or other valuation methodologies; and

Level 3 – Inputs to the valuation methodology are unobservable inputs in situations where there is little or no market activity for the asset or liability and the reporting entity makes estimates and assumptions related to the pricing of the asset or liability including assumptions regarding risk.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. The following are descriptions of the valuation methodologies used for instruments measured at fair value. No changes have occurred in the methodologies for December 31, 2024 or 2023.

Money Market Fund – This investment is a public investment vehicle valued at amortized cost with unit values determined on a daily basis. The underlying assets are generally comprised of short-term securities representing high-quality, liquid debt and monetary assets. The valuation technique used is the market approach and the input is the unit value quoted to unitholders for investments and redemptions. The money market fund is classified within Level 1 of the valuation hierarchy.

Mutual Funds – Funds are valued at the daily closing price as reported by the fund. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded and thus classified within Level 1 of the valuation hierarchy.

Stable Value Fund – Investments in the stable value fund are stated at estimated fair values, which have been determined based on the unit values of the funds. Each investment is valued at a daily calculated unit value which is determined by the organization sponsoring such funds by dividing the funds' net assets at fair value by its units outstanding at each valuation date. The stable value fund has indirect investments in synthetic and traditional guaranteed investment contracts. As the investment is indirect, there is no readily determinable fair value and the trust is valued at NAV practical expedient and is shown outside the fair value hierarchy.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 3—Information prepared and certified by the Trustee (unaudited)

The Plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the United States Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity Management Trust Company, the qualified institution and Trustee of the Plan has certified to the completeness and accuracy of the following data included in the accompanying financial statements as of December 31, 2024 and 2023 and for the year ended December 31, 2024:

- Investments, at fair value, as of December 31, 2024 and 2023 as shown in the statements of net assets available for benefits.
- Net appreciation in fair value of investments, and interest and dividend income, as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Schedule of Assets (Held at End of Year) Form 5500, Schedule H, Part IV, Line 4i as of December 31, 2024.

The Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

Note 5—Related party and party-in-interest transactions

Certain Plan investments are units of mutual funds and money market fund issued, backed, and/or managed by wholly-owned subsidiaries of Fidelity Management Trust Company, the Trustee. These transactions qualify as party-in-interest transactions. Certain broker and investment advisor fees incurred by the Plan are included in net appreciation in fair value of the mutual funds as they were paid through revenue sharing, rather than direct payment. The Plan made other direct payments to the Trustee which are included in administrative expenses. Fees paid by the Plan for the investment management services of Fidelity are reported as a reduction in investment returns. Additional administrative service fees amounted to \$29,940 for the year ended December 31, 2024, which are included in administrative expenses in the statement of changes in net assets available for benefits.

Note 6—Plan termination

Although it has not expressed an intention to do so, the Company has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants remain fully vested in their accounts. Under no circumstances may the Company take ownership of any of the Plan's assets as a result of such termination.

Note 7—Tax status

The Plan has not obtained a determination letter from the Internal Revenue Service ("IRS") stating that the Plan was in compliance with the applicable requirements of the IRC. The Plan is relying on the IRS approval of the standardized prototype plan it is utilizing. The IRS has determined and informed the Trustee by a letter dated June 30, 2020, that the prototype plan document was designed in accordance with applicable sections of the IRC. The Plan administrator believes the Plan is designed and is currently being operated in compliance with the applicable provisions of the IRC. Therefore, the Plan administrator believes the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements.

Note 8—Subsequent events

The Plan evaluated subsequent events through October 10, 2025, when these financial statements were available to be issued.
