## Independent Auditor's Report

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of DRT Holdings, LLC Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate to the best of their knowledge.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).
- The information in the accompanying financial statements related to assets held by and certified to by qualified institutions agrees to, or is derived from, in all material respects, the information prepared and certified by institutions that management determined meet the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

#### Note 1. Description of Plan

The following description of the DRT Holdings, LLC Retirement Plan (the Plan) provides only general information. Participants should refer to the summary plan description for a more complete description of the Plan's provisions.

**General:** The Plan is a defined-contribution plan covering all full-time and part-time employees, excluding students, of DRT Holdings, LLC, DRT Mfg. Co., DRT Precision Mfg., LLC, DRT Aerospace, LLC and Custom Machines, LLC; all wholly owned subsidiaries of DRT Holdings, LLC (the Company, Employer and Plan Sponsor). Employees are eligible to participate in the Plan immediately upon employment. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Contributions:** Participants may make pre-tax and Roth contributions to the Plan, subject to limitations imposed by law. The Company may authorize a discretionary matching contribution equal to a percentage of the participants' contributions. Participants direct the investment of their contributions into various investment options offered by the Plan. Additionally, the Company eliminated the discretionary contribution (Formulated Company Contribution) to the profit-sharing portion of the Plan effective January 1, 2024.

There is a limit placed on the percent of compensation deferred by those participants who are defined by the Plan as highly compensated employees. The Company compares the deferral percentage against several tests as prescribed by law. If the tests are not met, the Company reduces the contribution percentage of the group comprising the highly compensated employees until the tests are met. If, at the end of the year, the tests are still not met, the Company returns the excess contribution to the participant so as to meet the tests.

**Rollovers:** The Plan allows rollovers received by a participant as a distribution from another qualified plan after approval from the Plan Sponsor. Participants are fully vested in these amounts.

**Participant accounts:** Each participant account is credited with participant contributions, a proportionate share of the Company's discretionary profit-sharing contribution, discretionary matching contribution and an allocation of the Plan's earnings thereon. Allocations are based on participant compensation or account balances, as provided in the plan document. Each participant is entitled to only the benefits that can be provided from the participant's account.

**Vesting:** Vesting of Company contributions is based on years of service as defined by the plan document. For participants employed on or after January 1, 2022, these participants vest in matching contributions as follows: 50% after one year of service and 100% after completing two years of service. Participants who terminated prior to January 1, 2022 vested as follows: 20% vesting with two years of service, increasing at 20% per year until full vesting is achieved with six years of service. Employees are fully vested in amounts that they have elected to defer under the 401(k) provisions of the Plan.

**Notes receivable from participants:** Participants may borrow from their vested account balance a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. Loans bear interest at an agreed-upon percentage based upon prevailing market rates. Loan terms are for a period not exceeding five years unless such loan is used to acquire a dwelling unit, which within a reasonable time frame (determined at the time the loan is made) will be used as the participant's principal residence. Each loan is collateralized by the vested account balance in the participant's account, up to a maximum of 50%. Principal and interest are paid ratably through payroll deductions. Interest rates on participant loans range from 4.25% to 9.50% as of December 31, 2024 and 2023.

**Forfeited accounts:** Forfeited, non-vested accounts totaled \$13,839 and \$18,963 at December 31, 2024 and 2023, respectively. These amounts are used to pay plan expenses or reduce future employer contributions. Forfeitures totaling \$766 were used to reduce employer matching contributions for the year ended December 31, 2024.

**Payment of benefits:** On termination of services, or upon death, disability or retirement, a participant, or their beneficiary in the case of death, may receive a lump-sum payment or installment amounts equal to the participant's vested account balance. The Plan also permits certain financial hardship withdrawals.

#### Note 2. Summary of Significant Accounting Policies

**Basis of presentation:** The accompanying financial statements are prepared in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) in accordance with the Financial Accounting Standards Board (FASB) Accounting Standards Codification.

**Investment valuation and income recognition:** The Plan's participant directed investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Because the fixed annuity investment contract is fully-benefit responsive, contract value is the relevant measurement attribute for that portion of net assets available for benefits attributable to the fixed annuity investment contract. The fixed annuity investment contract is presented on the face of the statements of net assets available for benefits at contract value. Contract value, as reported to the Plan by Voya Retirement Insurance and Annuity Company (Plan's trustee), represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year. The change in the difference between market value and cost of investments is reflected as net appreciation/depreciation in the fair value of investments in the periods in which such changes occur. Capital gain distributions are included in dividend income.

**Notes receivable from participants:** Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes are treated as distributions based upon the terms of the plan document.

**Contributions:** Participant contributions and employer matching contributions are recognized when earned. Employer profit sharing contributions are recognized on an annual basis.

**Payment of benefits:** Benefit payments to participants are recorded when paid.

**Administrative expenses:** The Plan's administrative expenses are paid by the Plan or by use of the forfeiture account balances.

**Use of estimates:** The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements, and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

The information related to investments from participants that is included throughout the Plan's financial statements and supplemental schedules as of December 31, 2024 and 2023, and for the year ended December 31, 2024, was prepared by or derived from information provided by the current trustee and former custodian, and furnished to the Plan Administrator. The Plan Administrator has obtained certifications from the Plan's trustee that information provided to the Plan Administrator by the Plan's trustee related to these plan assets is complete and accurate to the best of their knowledge.

Accordingly, as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to information in Notes 7 and 8 and the supplemental schedule related to the Plan's investments.

Voya Institutional Trust Company certified the completeness and accuracy of \$4,368,087 of net appreciation in fair value of investments and \$2,008,781 of dividend and interest income related to investments for the year ended December 31, 2024.

#### **Note 4. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to provisions set forth in ERISA. In the event of Plan termination, participants become fully vested and the net assets will be distributed to participants and beneficiaries in proportion to their respective account balances.

#### **Note 5. Income Tax Status**

The Plan has adopted a volume submitter plan sponsored by Esler & VanderSchaaff Co., LPA. The volume submitter plan provider has received an advisory letter from the Internal Revenue Service as to the volume submitter plan's qualified status. The volume submitter plan advisory letter has been relied upon by the Plan. The Plan has been amended since the volume submitter plan received the advisory letter. The Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the Internal Revenue Code.

The Plan Administrator evaluated the Plan's tax positions and concluded that there are no uncertain tax positions that require recognition or disclosure in the financial statements. The Plan is subject to routine examinations by tax jurisdictions; however, there are currently no examinations for any tax periods in progress. The Plan Administrator believes the Plan is no longer subject to income tax examinations by tax authorities for years before 2021.

#### **Note 6. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statement of net assets available for benefits.

#### Note 7. Fair Value Measurements

The Plan has determined the fair value of certain assets through application of accounting guidance that establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value.

The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under this standard are described below:

**Level 1:** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2:** Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3:** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

**Mutual funds:** Valued at the closing price reported on the active market on which the individual securities are traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Plan management evaluates the significance of transfers between levels based upon the nature of the investment and size of the transfer relative to total net assets available for benefits.

#### Note 8. Group Annuity Contract

The Plan has a traditional investment contract with Voya Retirement Insurance and Annuity Company (Voya). This contract meets the fully benefit-responsive investment contract criteria and is therefore reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses.

Voya maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The investment contract held by the Plan is a guaranteed investment contract. The contract issuer is contractually obligated to repay the principal and interest invested in the general account assets of Voya.

The plan's ability to receive amounts due in accordance with the fully benefit-responsive investment contract is dependent on Voya's ability to meet its financial obligations. Voya's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: termination of the contract, spin-offs, divestitures, layoffs, corporate relocation, partial or total plan termination, retirement incentive programs and the liberalization of plan withdrawal or transfer rules. The Plan Administrator does not believe that the occurrence of any such value event, which would limit the Plan's ability to transact at contract value, is probable. Either the Plan or the insurance company may terminate the contract at any time with 90 days advance written notice. There are no reserves against the contract value for credit risk of the contract issuer or otherwise.

#### Note 9. Related-Party and Party-in-Interest Transactions

Certain plan investments are managed by the custodian/trustee, and therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for custodian services provided by Voya Institutional Trust Company amounted to \$159,782 for the year ended December 31, 2024.
