Independent Auditors' Report

To the Plan Participants and Plan Administrator of

Opinion

We have performed audits of the financial statements of Cambridge-Lee Industries, Inc. Employees' Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of December 31, 2024 (in liquidation) and 2023 (in liquidation), and the related statement of changes in net assets available for benefits for the years ended December 31, 2024 (in liquidation) and 2023 (in liquidation), and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits of Cambridge-Lee Industries LLC as of December 31, 2024 (in liquidation) and 2023 (in liquidation), and the changes in its net assets available for benefits for the years ended December 31, 2024 (in liquidation) and 2023 (in liquidation), in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

Emphasis of Matter - Plan Termination and Liquidation Basis of Accounting

As discussed in Notes 1 and 2 to the financial statements, on October 25, 2023, the Plan sponsor's Board of Directors approved a decision to terminate the Plan effective December 31, 2023 and management determined that liquidation of the Plan was imminent. In accordance with accounting principles generally accepted in the United States of America, the Plan's financial statements are presented under the liquidation basis of accounting for the years ended December 31, 2024 and 2023. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. 1. Description of Plan

The following description of the Cambridge-Lee Industries, Inc. Employee Retirement Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan is a noncontributory defined benefit pension plan covering substantially all employees of Cambridge-Lee Industries, Inc. and other affiliated companies (collectively, the Company or Employer) who have completed one year of employment on or before January 18, 1994, are age twenty-one or older and were not covered by a collective bargaining agreement with the Company. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

The Plan's Board of Trustees is responsible for the operation, administration and oversight of the Plan. The Plan's Investment Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to the Plan's Board of Trustees.

On January 18, 1994, the Board of Directors of the Company voted to close accruals under the Plan effective March 31, 1994. As of March 31, 1994, all participants of the Plan became fully vested and no benefits for further services have accrued subsequent to that date.

On October 25, 2023, the Board of Directors of the Company resolved to terminate the Plan effective December 31, 2023. Upon termination, substantially all assets remaining in the Plan (except for any excess funding) were to be distributed to the participants during 2024 and 2025, subject to the applicable requirements of ERISA and in accordance with the provisions of the plan document.

Plan Termination, Liquidation and Subsequent Events

As disclosed above, it was resolved that the Plan would effectively terminate on December 31, 2023 and the Plan began the process of liquidation during 2024. During 2024, the Plan paid approximately \$234,000 in pension and death benefits prior to the purchase of an annuity contract that effectively removed the Plan's obligation to pay those benefits. In addition, the Plan paid approximately \$1,479,000 in lump sum benefit payments to those former participants who elected to take lump sum settlements from the Plan prior to June 1, 2024. The Plan purchased a group annuity contract for the remaining participants and transferred cash of approximately \$4,993,000 to an annuity company to satisfy the unpaid accumulated pension benefit owed by the Plan. The liability assumption date of the group annuity contract was June 1, 2024, and therefore, no participants remained in the Plan as of that date. Payments from the group annuity contract to former participants of the Plan commenced June 1, 2024.

Subsequent to year-end, the Plan paid additional annuity premiums to either the annuity company or the Pension Benefit Guaranty Corporation, totaling approximately \$75,000, to purchase or adjust annuities for certain participants or missed participants. In March 2025 and July 2025, the Company reverted approximately \$700,000 and \$44,000, respectively, in excess funding to the Plan sponsor. After the final reversion of excess funds to the Plan sponsor, the Plan became fully liquidated.

The following attributes of the Plan were based on the plan document prior to termination.

Funding Policy

The Plan's funding policy was for the Company to contribute an amount which will meet or exceed the annual ERISA minimum funding requirement. No participant contributions are permitted. No employer contributions were required for the years ended December 31, 2024 or 2023 based upon actuarial funding calculations. The minimum funding requirements of ERISA were met for 2024 and 2023.

Pension Benefits

Prior to June 1, 2024, a participant who had attained age 65 and reached his or her fifth anniversary of participation in the Plan was entitled to receive a normal pension benefit equal to 1.25% of his or her final, five-year average earnings up to covered compensation, plus 1.9% of his or her final, five-year average earnings in excess of covered compensation, multiplied by credited service (to a maximum of 25 years). Earnings have stopped accruing as of March 31, 1994, the date of the freeze. This benefit was payable for life but not less than five years in any event. Benefits under the Plan were distributable, at the discretion of the participant, in a monthly life annuity with (1) a joint and survivor annuity option, (2) a life annuity with a five-year guarantee option or (3) a life annuity with a 10-year guarantee option.

Any participant who had attained age 52 and had completed at least 10 years of qualifying service was entitled to receive an early retirement benefit equal to the normal retirement benefit, reduced by 2/3 of 1% for each of the first 36 months by which commencement of benefits preceded normal retirement date and 1/3 of 1% thereafter.

Death Benefits

Prior to June 1, 2024, if the participant was eligible for early retirement, the benefit payable to the participant's spouse was an annuity for life equal to what the spouse would have received had the participant retired just prior to death and elected a 100% joint and survivor annuity option. If the participant had completed five years of service but was not age 52 and dies, the death benefit was deferred until the participant would have been eligible for early retirement and will be payable to the spouse as if the participant had elected a 50% joint and survivor annuity option.

2. Summary of Accounting Policies

Basis of Accounting

As a result of the resolution to terminate and liquidate the Plan, the financial statements of the Plan as of and for the years ended December 31, 2024 and 2023 are presented on the liquidation basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results may have differed from the original estimates.

It has been determined that the presentation of the actuarial present value of accumulated plan benefits and changes therein (historically done as of the beginning of plan year), for all periods of the financial statements, are not necessary given that the Plan was terminated effective December 31, 2023 and has since become fully liquidated as of July 2025. There was no valuation performed as of January 1, 2024 and the January 1, 2023 valuation is no longer relevant to these financial statements.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians or insurance companies, as applicable. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits payments to participants are recorded upon distribution.

Administrative Expenses

The Plan's expenses are paid either by the Plan or the Company, as provided by the plan document. Expenses that are paid directly by the Company are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the Statement of Changes in Net Assets Available for Benefits. In addition, certain investment related expenses are included in net appreciation in fair value of investments in the Statements of Changes in Net Assets Available for Benefits.

Subsequent Events

Subsequent events were evaluated through October 13, 2025, the date the financial statements were available to be issued.

3. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under authoritative guidance are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observables and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Interest-bearing cash: These investments are stated at cost, which approximates fair value.

Money market funds: Valued at the quoted net asset value (NAV) of shares held by the Plan at year-end.

5. Tax Status

The Internal Revenue Service (IRS) has determined and informed the Company by a letter dated December 16, 2002, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan has been amended since receiving the determination letter. However, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

6. Risks and Uncertainties

The Plan may invest in various investment securities. Investment securities can be exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities could occur in the near term and that such changes could materially affect the amounts reported in the Statements of Net Assets Available.

As of December 31, 2024, the Plan's investments were comprised of interest bearing cash savings accounts and money market funds. None of these investments exceeded the FDIC limits of \$250,000 per account.
