We have performed audits of the financial statements of Norder Supply, Inc. 401(k) Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

1. Plan Description

The following brief description of the Norder Supply, Inc. 401(k) Profit Sharing Plan (the Plan) is provided for general informational purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan provides retirement benefits for the employees of Norder Supply, Inc. (the Company).

Employees, excluding union, non-resident aliens, leased, reclassified, and seasonal and temporary employees (whose employment began after January 1, 2013 and is limited to less than 1,000 hours of service), are eligible to make pre-tax and after-tax Roth salary deferral contributions after attaining age 21. Eligible employees may become participants immediately upon the date on which the entry requirements were fulfilled. The Plan is a "Safe Harbor 401(k) Plan" whereby the Company is required to make safe harbor matching contributions and may make additional discretionary matching contributions and discretionary non-elective contributions. To receive safe harbor matching contributions and discretionary matching contributions, employees must be 21 years of age and complete one year of service (1,000 hours). Employees must be employed on the last day of the year (with 1,000 hours of service) in order to receive discretionary non-elective contributions. The Plan entry date for any Company contributions is the first day of the Plan year or the first day of the seventh month of the Plan year when eligibility requirements are fulfilled.

Contributions

Participants may make voluntary salary deferral contributions of up to 100% of their eligible annual compensation in connection with the 401(k) or Roth provisions of the Plan up to the maximum deferral dollar amount allowed by law. Participants may also contribute amounts representing distributions from other qualified plans. The Company will make a safe harbor matching contribution equal to 100% of the participant's elective deferral up to 4% of eligible compensation. If a discretionary matching contribution is made, it will apply to elective deferrals up to 6% of eligible compensation and the total amount of the discretionary matching contribution will not exceed 4% of total eligible compensation. The Company may also make discretionary non-elective contributions. Participants who are projected to attain age 50 before the close of the calendar year shall be eligible to make catch-up contributions. Contributions are subject to certain limitations.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of a) the Company's safe harbor matching contributions, discretionary matching contributions, and discretionary non-elective contributions and b) Plan earnings and losses and charged with an allocation of administrative expenses. The Company's safe harbor matching contributions and discretionary matching contributions are allocated based upon each participants' elected salary deferral. The Company's discretionary non-elective contributions are allocated among participants on the basis of the participant's compensation to the aggregate compensation of all participants. Plan earnings or losses are allocated on the basis of actual results of investments held in participant accounts. Effective July 1, 2024, investments are maintained in individual member accounts managed by Matrix Trust Company (Matrix). Prior to July 1, 2024, investments were maintained in individual member accounts managed by United of Omaha Life Insurance Company (United of Omaha).

Vesting

Participants are immediately vested in their contributions and the Company's safe harbor matching contributions plus actual earnings thereon. The Company's discretionary matching contributions and discretionary non-elective contributions credited to participants' accounts are vested based on years of continuous service. A participant is 20% vested after two years of credited service and vesting increases 20% per year until a participant is 100% vested after six years of service.

Payment of Benefits

Upon retirement, termination, disability, or death or attainment of age 59.5 (for certain in-service distributions), the participant or beneficiary may receive a single lump sum or partial payments equal to the value of the vested funds allocated to the participant's account. Distributions under \$7,000 (\$5,000 prior to January 1, 2024) will be directly rolled over to an individual retirement account designated by the plan administrator in the event the participant does not elect a payout option. The Plan also allows for hardship distributions (as defined by the Plan document). Benefits are recorded when paid.

Forfeitures

Upon a participant's termination of employment before normal retirement, disability, or death, the portion of the Company's discretionary matching contributions and discretionary non-elective contributions not then vested shall be forfeited. The forfeitures may be used to pay Plan expenses, to reduce all Company contributions or be allocated as additional discretionary matching contributions and discretionary non-elective contributions. There were \$3,074 and \$8,059, of forfeitures available as of December 31, 2024 and 2023, respectively. The Company used \$5,962 and \$3,480 of forfeitures to reduce Company contributions or to pay Plan expenses during 2024 and 2023, respectively.

2. Summary of Significant Accounting Policies

A summary of the significant accounting policies consistently applied in the preparation of the accompanying financial statements is set forth below.

Basis of Presentation

The accompanying financial statements have been prepared on the accrual basis and in conformity with accounting principles generally accepted in the United States of America.

Presentation of Participant-Directed Funds

The Plan's presentation of participant-directed investments is in accordance with the Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 962, *Plan Accounting – Defined Contribution Pension Plans*.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments, except for fully benefit-responsive investment contracts, are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Company determines the Plan's valuation policies utilizing information provided by the investment advisors and custodian. See Note 4 for further discussion of fair value measurements.

Fully benefit-responsive investment contracts (the Plan no longer holds as of July 1, 2024) were reported at contract value. Contract value was the relevant measurement attribute for that portion of the net assets available for benefits of a defined-contribution plan attributable to fully benefit-responsive investment contracts because contract value was the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. The Company invested in investment contracts through a guaranteed investment account.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Expenses

Audit fees are paid by the Company and are excluded from these financial statements. Certain investment management and record-keeping expenses are paid by the Plan and other expenses specifically incurred or attributable to individual participants are paid from the applicable participants' accounts and are included administrative expenses. Other investment-related expenses are included in net appreciation in fair value of investments.

Subsequent Events

Subsequent events are events or transactions that occur after the statement of net assets available for benefits date, but before the financial statements are available to be issued and may require potential recognition or disclosure in the financial statements. Management has considered such events or transactions through October 8, 2025, noting no items requiring disclosure.

3. Information Certified by Matrix and United of Omaha

The plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the plan administrator instructed the Plan's independent auditor's not to perform any auditing procedures with respect to the following information certified by Matrix and United of Omaha, except for comparing such information certified by the custodians to information included in the Plan's financial statements and supplementary information.

4. Fair Value Measurements

FASB ASC 820, *Fair Value Measurements and Disclosures* provides a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2: Inputs to the valuation methodology include:
 - Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability;
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset’s or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at December 31, 2024 and 2023.

Pooled Separate Accounts: Valued at the Net Asset Value (NAV) of its underlying investments. FASB ASC 820, *Fair Value Measurement*, allows NAV to estimate the fair value as a practical expedient as long as certain requirements are met. It is the Plan's assessment that these accounts meet those requirements, since the participants have the ability to redeem the accounts at NAV as of the measurement dates on a daily basis. The accounts have no unfunded commitments at December 31, 2023.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their NAV and to transact at that price. Mutual funds held by the Plan are deemed to be actively traded.

Collective Trust Funds: Valued at the NAV. FASB ASC 820, *Fair Value Measurement*, allows NAV to serve as a practical expedient to estimate fair value as long as certain requirements are met. It is in the Plan's assessment that this fund meets those requirements, since the participants have the ability to redeem this fund at NAV as of the measurement date on a daily basis. The funds have no unfunded commitments at December 31, 2024.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Investment Contract with United of Omaha

The Plan had entered into an investment contract with United of Omaha (through July 1, 2024). United of Omaha maintained the contributions in pooled separate accounts and a guaranteed investment account. The accounts were credited with earnings on the underlying investments and charged for Plan withdrawals and administrative expenses charged by United of Omaha.

The pooled separate accounts, as reported to the Plan by United of Omaha, were included in the financial statements at fair value, which represented contributions made under the contract, plus earnings, less withdrawals and administrative expenses.

As the guaranteed investment account was fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment account. Contract value, as reported to the Plan by United of Omaha, represented contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants could ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

6. Tax Status

The Plan is qualified as a profit-sharing plan under Section 401(a) of the Internal Revenue Code and is exempt from federal income taxation under Section 501(a) of the Internal Revenue Code.

The plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authority. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

7. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested. Any unallocated assets of the Plan shall be allocated to participant accounts and distributed as soon as practicable after the termination date.

8. Related Party Transactions

Certain plan investments at December 31, 2023, were pooled separate accounts and a guaranteed investment account managed by United of Omaha or affiliate, Stadion Money Management. United of Omaha was the former custodian as defined by the Plan, therefore these transactions qualified as party-in interest transactions.
