Opinion

Note 1 DESCRIPTION OF PLAN

The following description of the Local 49 Heat and Frost Insulators Retirement Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a complete description of the Plan's provisions.

General

The Plan is a defined contribution retirement plan with participant directed investments covering members of the International Association of Heat and Frost Insulators and Allied Workers Local Union No. 49. It is subject to the provisions of the Employer Retirement Income Security Act of 1974 (ERISA) and the Internal Revenue Code of 1986, as amended.

Contributions

Contributions are received from participating employers at an amount not less than the hourly amount specified in the Collective Bargaining Agreement for such employers. The Plan also allows for a deferred arrangement qualified under Section 401(k) of the Internal Revenue Code.

Participant Accounts

Each participant's account is credited with the employer contribution and an allocation of plan earnings based on their individual choice of investments. The income of the trust fund shall be allocated to each participant's elective account on each valuation date. In the event a participant fails to make an investment election, with respect to all or any portion of his account subject to his investment direction, the Trustee will invest all or such portion of his account in the qualified default investment alternative to be designated by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

All items of administrative expenses, other than investment expenses, incurred during the year by this Fund will be charged against each participant's account balance by allocating either a pro rata or a per capita amount of such charges against all account balances in existence as of the date the expense is charged to participant's accounts.

Vesting

A Participant will have a 100% non-forfeitable interest in the participant's account at all times.

Note 1 DESCRIPTION OF PLAN (Continued)

Benefit Payments

Benefits are paid directly to participants or their beneficiaries upon death, retirement, total and permanent disability before retirement, or upon termination of service with the employer.

Distributions of benefits from the Account A (assets transferred from Legacy Plan, see Note 3, or qualified rollovers) portion of a participant's account will be paid in a single lump sum unless the participant elects an optional form of benefit provided in the Plan's provisions. However, if a participant is married at the time of separation and the participant's account exceeds \$5,000, payment of the participant's benefits will be in the form of the Qualified Joint and Survivor Annuity unless their spouse consents in writing to another form of payment.

Distribution of benefit from the Accounts B and C (contributions made to the Plan that are not transferred from the Legacy Plan or rollover contributions into the plan and elective deferral contributions, respectively) portions of a participant's account will be paid in the form of a lump sum cash distribution unless the participant elects an optional form of benefit provided in the Plan's provisions. Distributions from Accounts B and C are not subject to the Qualified Joint and Survivor Annuity.

Notes Receivable from Participants

Participants may borrow from their account a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balances. The loans are secured by the balance in the participant's account. The interest rate is fixed and will be equal to the prime rate plus one and one-half percent. Principal and interest are paid through an automatic withdrawal payment system with the participant's bank or other institution.

Note 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Presentation

The financial statements of the Plan are recognized on the accrual basis of accounting.

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Note 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Valuation of Investments and Income Recognition

The Plan's investments are stated at fair value. Shares of mutual funds are valued at quoted market prices, which represent the net asset value of shares held by the Plan at year-end. Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments purchased and sold as well as held during the year.

The Plan's investments are held by John Hancock Trust Company LLC as of the end of the plan year.

Fair Value Measurements

The Financial Accounting Standards Board Accounting Standards Codification (FASB ASC) establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under the FASB ASC are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Fair Value Measurements (Continued)

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value as of December 31, 2024.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Pooled Separate Accounts: PSA's are valued at NAV which is based on the value of the underlying assets owned by the PSA minus any liabilities, and then divided by the number of shares outstanding. The PSA's invest primarily in mutual funds, exchange traded funds or collective investment trusts. The Plan has concluded that the NAVs reported by the investment companies approximate the fair value of the investments. There are currently no redemption restrictions or unfunded commitments on these investments.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Defaulted loans are carried on the books as a note receivable until a distributable event occurs. The Plan had \$170,161 and \$123,957 in defaulted loans as of December 31, 2024 and 2023, respectively.

Administrative Expenses

Administrative expenses are paid directly by the Plan.

Payment of Benefits

Benefit payments to participants are recorded when paid.

Subsequent Events

In preparing these financial statements, the Plan has evaluated events and transactions for potential recognition or disclosure through September 25, 2025, the date the financial statements were available to be issued.

Note 4 CONCENTRATION OF CREDIT RISK

The Plan maintains cash balances at financial institutions, which, at times, may exceed federally insured limits. The Plan has not experienced any losses from these accounts. The Plan believes it is not exposed to any significant risk on such balances. Credit risk for contributions receivable is concentrated as well because the balances are from companies located within the same geographic region.

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such change could materially affect the amounts reported in the statements of net assets available for benefits.

Note 5 INCOME TAX STATUS

The Plan is qualified under Section 401(a) of the Internal Revenue Code and is exempt from federal income taxes. The most recent favorable determination letter is dated June 27, 2018. The Plan is also exempt from state income taxes. The Plan has been amended since receiving the determination letter; however, the Plan administrator believes that the Plan continues to qualify and operate as designated.

Note 6 PLAN TERMINATION

Although it has not expressed any intent to do so, in the event of Plan termination, the participants' balances, net of the expenses incurred at that date, will be returned to each participant with no part of the assets being forfeited to the employers or union. Upon full termination of the Plan, the Trustees shall direct the distribution of the assets of the Trust Fund to participants in a manner, which is consistent with the payment provisions in Note 1. Distributions to a participant shall be made in cash.
