INDEPENDENT AUDITOR'S REPORT

To the Administrative Committee and participants of the
MedCare South 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the MedCare South 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements (the financial statements).

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the investment information is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section of the report,

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP); and
- the certified investment information in the accompanying financial statements agrees to, or is derived from, in all material respects, the information prepared and certified by a qualified institution that management determined meet the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are available to be issued.

Management is also responsible for administering the Plan and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

1. Description of Plan

The following description of the MedCare South 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document, copies of which are available from the plan administrator, for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all employees of MedCare South, LLC and its subsidiaries (collectively, the Company) who have completed 60 days of service and who are age 21 or older. Participants are allowed to enroll in the Plan on the first day of the month coinciding with or next following when the requirements are met. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

During 2024, the Company sold one healthcare facility, resulting in a partial plan termination. Effective June 30, 2024, all affected participants are considered fully vested in their Company contributions due to the partial plan termination.

Effective August 14, 2025, the Company was merged into Regional Health Properties, Inc. Regional Health Properties, Inc. and Adcare Administrative Services, LLC both become participating employers of the Plan effective August 14, 2025. In October 2025, the plan sponsor name was changed to Crown Healthcare Investments, LLC and the Plan name was changed to Regional Health Properties, Inc. 401(k) Plan.

Contributions

Each participant may make pre-tax and/or Roth contributions of up to 100% of eligible compensation as defined by the Plan, not to exceed a maximum of \$23,000 in 2024, plus additional "catch-up" contributions of up to \$7,500 for those participants who have attained age 50 by the end of the Plan year. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers).

The Company may make a discretionary matching contribution on a quarterly or annual basis for participants who are employed by the Company on the last day of the quarter or Plan year, respectively. In addition, the Company may make a discretionary nonelective contribution for participants with at least 500 hours of service during the Plan year and who are employed by the Company on the last day of the Plan year. In 2024, the Company did not make any discretionary contributions.

Participant Accounts

Each participant's account is credited with the participant's contribution, rollovers, the Company's contribution, and earnings and losses on the investments in their account and is charged with certain fees related to specific transactions and an allocation of administrative

expenses based on participant account balances. Upon enrollment in the Plan, a participant may direct any contributions to any of the investment options offered by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their account is based on years of continuous service. Participants vest 20% per year in the Company's contribution and are fully vested after 5 years of service. A participant must work at least 1000 service hours annually to be credited with a year of service. Participants affected by a partial plan termination become fully vested in their Company contributions.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of the vested balance of their account. A participant may have one note outstanding at a time. The notes are secured by the balance in the participant's account and bear interest at the prime rate plus 1%. At December 31, 2024, notes had fixed rates of 4.25% to 9.50% for the term of the note not to exceed 5 years, or 10 years if used for the purchase of a principal residence. Principal and interest are paid through payroll deductions.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service (IRS) are recorded as a liability and a reduction to contributions in the year the original contribution was made. The Plan distributed the 2024 and 2023 excess contributions to applicable participants in 2025 and 2024, respectively.

Payment of Benefits

At the time of death, disability, termination of service or retirement, the participant or their beneficiary may receive payment of the vested interest in their account in a lump-sum distribution, or a series of distribution payments. After attaining the age of 59 ½, participants may also be eligible to make an in-service withdrawal of all or part of their vested account. The participant's contributions may also be withdrawn for certain hardship situations. If a participant terminates employment and has an account balance of less than \$1,000, the participant will automatically receive a lump-sum distribution of their vested account. Balances greater than \$1,000, but less than \$7,000, will be automatically rolled over to an individual retirement account (IRA) set up in the participant's name, if no distribution election is made.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$4,341 and \$4,201, respectively. Forfeitures can be used to reduce Company contributions or to pay Plan administrative expenses. During 2024, no forfeitures were used by the Company.

Administrative Expenses

Loan origination fees and certain transaction fees for withdrawals are charged directly to the respective participant's account. Consulting fees, audit fees, and certain recordkeeping fees are paid by the Plan. These expenses are paid to service providers of the Plan and qualify as party-in-interest transactions. All other expenses are paid by the Company. The Company does not expect reimbursement from the Plan for any expenses paid on behalf of the Plan.

The Plan has established an ERISA account where the qualified institution deposits revenue sharing payments that can be used to pay Plan administrative expenses. The account balance at December 31, 2024 and 2023 was \$76,729 and \$84,012, respectively, and is included in interest-bearing cash or non-interest bearing cash, respectively, on the accompanying statements of net assets available for benefits. During 2024, \$98,226 was deposited into the account and expenses totaling \$105,509 were paid from the account. Deposits to this account are included in net change in fair value of investments in the accompanying statement of changes in net assets available for benefits. Payments are included in expenses in the year paid.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are presented on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Contributions

Participant contributions are considered payable to the Plan upon the withholding of contributions from the participant's paycheck. The Company discretionary matching and discretionary nonelective contributions are considered payable to the Plan when they are approved by the Company.

Valuation of Investments and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements. Net change in fair value of investments includes interest, dividends, and realized and unrealized gains and losses on those investments. Interest income is recorded when earned.

Notes Receivable from Participants

Notes receivable from participants are carried at their outstanding principal balance. Interest income is recorded when receivable by the Plan. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make note repayments and the plan administrator deems the participant note to be in default, the participant note balance is reduced, and a deemed distribution is recorded. Notes receivable from participants also qualify as party-in-interest transactions.

Payment of Benefits

Benefits are recorded when paid.

Subsequent Events

Management evaluates events occurring subsequent to the date of the financial statements in determining the accounting for and disclosure of transactions and events that affect the financial statements. Subsequent events have been evaluated through October 13, 2025, which is the date the financial statements were available to be issued.

3. Information Certified by the Qualified Institution

All information in the accompanying financial statements and supplemental schedule, including investments held and notes receivable from participants at December 31, 2024 and 2023, and the net change in fair value of investments and interest income for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by State Street Bank and Trust Company (State Street), the Plan's qualified institution.

4. Investments

Certain Plan investments include a mutual fund and the stable value fund managed by Transamerica Retirement Solutions (Transamerica) and Transamerica Capital, Inc., affiliates of State Street. Additionally, the Plan has an interest-bearing cash account that is managed by State Street. State Street is the qualified institution of the Plan; therefore, transactions in these investments qualify as party-in-interest transactions. Fees incurred by the Plan for investment

management services are included in net change in fair value of the investment as they are paid through revenue sharing rather than a direct payment.

Investments are exposed to various risks, such as market, currency, interest rate, and credit risks. Market risks include U.S. and global events which could impact the value of Plan investments. Such events would include healthcare crises, such as a pandemic, international conflicts, supply chain disruptions, global monetary policy decisions, significant exogenous economic influences, and significant cybersecurity attacks. It is at least reasonably possible that changes in their fair value will occur in the near term and that such changes could materially affect participants' account balances.

The Financial Accounting Standards Board established a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value into three levels. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities, and the lowest priority to unobservable inputs. The three levels of the fair value hierarchy are described as follows:

Level 1 – unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access

Level 2 – other observable data, including quoted prices for similar assets or liabilities in active markets

Level 3 – unobservable inputs

Observable inputs are those based on market data obtained from sources independent of the Plan, and unobservable inputs reflect the Plan's own assumptions based on the best information available. The input levels are not necessarily an indication of the risk or liquidity associated with financial instruments at that level but rather the degree of judgment used in determining those values.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Investments in mutual funds and the interest-bearing cash account are stated at quoted market prices for the identical security in an active market (Level 1).

The Plan invests in a stable value fund. The stable value fund invests in one fund which, in turn, primarily invests in investment contracts, including traditional guaranteed investment contracts (GICs) and security-backed contracts issued by insurance companies and other financial institutions. GICs are backed by the general account of the contract issuer and the issuer guarantees that all qualified participant withdrawals will be at contract value (principal plus accrued interest). A security-backed contract is an investment contract issued by an insurance

company or other financial institution backed by a portfolio of bonds and other securities. The Plan's investment in the stable value fund is stated at net asset value (NAV) as reported by the investment advisor. The NAV of the stable value fund is determined daily based on the fair value of underlying investments. The Plan can trade the stable value fund daily. The stable value fund is considered to be a Level 2 asset because it is not considered to be traded in an active market. The stable value fund has a restriction on withdrawal of up to one year if the Company eliminates this investment option and up to 90 days for certain participant withdrawals.

5. Plan Termination

Although it has not expressed an intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants would become fully vested in Company contributions.

6. Income Tax Status

The Plan is a non-standardized pre-approved profit sharing plan with CODA (pre-approved plan) created by Transamerica. The Internal Revenue Service has determined and informed Transamerica by a letter dated June 30, 2020, that the pre-approved plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the pre-approved plan's opinion letter and has not obtained an individual determination letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. The Plan's income tax returns for the past three years are subject to examination by taxing authorities and may change upon examination.
