**Note 1. Description of Plan**

The following is a brief description of Tribune Publishing Company 401(k) Plan (the “Plan”). Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

**General**

The Plan is a defined contribution plan subject to the provisions of the *Employee Retirement Income Security Act of 1974* (“ERISA”). The Plan was established on June 13, 2014. It was amended and restated on July 1, 2022. The Plan covers certain employees of Tribune Publishing Company (the “Company” or “Employer”). The Plan excludes union employees other than employees who are in the NY Daily News Control Room Union, the LA Times Guild Union, the Chicago Tribune Guild Union, the Digital Production Studio Union, the Suburban Hoy Union, Virginian Pilot/Daily Press Guild Union or the Virginia Gazette and Tidewater Review Guild Union, Chesapeake News Guild Union, Harford Courant Guild Union (effective February 20, 2019), Morning Call Guild Union (effective April 1, 2019), The Daily Meal Union and Tribune Content Agency Guild union (effective August 27, 2020), The Baltimore Sun Drivers (Teamsters) Chicago Tribune Drivers (Teamsters). Baltimore Sun (Guild), Pioneer Press Editorial Guild), Post Tribune Editorial (Guild), Chicago Tribune Machinists (IAM) (effective July 1, 2022).

Effective June 1, 2023, the Plan excluded union employees of Schaumburg Production Facility, however, the union employees who are in the Baltimore Sun (Guild), Pioneer Press Editorial (Guild), Post Tribune Editorial (Guild), Chicago Tribune Machinists (IAM), or employed at the Schaumburg Production Facility shall be eligible employees only for purposes of elective deferrals and non-elective contributions not for purposes of employer matching contributions.

The plan was amended effective January 12, 2024, to allow leased employees to participate in the plan.

Effective June 28, 2025, the Plan Sponsor entered into an agreement to sell the Baltimore Sun. On this date, all employees of the Baltimore Sun were terminated and their account balances were distributed.

**Eligibility and Contributions**

Full time employees become eligible for participation on the first business day. Participants may make pre-tax and Roth contributions from 1% to 75% of their eligible compensation each pay period, subject to the limitations of the Internal Revenue Code (“IRC”). Participants over the age of 50 are able to defer an additional amount, subject to the limitations of the IRC (“catch-up contribution”). Participants are automatically enrolled at a pre-tax deferral percentage of 3%, unless the participants elect not to participate in the Plan or chooses their own deferral rate.

The Plan allows for discretionary match contributions in amounts to be determined by the Company, based on eligible compensation contributed to the Plan. There is no service requirement for full-time employees. Part time employees and full time employees of Baltimore Sun (Guild) are eligible to receive match contributions if they have completed at least 1,000 hours of service during the applicable period. For the year ended December 31, 2024, the Company made discretionary match contributions of \$563,955.

The employer may, in its sole discretion, make a non-elective contribution to the plan on behalf of its participants. Participants, other than collectively bargained employees of Baltimore Sun (Guild), will be eligible to receive an allocation if they have completed at least 1,000 hours of service during the applicable period and are employed on the last day of applicable period. Certain collectively bargained employees of Baltimore Sun (Guild) will be eligible to receive a contribution of 3.5% of the employee’s eligible compensation. For the year ended December 31, 2024, the Company made non-elective contributions of \$60,903.

***Vesting***

Participants are always fully vested in their own contributions plus earnings thereon. Participants become fully vested in the Plan's employer contributions after 2 years of service. A participant will become fully vested in the event of permanent disability or death.

In connection with the July 1, 2022 restatement of the plan document, the Plan adopted an additional vesting schedule will apply to DCRP Union participants (Baltimore Sun Guild, Post Tribune Guild and Chicago Tribune Machinists): Less than 2 years – 0%, 2 years – 25%, 3 years – 50%, 4 years – 75%, 5 years – 100%.

***Forfeitures***

The portion of a participant's account balance, which is not vested upon termination of employment, is forfeited and remains in the Plan. Forfeitures are used to reduce Company contributions or to pay allowable Plan expenses. Forfeitures were approximately \$137,000 and earnings on forfeitures were \$17,000 for the year ended December 31, 2024. Uncashed checks totaling approximately \$71,100 were returned to Plan during the year ended December 31, 2024. Company contributions and administration fees of \$67,000 were funded from the forfeiture account for the year ended December 31, 2024. At December 31, 2024 and 2023, there were forfeitures of approximately \$661,500 and \$503,400 available, respectively.

***Benefit Payments***

Upon attaining the age of 65, a participant is entitled to a lump-sum distribution from the Plan, with optional forms of installment payments and partial payments. In addition, participants may withdraw funds from the Plan upon termination of employment or, in certain other cases and subject to the approval of the Retirement Plan Committee; participants may request a withdrawal of a portion of their balances in the case of financial hardship.

***Notes Receivable from Participants***

Loans may be available to the participants subject to the approval of the Plan administrator. Participants may borrow a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Their vested account balances also serve as collateral for the loan. A participant can have no more than two loans outstanding at any time. Interest rates ranged from 3.25% to 9.50% at December 31, 2024. Loans that are in default are accounted for as a distribution in the year the default occurs.

***Participant Accounts***

Individual participant accounts are credited with participant contributions, the Company's matching contributions, the Company's non-elective contribution, if applicable, and allocations of Plan earnings, and charged with withdrawals and allocations of the losses and expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

***Plan Expenses***

Distribution and loan fees are charged directly to the requesting participant's account. Substantially all other administrative expenses are paid by the Company.

## **Note 2. Summary of Accounting Policies**

### ***Basis of Accounting***

The financial statements of the Plan are prepared using the accrual basis of accounting.

### ***Benefits Paid to Participants***

Benefits paid to participants are recorded when paid.

### ***Participants Notes Receivable***

Participant notes receivable are recorded at their unpaid principal balances plus any accrued interest. Participant notes receivable are written off when deemed uncollectible.

### ***Investment Valuation and Income Recognition***

The Plan's investments are stated at fair value except as noted below. The fully benefit-responsive unallocated contract is valued at contract value. Contract value represents deposits made to the contract, plus earnings at guaranteed crediting rates, less withdrawals and fees.

The pooled separate accounts are valued at fair value, which is based on the fair value of the underlying mutual funds or stocks and fixed income securities. The fair value of the underlying securities is based on quoted prices of similar assets. All other investments are valued based on quoted market prices reported in active markets. See Note 4 for additional information.

### ***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amount of net assets available for benefits at the date of the financial statements and the changes in net assets available for benefits during the reporting period and, when applicable, disclosures of contingent assets and liabilities at the date of the financial statements. Actual results may differ from those estimates.

### ***Refundable Contributions Due to Participants***

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the 2023 excess contributions to the applicable participants prior to April 15, 2024.

### ***Subsequent Events***

The Plan has evaluated subsequent events through October 11, 2025, the date the financial statements were available for issuance. All subsequent events requiring recognition or disclosure have been incorporated in these financial statements.

### **Note 3. Information Certified by the Plan's Trustees**

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Empower Annuity Insurance Company, a qualified institution, has certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023
- Investment income and interest income from notes receivable from participants as shown in the statements of changes in net assets available for benefits for the year ended December 31, 2024
- Investment information and notes receivable from participants included in the accompanying schedule of assets (held at end of year) as of December 31, 2024

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

### **Note 4. Fair Value Measurements**

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques need to maximize the use of observable inputs and minimize the use of unobservable inputs. Valuation techniques used to measure fair value are defined as follows:

- Level 1** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2** Inputs to the valuation methodology include: (a) quoted prices for similar assets or liabilities in active markets; (b) quoted prices for identical or similar assets or liabilities in inactive markets; (c) inputs other than quoted prices that are observable for the asset or liability; and (d) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024:

*Mutual funds and money market funds:* Valued at unadjusted quoted market prices in an active market.

*Pooled separate accounts:* The fair value of the pooled separate accounts is determined by the fair value of the underlying mutual funds or stocks and fixed income securities. The fair value of the underlying securities is based on quoted prices of similar assets.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**Note 5. Investment Contract**

The Plan offers a fully benefit-responsive investment contract with Empower Annuity Insurance Company (EAIC) as an investment option to plan participants. EAIC maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Interest is credited on contract balances using a single portfolio rate approach. Under this methodology, a single interest rate is applied to all contributions made to the product, regardless of the timing of those contributions. Interest crediting rates are reviewed on a semiannual basis for resetting but may not be less than 1.5%. When establishing interest crediting rates for this product, EAIC considers many factors, including current economic and market conditions, the general interest rate environment, and both the expected and actual experience of a reference portfolio within the issuer's general account.

Generally, there are no events that could limit the ability of the Plan to transact at contract value paid within 90 days or, in rare circumstances, contract value paid overtime. There are no events that allow the issuer to terminate the contract and that require the plan sponsor to settle an amount different than contract value paid either within 90 days or over time.

As described in Note 2, because the contract is fully benefit responsive, contract value is the relevant measurement attribute for that portion of the net assets attributable to the investment contract. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investments at contract value.

**Note 6. Related Party Transactions**

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association or relatives of such persons.

During the year ended December 31, 2024, Empower was the trustee and record-keeper as defined by the Plan, and therefore, these transactions qualify as party-in-interest transactions. Fees paid to Empower by the Plan for management services amounted to \$133,116 for the year ended December 31, 2024. Services rendered by the investment advisor and auditor also qualify as party-in-interest transactions. Total administrative expenses amounted to \$176,039 for the year ended December 31, 2024.

The Company provides certain administrative services at no cost to the Plan.

**Note 7. Plan Termination**

Although it has not expressed any intention to do so, the Company has the right to terminate the Plan subject to the provisions of ERISA. If the Plan is terminated, the amount credited to the account of each participant will be fully vested.

**Note 8. Tax Status**

The Plan is based on a prototype plan developed by Empower which received a favorable opinion letter dated September 16, 2022, from the Internal Revenue Service (IRS) stating that the prototype plan constitutes a qualified plan under Section 401(a) of the IRC. The Company believes the Plan, as adopted and amended, is operating within the guidelines of the IRC and continues to be tax exempt. Accordingly, no provision for federal income taxes has been provided in the accompanying financial statements.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the organization has taken an uncertain position that more-likely-than-not would not be sustained upon examination by the DOL or IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examination for years prior to 2021.

**Note 9. Risks and Uncertainties**

The Plan invests in various mutual funds. These investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain securities and the level of uncertainty related to changes in the value of these securities, it is at least reasonably possible that changes in market conditions in the near term could materially affect participants' account balances and the value of investments reported in the financial statements.
