**INDEPENDENT AUDITOR'S REPORT**

To the Plan Administrator of  
Little City Foundation 401(K) Plan:

***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the accompanying financial statements of the Little City Foundation 401(K) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2023, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

***Opinion***

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. ***Responsibilities of Management for the Financial Statements***

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

NOTES TO FINANCIAL STATEMENTS  
DECEMBER 31, 2024 AND 2023

(1) DESCRIPTION OF PLAN:

The following description of the Little City Foundation 401(K) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

The financial statements were available to be issued on October 13, 2025 with subsequent events being evaluated through this date.

General -

The Plan is a defined contribution plan covering all full-time employees of Little City Foundation (the Foundation) who have completed four months of service and are not:

- Leased employees;
- Non-resident aliens;
- Highly compensated employees.

The Plan is subject to the provision of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. Participants who do not have at least 1,000 hours of service during such Plan year, are under the age of 21, have not completed a year of service or, are not employed on the last working day of a Plan year, are generally not eligible for an allocation of Foundation contributions for such year.

The Plan was restated effective July 1, 2024 and changed third-party administrators. There were no significant changes to the provisions of the Plan from this restatement.

Contributions -

A participant may elect to contribute a portion of his or her pretax or after-tax compensation for the Plan year, as defined in the Plan, not to exceed the Internal Revenue Code (the Code) section 415(d) limit as adjusted in any Plan year. All participants who were eligible to make salary deferral contributions under the Plan, and who have attained age 50 before the close of the Plan year, were eligible for catch-up contributions of up to \$7,500 during 2024. Some or all of a Participant's contribution may be designated as a Roth Deferral Contribution. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. In addition, the Foundation matches 50 percent of participant contributions up to 6 percent of participant contributed compensation.

Participants direct the investment of their contributions into various investment options offered by the Plan. Participants may change their investment options daily. Contributions are subject to certain limitations.

Participant Accounts -

Each participant's account is credited with the participant's elective and, if applicable, rollover contributions and allocations of a) the Foundation's matching and profit-sharing contributions, and b) Plan earnings and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

(1) DESCRIPTION OF PLAN: (Continued)

Participant Loans -

Participants may borrow a minimum of \$1,000 from their fund accounts, up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance net of loans outstanding. The Plan allows participants to have two outstanding loans. Loan terms range from one to five years but may be longer if used for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at rates that range from 4.25 percent to 9.50 percent, which are commensurate with local prevailing rates at loan origination, as determined by the Plan Administrator. Principal and interest are paid ratably through bi-weekly payroll deductions.

Vesting -

Participants are immediately fully vested in their salary deferral contributions, plus actual earnings thereon and in all other accounts, if the participant dies, becomes disabled, or retires while an employee of the Foundation. Participants are also immediately fully vested in their employer matching contribution portion of accounts upon meeting the eligibility requirements of the Plan.

Payment of Benefits -

On termination of service, a participant may elect to receive 1) a lump sum amount equal to the value of the participant's vested interest in his or her account, or 2) partial withdrawals or installments, but only with respect to lifetime minimum required distributions over a period of not more than their assumed life expectancy. If the participant's vested account balance does not exceed \$1,000, payment is made at time of termination in a lump sum distribution. Except for hardship, withdrawals are not permitted prior to a participant's death, disability, reaching the age of 59 1/2, or termination of employment. Participants are also required to take minimum distributions at the age of 72.

(2) SUMMARY OF ACCOUNTING POLICIES:

Basis of Accounting -

The financial statements of the Plan are prepared under the accrual method of accounting.

Accounting Policies -

The Plan follows generally accepted accounting principles as established by the Financial Accounting Standards Board (FASB) to ensure consistent reporting of financial condition and results of operations.

Estimates -

The preparation of financial statements in conformity with generally accepted accounting principles requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Payment of Benefits -

Benefits are recorded when paid.

(2) SUMMARY OF ACCOUNTING POLICIES: (Continued)

Investment Valuation and Income -

Appreciation or depreciation in the market value of an investment held both at the beginning and end of the year is equal to the difference between the market value at the beginning and end of the year. Appreciation or depreciation in the market value of an investment acquired during the year and held at the end of the year is equal to the difference between the cost and the market value of the investment at the end of the year.

The Plan's investment committee determines the Plan's valuation policies, utilizing information provided by the Investment Advisor and Trustee.

Gain or loss recognized from the disposition of an investment held at the beginning of the year is equal to the difference between the market value of the disposed asset at the beginning of the year and the proceeds from disposition. Gain or loss realized from the disposition of an investment acquired during the year is equal to the difference between the cost and the proceeds from disposition.

Notes Receivable from Participants -

Notes receivable from participants are measured at their unpaid principal balance plus any accrued, but unpaid interest. Defaulted participant loans are treated as distributions based upon the terms of the Plan document.

Administrative Expenses -

Administration expenses of the Plan are paid by the Plan as provided in the Plan document. Certain of the Plan's administrative expenses are paid by the Foundation on behalf of the Plan, without reimbursement.

(3) FAIR VALUE MEASUREMENTS:

The Accounting Standards Codification establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1:

Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

(3) FAIR VALUE MEASUREMENTS:

Level 2:

Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3:

Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Pooled Separate Accounts: Investments in shares of pooled separate accounts held with an insurance company are stated at estimated fair market value and are valued by the insurance company based on the net asset value shares held by the Plan at year end. The net asset value is determined by the insurance company based on the market value of the underlying investments and deducting participant withdrawals and administrative expenses.

Registered Investment Companies: Valued at the daily closing price as reported by the fund. Shares in registered investment companies held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Insurance Company General Accounts: The general account is a deposit administration account through an insurance company that is non fully benefit-responsive. Interest is credited to the general account using a current rate. The general account is reported at the estimated fair value representing contributions and transfers made to the account, plus earnings, less participant withdrawals and transfer and administrative expenses.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

(4) INCOME TAXES:

Effective July 1, 2024, The Plan has adopted Standard Retirement Services, Inc Non-Standardized Defined Contribution Pre-Approved Plan. The Plan has received a favorable opinion from the Internal Revenue Service (IRS), who stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. Through June 30, 2024, the Plan adopted the Non-Standardized Mutual of America 401(K) Profit-Sharing Plan, which had received a favorable opinion letter from the IRS.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2021.

(5) PARTY-IN-INTEREST TRANSACTIONS:

Certain Plan investments are managed and advised by Reliance Trust Company or Mutual of America (through June 30, 2024). Reliance Trust Company and Mutual of America are the Trustees as defined by the Plan and therefore, these investments held by the Plan and issued by these entities are party-in-interest transactions. As of December 31, 2024 and 2023, \$545,246 and \$15,147,381, respectively, of the Plan's investments are pooled separate accounts, an insurance company general account, or non-interest bearing cash account offered by Reliance Trust Company, Mutual of America or one of their subsidiaries.

Participants covered under the Plan are considered to be parties-in-interest. Participant loans in the amounts of 428,904 and \$411,201 at December 31, 2024 and 2023, respectively, are considered to be party-in-interest investments.

Certain employees of the Foundation provide administrative services to the Plan and are not reimbursed for their services from the Plan.

(6) CERTIFIED INVESTMENTS:

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation/depreciation in fair value of investments, interest and dividends for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Mutual of America (through June 30, 2024) and Reliance Trust Company (the trustees of the Plan).

(7) PLAN TERMINATION:

Although it has not expressed any intent to do so, the Foundation has the right under the Plan to terminate the Plan subject to the provisions set forth in ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

(8) RISKS AND UNCERTAINTIES:

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
