### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the accompanying financial statements of Brailsford & Dunlavey, Inc. 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. ### **Notes to Financial Statements**

#### **Note 1. Plan Description**

The following description of Brailsford & Dunlavey, Inc. 401(k) Plan (“Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

##### **General**

The Plan is a defined contribution plan covering eligible employees of Brailsford & Dunlavey, Inc. and Centers, LLC (collectively, the “Company” or “Plan Sponsor”) who are age 21 or older. The Plan excludes leased employees, seasonal employees, part-time employees who are regularly scheduled to work less than 20 hours per week and residents of Puerto Rico. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Investment Committee is responsible for the oversight of the Plan, determining the appropriateness of the Plan’s investment offerings, and monitoring investment performance.

##### **Eligibility**

Employees of the Company are eligible to contribute employee deferrals and receive discretionary matching contributions in the Plan after completing 83.33 hours of service in a month. Employees of Brailsford & Dunlavey, Inc. are eligible to receive Company nonelective safe harbor and discretionary profit sharing contributions after completing 1,000 hours of service within one year of employment. Employees of Centers, LLC are eligible to receive Company nonelective safe harbor and discretionary profit sharing contributions after completing 83.33 hours of service in a month. The entry date for the participants for all contributions is the beginning of the first day of the month coinciding with or following the completion of the eligibility requirements.

##### **Contributions**

The Plan includes a salary deferral arrangement allowed under Section 401(k) of the Internal Revenue Code (IRC). Eligible participants are permitted to elect to have a percentage of their eligible compensation contributed as pre-tax 401(k) or Roth contributions to the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions.

For the year ended December 31, 2024, the Company made nonelective safe harbor contributions and discretionary profit sharing contributions to the Plan. There were no matching contributions made for the year ended December 31, 2024. For the year ended December 31, 2024, the Company made nonelective safe harbor contributions equal to 3% of a participant’s eligible compensation, limited by section 415 compensation limitations, totaling \$843,821. For the year ended December 31, 2024, the Company elected to make profit sharing contributions totaling \$1,107,009. For employees of Centers, LLC, the profit sharing contribution was equal to 5% of eligible compensation. For employees of Brailsford & Dunlavey, Inc., the profit sharing contribution was allocated on a pro rata basis based upon the eligible employees’ compensation.

## Notes to Financial Statements

Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans or conduit Internal Retirement Account (IRA). Participants direct the investment of contributions into various investment options offered by the Plan. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

### Participant Accounts

Each participant's account is credited with the participant's contributions, the Company's nonelective safe harbor, discretionary matching, and discretionary profit sharing contributions, if applicable, and allocation of Plan earnings and losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balances, or participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### Forfeited Accounts

Forfeitures of nonvested accounts are used to reduce administrative expenses or future Company contributions. Forfeited nonvested accounts as of December 31, 2024 and 2023, totaled \$84,569 and \$4,234, respectively. For the year ended December 31, 2024, forfeitures totaling \$2,343 and \$5,398 were used to reduce Company contributions and pay administrative expenses, respectively.

### Vesting

Participants are fully vested to the extent of their account balances in their employee deferrals and Company nonelective safe harbor contributions. Participants who are employees of Brailsford and Dunlavey are fully vested in the Company discretionary matching and profit sharing contribution when six years of qualifying service are attained. Participants who are employees of Centers, LLC are immediately vested in Company discretionary profit sharing contributions and are fully vested in Company discretionary matching contributions when six years of qualifying service are attained. Notwithstanding the above, a participant is fully vested upon reaching normal retirement age, death, or permanent disability.

### Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum amount equal to the lesser of 50% of their vested account balance or \$50,000, reduced by the amount of the participant's highest outstanding loan balance during the previous one-year period. Principal and interest are re-paid ratably through payroll deductions. The notes are secured by the balance in the participant's account and bear interest at a rate of prime plus 1%.

## Notes to Financial Statements

### Payment of Benefits

Upon termination of service, death, disability, or retirement, a participant may receive the value of the vested interest in his or her account in the form of a lump sum distribution. The Plan allows for in-service distributions once a participant reaches age 59½ and permits hardship distributions subject to Plan provisions. If a participant terminates employment and the participant's account balance does not exceed \$1,000, the trustee will authorize the benefit payment without the participant's consent. If the balance of the terminated participant's account is between \$1,000 and \$5,000, the Plan Sponsor may authorize that the benefit payment be rolled into an IRA in the participant's name.

## Note 2. Summary of Accounting Policies

### Basis of Accounting

The financial statements of the Plan are prepared on the accrual method of accounting.

### Investment Valuation and Income Recognition

Investments are reported at fair value, except for the fully benefit-responsive investment contract which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisors, trustees, and insurance company. See Note 3 for discussion of fair value measurement.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned on an accrual basis. Dividends are recorded at the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the loan is deemed to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

### Payment of Benefits

Benefits are recorded when paid. At December 31, 2024 and 2023, there were no benefit claims filed by terminated employees that had not yet been paid.

## Notes to Financial Statements

### Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants and benefit payments are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

### Note 3. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

## Notes to Financial Statements

*Collective Trust Funds and Pooled Separate Accounts:* Valued at the fair value of the fund's share of the underlying investments. The NAV is based on the fair value of the underlying investments, which are traded at publicly quoted amounts.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another.

Plan management evaluates the significance of transfers between levels based upon the nature of the financial instrument and size of the transfer relative to total net assets available for benefits. For the year ended December 31, 2024, there were no significant transfers in or out of different levels.

## Notes to Financial Statements

### **Note 4. Investment Contract**

In 2018, the Plan entered into a fully benefit-responsive investment contract with Principal Life Insurance Company. Principal Life Insurance Company maintains the contributions in a guaranteed fund. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 1%. The crediting rate is reviewed on a semi-annual basis for resetting. The guaranteed investment contract does not permit the custodian to terminate the agreement prior to the scheduled maturity date.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Principal Life Insurance Company, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses.

Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments. To terminate the contract, the Plan must provide at least 12 months' notice.

### **Note 5. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100 percent vested in their entire account balances.

### **Note 6. Information Certified by Principal Life Insurance Company and Principal Trust Company**

Certain information disclosed in the accompanying financial statements and supplemental schedule, including investments held at December 31, 2024 and 2023, net appreciation in fair value of the investments, interest, and dividend income for the year ended December 31, 2024, was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Principal Life Insurance Company and Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company, the trustees and custodians of the Plan.

## Notes to Financial Statements

### Note 7. Tax Status

The Plan has adopted a non-standardized pre-approved plan sponsored by Retirement Planners and Administrators, Inc. The plan provider has received an opinion letter from the Internal Revenue Service dated June 30, 2020, as to the pre-approved plan's qualified status. The preapproved plan opinion letter has been relied upon by the Plan. The Plan has been amended since the pre-approved plan received the opinion letter. The Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the Internal Revenue Code.

In accordance with accounting principles generally accepted in the United States of America, Plan management is required to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### Note 8. Related Party Transactions and Party-in-Interest Transactions

Certain plan investments were managed by Principal Life Insurance Company, Principal Trust Company, Ameriprise Financial Services and Wilshire Associates Inc. for the year ended December 31, 2024. Principal Life Insurance Company and Principal Trust Company, the trustees and custodians, and Ameriprise Financial Services and Wilshire Associates, Inc. are fiduciaries as defined by the Plan, and therefore, these investment transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of the investments. These investment advisors may receive revenue from pooled separate accounts, mutual funds, and collective trust service providers for services provided to the funds. This revenue is used to offset certain amounts owed to the service providers for its administrative services to the Plan.

If the payments received by the trustees, custodians, and investment advisors from such investments exceed the amount owed under the agreement, they shall remit the excess to the Plan's trust on a quarterly basis. Such amounts may be applied to pay Plan administrative expenses. The Plan or Plan Sponsor may make payments to the investment advisors for expenses not covered by revenue sharing.

Retirement Planners and Administrators, Inc. provides recordkeeping services to the Plan. Therefore, amounts paid to this party also qualify as party-in-interest transactions. These fees paid are included as a component of administrative expenses on the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024.

## Notes to Financial Statements

### **Note 9. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

### **Note 10. Subsequent Events**

In preparing these financial statements, the Plan has evaluated events and transactions for potential recognition or disclosure through October 13, 2025, the date the financial statements were available to be issued.

Effective January 1, 2025, the Plan was amended and restated to adopt a pre-approved plan document sponsored by CCH Incorporated, DBA ftwilliam.com.
