### **Basis for Opinion**

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

NOTES TO FINANCIAL STATEMENTS

For the Years Ended December 31, 2024 and 2023

NOTE A – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Presentation – The accompanying financial statements of Midwest Surgical Hospital, LLC 401(k) Plan (the Plan) are prepared under the accrual method of accounting and in conformity with United States generally accepted accounting principles. The Plan Sponsor is Midwest Surgical Hospital, LLC (the Company).

General – The Plan was originated on May 1, 2013, and is a defined benefit contribution plan covering substantially all employees, other than union, nonresident aliens, and leased employees, of Midwest Surgical Hospital, LLC (the Employer). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan administrator is responsible for oversight of the Plan, determines the appropriateness of the Plan's investment offerings, and monitors investment performance. Some administrative expenses related to the Plan are paid by the Company. The Company has no reversionary interest in the Plan.

Investment Valuation and Income Recognition – Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Administrator determines the Plan's valuation policies utilizing information provided by the custodian and investment advisors.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants – Notes receivable from participants are measured at the unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

Estimates – The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Payment of Benefits – Benefits are recorded when paid.

Expenses – Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net (depreciation) appreciation of fair value of investments.

NOTE B – DESCRIPTION OF PLAN

The following description of the Plan provides only general information. Participants should refer to the Plan Agreement for a more comprehensive description of the Plan's provisions.

Eligibility – Under the terms of the Plan, an employee will be eligible to participate in the plan once they have completed six consecutive months of service and are 21 years of age or older.

Contributions and Participant Accounts - Each year participants may elect to make salary reduction 401(k) contributions of up to 100% of their compensation, as defined, subject to federal deferral limits. Each participant may also elect to make Roth contributions of up to 100% of their compensation, as defined, subject to federal deferral limits. Employees over the age of 50, may make "catch-up" contributions subject to federal annual limits. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). Participant and Company 401(k) contributions are allocated within each participant's account to investment options based upon the participant's current investment allocation elections. Annual contributions are subject to limitations set by the Internal Revenue Service.

The Employer may make discretionary matching contributions on behalf of contributing participants each year. For the years ended December 31, 2024 and 2023, matching contributions equaled 100% of employee contributions up to 5% of eligible compensation. Nonelective contributions may be contributed at the option of the Employer. No such nonelective contributions were made to the Plan for 2024 or 2023.

Forfeitures – Forfeitures are amounts that come from terminated employees (participants) share of employer matching 401(k) contributions that are not vested. Forfeitures can be used to offset 401(k) plan expenses and employer matching contributions. The forfeiture balance was \$39,605 and \$28,602 as of December 31, 2024 and 2023, respectively. For the years ended December 31, 2024 and 2023, forfeited amounts used to reduce Employer contributions totaled \$4,163 and \$2,262, respectively.

Vesting – Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Employer contributions portion of their accounts is based on years of continuous service and are vested using a two-year cliff schedule. Separate rules apply in the event of disability or death of a participant.

Notes Receivable from Participants – Participants may borrow from their fund accounts. The minimum amount is \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and the loan interest is set at 2% above the prime rate, as defined. Principal and interest is paid ratably through regular payroll deductions. Participants may have no more than three loans outstanding at any given time.

NOTE B – DESCRIPTION OF PLAN – Continued

**Benefits** – Upon the participant’s retirement or termination of service, the Company shall value and distribute the participant’s account in accordance with the Plan document and the Internal Revenue Code. Separate provisions apply in the event of death or disability of the participant. Payments are to be made in a lump sum. Withdrawals prior to termination of employment or retirement are prohibited unless elected by the participant under the following conditions: attaining age 59 ½, establishing permanent and total disability, demonstrating financial hardship, or otherwise allowed by the applicable laws and regulations.

NOTE C – INVESTMENTS

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and the supplemental schedules, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends for the years then ended, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Charles Schwab Trust Bank (the custodian).

NOTE D – FAIR VALUE MEASUREMENTS

FASB Accounting Standards Codification No. 820 (ASC 820) *Fair Value Measurements and Disclosures* (formerly Statement No. 157, *Fair Value Measurement*), establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC No. 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets.

Level 2 Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

NOTE D – FAIR VALUE MEASUREMENTS – Continued

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques that are used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Registered investment company:* Closed-end mutual funds and ETFs are valued at the closing price reported in the active market in which the individual funds are traded. Open-end mutual funds are valued at the daily closing price. Open-end mutual funds are required to report their daily net asset value (NAV) and to transact at that price.

*Money market fund:* Carrying value approximates fair value.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE E – RELATED PARTY TRANSACTIONS**

A party-in-interest, as defined by Section 3(14) of ERISA, includes, among others, fiduciaries or employees of the Plan, any person who provides services to the Plan, or an employer whose employees are covered by the Plan. Accordingly, loans to participants are considered party-in-interest transactions. Fees incurred by the Plan to the trustee for investment and trust services amounted to \$57,413 and \$47,887 for the years ended December 31, 2024 and 2023, respectively. There were no fees payable at December 31, 2024 and 2023, respectively.

**NOTE F – PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company retains the right under the Plan to discontinue its matching contributions at any time or to terminate the Plan subject to the provisions set forth in ERISA. In the event of Plan termination, participants will become fully vested in their accounts and the assets will be distributed as determined by the Plan.

**NOTE G – TAX STATUS**

The Plan adopted a non-standardized defined contribution plan with CODA that has received an opinion letter dated June 30, 2020, in which the Internal Revenue Service stated that the non-standardized plan was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

GAAP requires plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would be sustained upon examination by the applicable authorities. The plan administrator has analyzed the tax positions taken by the plan, and has concluded that as of December 31, 2024, there are no uncertain tax positions taken or expected to be taken that require recognition of a liability (or asset) or disclosure in the financial statements. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE H – RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**NOTE I – SUBSEQUENT EVENTS**

Subsequent events were evaluated through August 1, 2025, which is the date the financial statements were available to be issued.
