Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

(1) Description of Plan

The following description of the Section 403(b) Plan of the John D. and Catherine T. MacArthur Foundation (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the plan provisions. The Plan is a defined contribution plan, commonly referred to as a 403(b) plan, covering participating employees. Plan participants are employees who have satisfied the Plan's eligibility requirements.

Eligible participants may make salary deferrals to the Plan, and any salary deferrals will be invested in accordance with the Plan's investment policies. Qualifications to become a participant under the Plan are as follows:

- Must be an eligible employee (expected to work at least 20 hours per week)
- Satisfy any allocation conditions required under the Plan

An eligible employee may begin to make salary deferrals into the Plan as soon as administratively possible after date of hire. There are no minimum age or service requirements to make salary deferrals. Effective July 17, 2023, the Plan has an Automatic Deferral Election of 3%, increasing by 1% each Plan Year until a cap of 6% is met. A Participant will be deemed to have entered into a salary deferral election for each payroll period unless the Participant completes a Salary Deferral Election to opt out.

The Employer is not authorized to make Matching Contributions under the Plan.

The Plan does not permit Participants to take a loan from the Plan. To access Plan assets, Participants must be eligible to receive a distribution from the Plan. The Plan does not accept rollovers from another qualified retirement plan or an IRA.

The Plan allows in-service withdrawals upon attainment of age 59 ½.

The Plan provides for distributions of the vested values of the participants' accounts upon termination of employment, as defined in the Plan. The form, valuation, and timing of such distributions are specified in the Plan. Participants are vested immediately in their contributions plus actual earnings thereon. Terminated participants with vested account balances of \$5,000 or less will be eligible to receive a distribution of the entire vested account balance as soon as administratively feasible. Terminated participants with vested account balances in excess of \$5,000 may leave their accounts invested in the Plan.

(2) Summary of Significant Accounting Policies

(a) *Basis of Accounting*

The accompanying financial statements of the Plan have been prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America.

(b) *Contributions*

Employee contributions represent pre-tax and post-tax monies. No Special Contributions are permitted.

Employee contributions are remitted on a semi-monthly basis to the Plan and are invested based upon direction by the employee.

(c) *Investment Valuation and Income Recognition*

Investments are stated at fair value. Fair value is defined as the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date on the Plan's principal or most advantageous market for the asset.

The Plan presents, in the statements of changes in net assets available for benefits, the net appreciation or (depreciation) in the fair value of its investments which consists of realized gains or (losses) and unrealized appreciation (depreciation) on those investments. Investment transactions are accounted for on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

(d) *Risks and Uncertainties*

The Plan provides for various investments that, in general, are exposed to various risks such as interest rate, credit, liquidity, global events, and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

(e) *Administrative Expenses*

Most administrative fees of the Plan are paid directly by the Foundation.

(f) *Use of Estimates in the Preparation of Financial Statements*

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities, if any, at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

(g) *Payment of Benefits*

Benefits are recorded when paid.

(3) Certified Investments

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation (depreciation) in fair value of investments, interest, and dividends for the years ended December 31, 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Vanguard Fiduciary Trust Company (the custodian of the Plan).

(4) Fair Value Measurements of Investments

“*Fair Value Measurements and Disclosures*” (ASC Topic 820) establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to observable unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurement) and the lowest priority to unobservable inputs (Level 3 measurement). The three levels of inputs within the fair value hierarchy are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets.

- Level 2 Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets, and inputs are observable for the asset or liability, either directly or indirectly, for substantially the full term of the financial instrument.
- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

The following tables set forth by level, within the fair value hierarchy, the Plan's investment assets measured at fair value as of December 31, 2024, and 2023, respectively.

The fair value of investments in registered investment companies is determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

(5) Tax Status

The Internal Revenue Services issued an advisory letter dated February 1, 2018, indicating that the volume submitter plan adopted by the Plan Sponsor as then designed was in compliance with the applicable requirements of the Internal Revenue Code (IRC). Although the Plan has been amended from the original volume submitter document Plan management believes that the Plan is currently being operated in accordance with the IRC.

U.S. GAAP requires management of the Plan to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan and has concluded that, as of December 31, 2024, and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress for any tax periods. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

(6) Termination of Plan

Although it has not expressed intent to do so, the Board of Directors of the Foundation has the right under the Plan to amend or terminate the Plan, subject to the provisions of the Employee Retirement Income Security Act of 1974 or discontinue its contributions to the Plan at any time. However, in the event of plan termination or permanent discontinuance of contributions, participants will become fully vested in their accounts and will become entitled to a distribution from the Plan.

(7) Party-in-interest Transactions

Parties-in-interest are defined under Department of Labor regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Certain administrative functions are performed by officers or employees of the Foundation. No such officer or employee receives compensation from the Plan. All Plan transactions are party-in-interest transactions.

(7) Party-in-interest Transactions (continued)

These include shares of registered investment companies managed by The Vanguard Group, Inc. Investment earnings are net of fees paid for investment management services.
