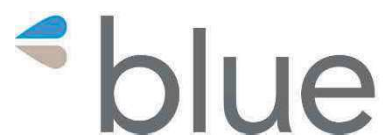

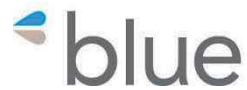

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

### 1. DESCRIPTION OF THE PLAN

Effective January 1, 2022, Fastline Publications, Inc. 401(k) Plan changed its name to Fastline Marketing Group 401(k) Plan. The following brief description of the Fastline Marketing Group 401(k) Plan (the Plan), is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

#### General

The Plan is a profit sharing plan established by Fastline Marketing Group, LLC (the Company), which includes salary deferral features of Section 401(k) of the Internal Revenue Code. The Plan is intended to meet the requirements of a qualified plan under Section 401(a) of the Internal Revenue Code. The Plan provides for retirement benefits and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). All employees may elect to participate in the Plan immediately upon attaining the age of 20 ½ and completing three months of service.

#### Contributions

Participants are permitted to make salary deferral contributions up to the lesser of 100 percent of their compensation or Internal Revenue Service (IRS) deferral limits. Beginning January 1, 2022, participants are automatically enrolled to defer two percent of eligible compensation after satisfying the eligibility requirements. Employee rollover contributions are also permitted. The Company may make discretionary matching contributions. For the year ended December 31, 2024, the Company made matching contributions equal to the lesser of 50 percent of the salary deferral amount or three percent of the employee's eligible compensation. Additional profit-sharing amounts may be contributed at the discretion of the Company.

#### Participant Accounts

Each participant's account is credited with the participant's contribution and allocation of: (a) the Company's contribution, and (b) Plan earnings. Allocations are based on the participant's earnings or account balances as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants can direct investments in their account into several investment options and are allowed to change investment selections on a daily basis.

### Payment of Benefits

Upon termination of service due to death, disability, retirement or other reasons, a participant will receive a lump sum payment equal to the participant's vested account balance.

Employees are entitled to receive their entire balance credited to their account upon reaching normal retirement age. Upon earlier termination, employees may receive their contributions to the Plan and investment income thereon plus the vested portion of Company contributions and income thereon. The Plan permits hardship withdrawals from participant contributions, vested portion of Company matching contributions and actual earnings thereon. Participants who are at least 59 ½ may also withdraw their vested Company contribution account balance, participant contributions, and any earnings.

### Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company contribution portion of their accounts is based on years of continuous service. Company contributions are fully vested at the end of five years with partial vesting as follows:

### Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to \$50,000 or 50 percent of their vested account balance, whichever is less. The loan term may not exceed five years unless such loan is for the purpose of the participant's primary residence. The loans are secured by the balance in the participant's account and bear interest at fixed rates that range from 3.25 percent to 5.50 percent, which at the time of the note are based on the prime rate. Principal and interest are paid ratably through payroll deductions.

### Forfeited Accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$3,423 and \$11,450, respectively. These accounts may first be applied to administration expenses of the Plan and the remaining amount may be used to reduce future Company contributions. During 2024, \$9,098 was used to pay administrative expenses.

### 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

#### Basis of Accounting

The accompanying financial statements of the Plan are prepared on the modified cash basis of accounting. As such, contributions are recorded when received and benefit payments, corrective distributions and expenses are recorded when paid. The modified cash basis differs from the cash basis in that investments are recorded at fair value and notes receivable from participants are recognized.

Although the modified cash basis of accounting represents a departure from accounting principles generally accepted in the United States of America, it is an allowable method of accounting for employee benefit plans under the reporting requirements of ERISA.

#### Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest are received through payroll deductions and the notes are collateralized by the participants' account balances. Delinquent notes receivable are recorded as a distribution based upon the terms of the plan document.

#### Use of Estimates

The preparation of financial statements in conformity with the modified cash basis of accounting requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results may differ from those estimates.

#### Investment Valuation and Income Recognition

The Plan's investments are held in mutual funds and reported at fair value. Investments in mutual funds are valued using quoted market prices in the active market.

Purchases and sales are recorded on a settlement date basis. Dividends and interest are recorded when received. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### Payment of Benefits

Benefits are recorded when paid.

#### Risks and Uncertainties

The Plan invests in various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with these investment securities, it is at least reasonably possible that changes in the values of the investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

#### Plan Tax Status

The Plan is based on a Prototype Non-Standardized Profit Sharing Plan with Cash or Deferred Arrangement which has obtained its latest determination letter dated June 30, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code and therefore exempt from federal income taxes. The plan administrator has not separately applied for a determination letter from the Internal Revenue Service. However, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and that the Plan was qualified, and the related trust was tax-exempt as of the financial statement date.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### Expenses

Certain expenses incurred maintaining the Plan are paid directly by the Company are excluded from the financial statements. Investment-related expenses are included in net depreciation of fair value of investments.

#### Subsequent Events

The Plan has evaluated events or transactions occurring subsequent to the statement of net assets available for benefits date for recognition and disclosure in the accompanying financial statements through the date the financial statements were available to be issued, which is October 10, 2025.

### 3. INFORMATION CERTIFIED BY THE PLAN'S CUSTODIAN

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Ascensus Trust Company, the custodian of the Plan, has certified to the completeness and accuracy of all investments and notes receivable from participants reflected in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the Schedule of Assets (Held at End of Year) as of December 31, 2024, and the related investment activity reflected in the statement of changes in net assets available for benefits for the year ended December 31, 2024.

### 4. FAIR VALUE MEASUREMENT

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy are described as follows:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets in active markets that the Plan has the ability to access.
- Level 2: Inputs to the valuation methodology include quoted prices for similar assets in active markets; quoted prices for identical or similar assets in inactive markets; inputs other than quoted prices that are observable for the asset; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset.
- Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

- *Mutual funds*: Valued at the daily closing price as reported by the fund. Mutual funds are held by the Plan and are open-end funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The funds held by the Plan are deemed to be actively traded.

### 5. PARTY-IN-INTEREST TRANSACTIONS

At December 31, 2024 and 2023, Ascensus, Inc., serves as the Plan's third party administrator. Fastline Marketing Group serves as the Plan's sponsor. Blue & Co., LLC serves as the Plan's auditor. Trustee fees are also paid to Ascensus Trust Company. Morgan Stanley serves as the Plan's investment consultant and advisor. Transactions with these parties qualify as party-in-interest transactions. The Company provides certain accounting, recordkeeping, and administrative services to the Plan, for which it is not compensated.

### 6. PLAN TERMINATION

Although the Company has not expressed any intent to discontinue participation in the Plan, it has the right to terminate the Plan. All accounts of the participants shall vest and become nonforfeitable in the event the Plan is terminated, partially terminated, or contributions by the Company are discontinued. Upon termination, the Company shall direct the custodian regarding distribution of accounts to participants or their beneficiaries.
