No new accounting policies were adopted and the application of existing policies was not changed during 2024. We noted no transactions entered into by the Plan during the year for which there is a lack of authoritative guidance or consensus. All significant transactions have been recognized in the financial statements in the proper period.

Accounting estimates are an integral part of the financial statements prepared by management and are based on management's knowledge and experience about past and current events and assumptions about future events. Certain accounting estimates are particularly sensitive because of their significance to the financial statements and because of the possibility that future events affecting them may differ significantly from those expected. During 2024, there were no significant estimates effecting the financial statements.

The financial statement disclosures are neutral, consistent, and clear.

Form 5500 Procedures

We are required to obtain and read a substantially complete draft of Form 5500 prior to dating our auditor's report. The purpose of this procedure is to identify any material inconsistencies between the draft Form 5500 and the Plan's financial statements. We identified no material inconsistencies in performing and completing our audit.

Difficulties Encountered in Performing the Audit

We encountered no significant difficulties in dealing with management in performing and completing our audit.



Corrected and Uncorrected Misstatements

Professional standards require us to accumulate all misstatements identified during the audit, other than those that are clearly trivial, and communicate them to the appropriate level of management. There were no misstatements detected as a result of our audit procedures.

Disagreements with Management

For purposes of this letter, a disagreement with management is a disagreement on a financial accounting, reporting, or auditing matter, whether or not resolved to our satisfaction, that could be significant to the financial statements or the auditor's report. We are pleased to report that no such disagreements arose during the course of our audit.

Management Representations

We have requested certain representations from management that are included in the management representation letter dated October 10, 2025.

Management Consultations with Other Independent Accountants

In some cases, management may decide to consult with other accountants about auditing and accounting matters, similar to obtaining a "second opinion" on certain situations. If a consultation involves application of an accounting principle to the Plan's financial statements or a determination of the type of auditor's opinion that may be expressed on those statements, our professional standards require the consulting accountant to check with us to determine that the consultant has all the relevant facts. To our knowledge, there were no such consultations with other accountants.

Other Audit Findings or Issues

We generally discuss a variety of matters, including the application of accounting principles and auditing standards, with management each year prior to retention as the Plan's auditors. However, these discussions occurred in the normal course of our professional relationship and our responses were not a condition to our retention.

Other Matters

1. Description of Plan

The following description of the Finalsite Holdings, Inc. 401(k) Plan (the Plan) is provided for general purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan, established on July 27, 2012, is a defined contribution plan, available to all employees of Finalsite Holdings, Inc. (the Company) who have met the eligibility requirements stipulated by the Plan. The Plan is administered by the management of the Company and is subject to the provisions of the Employee Retirement Income Security Act (ERISA).

Effective January 1, 2023, the Plan made changes to investment offerings for participants to offer primarily institutional funds.

Effective August 1, 2024, the Plan adopted various provisions of SECURE 2.0, including qualified birth or adoption distributions, withdrawals for emergency expenses or federally declared disasters and eligible distributions for domestic abuse victims. The new provisions were available to participants in November 2024.

Eligibility

In general, employees are eligible to participate in the Plan upon hire and attainment of age 21. Employees who meet the eligibility requirements can enter into the Plan at any time. Eligible participants are automatically enrolled in the Plan at a 6% contribution rate unless they opt out of participation in the Plan or elect a different contribution rate.

Contributions

Each year, participants may contribute a dollar amount or percentage from 1% through 90% of their pretax annual compensation as defined by the Plan. Participant's contributions are subject to limitations imposed by the Internal Revenue Code. Participants may also designate a portion of their contributions as Roth 401(k) contributions, which are taxable to the participant at the time of deferral.

1. Description of Plan (continued)

Contributions (continued)

The Company makes discretionary matching contributions each pay period to all eligible participants equal to 100% of the first 3% and 50% of the next 2% of the Participant's compensation which is deferred as an elective deferral. Nonelective contributions may also be made at the discretion of the Company. There were no nonelective employer contributions made for 2024.

Investment Options

All of the assets of the Plan are held by Fidelity Management Trust Company. All investments are fully participant directed. Participants may direct the investment of their contributions and the Company matching contribution into any of the Plan's available investment options.

Participant Accounts

The account of each participant reflects a separate record of participant contributions, Company matching and discretionary contributions, withdrawals, expenses, and investment gains and losses.

Vesting

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Participants vest in the Company's matching contributions, any nonelective employer contributions, and any earnings thereon in accordance with the following schedule. Participants are credited with a year of service for any year in which they work 1,000 hours or more.

Notes Receivable from Participants

Notes receivable from participants represent participant loans that are recorded at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when it is earned. No allowances for credit losses have been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be a distribution, the participant loan balance is reduced and a benefit payment is recorded.

Participants may borrow up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance and a minimum of \$1,000 and may only have one loan outstanding at a time. Loans must be repaid over a period of no more than 5 years except in the case of a loan used to acquire a principal residence, in which case the Plan Administrator may permit a longer repayment term. Payments of principal and interest are made through payroll deductions over the loan period. A loan is secured by the vested balance in the participant's account. The loan bears interest at a rate that is determined by the Plan administrator based on prevailing market conditions and is fixed over the life of the note. Interest rates on participant loans ranged from 4.25% to 9.50% in 2024.

Payment of Benefits

Upon a participant's separation from service due to death, disability, termination, or retirement, benefits may be distributed to them in a single lump sum amount equal to the vested value of their account or through installments over a certain period at the participant's election. Active participants may also withdraw funds from their accounts under certain hardship conditions.

If the vested benefit is less than \$5,000, the Plan administrator may initiate an involuntary distribution. Prior to such distribution, the participant has the right to request that the amount be distributed directly to the participant in the form of a lump sum amount or request that it be rolled over to a different IRA provider or another retirement plan eligible to receive rollover contributions.

1. Description of Plan (continued)

Forfeitures

Upon a participant's separation from service, unvested contributions are forfeited by the participant and may be used to reduce future employer contributions. Forfeited nonvested accounts totaled \$82,590 and \$76,596 as of December 31, 2024 and 2023, respectively. There were \$82,968 of new forfeitures and Company used \$81,029 in forfeitures to reduce employer contributions for 2024.

Administrative Expenses

All costs related to the administration of the Plan, other than loan servicing fees, are paid by the Company.

2. Summary of Accounting Practices

Basis of Accounting

The accompanying financial statements of the Plan have been prepared in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make significant estimates and assumptions that affect the reported amounts of net assets available for benefits at the date of the financial statements and the changes in net assets available for benefits during the reporting period and, when applicable, disclosures of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Risk and Uncertainties

The Plan invests primarily in various money market and mutual fund securities. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities in the near term could materially affect participants' account balances and the amounts reported in the accompanying financial statements.

2. Summary of Accounting Practices (continued)

Benefit Payments

Benefits are recorded when they have been approved for payment and paid by the Plan.

Investment Income Recognition

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date. The Plan presents in the Statement of Changes in Net Assets Available for Benefits the net appreciation (depreciation) in the fair value of its investments, which consists of realized and unrealized gains (losses).

Fair Value of Financial Instruments

The Plan's investments are stated at fair value. Shares of money market and mutual funds are valued at quoted market prices.

The Plan follows ASC 820 for all financial assets and liabilities and nonfinancial assets and liabilities that are recognized or disclosed at fair value in the financial statements on a recurring basis. ASC 820 defines fair value, establishes a fair value hierarchy, and expands disclosures about fair value measurements.

ASC 820 defines fair value as the price that would be received upon sale of an asset or paid upon the transfer of a liability in an orderly transaction between market participants at the measurement date and in the principal or most advantageous market for that asset or liability.

The fair value should be calculated based on assumptions that market participants would use in pricing the asset or liability, not on assumptions specific to the entity. In addition, the fair value of liabilities should include consideration of non-performance risk including the Plan's own credit risk.

3. Information Certified by the Trustee

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. The amount of appreciation (depreciation) in the fair value of investments, individually and in the aggregate, for the year ended December 31, 2024.

(d) Notes Receivable from Participants

The amount of notes receivable from participants plus any accrued but unpaid interest as of December 31, 2024 and 2023.

4. Fair Value Measurements

Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy prioritizes the inputs into three levels based on the extent to which inputs used in the measuring fair value are observable in the market. Each fair value measurement is reported in one of three levels which is determined by the lowest level input that is significant to the fair value measurement in its entirety. These levels are:

Level 1 - Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

Level 2 - Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

Level 3 - Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

5. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time or to terminate the Plan subject to the provisions of ERISA. Upon termination of the Plan, no further contributions could be made and all amounts credited to participant accounts would become 100% vested.

6. Party-in-Interest and Related Party Transactions

Section 3(14) of ERISA defines party-in-interest to include, among others, fiduciaries or employees of the Plan, any person who provides services to the Plan or an employer whose employees are covered by the Plan. Accordingly, loans to participants and interest, and transactions with investment funds managed and held by the trustees are considered party-in-interest transactions. During 2024 and 2023, certain plan investments are investments and shares of money market funds and mutual funds held by Fidelity Management Trust Company. Fidelity Management Trust Company is also the trustee and recordkeeper of the Plan, therefore, these transactions qualify as party-in-interest transactions.

Fees paid by the Plan for investment management, recordkeeping and other operating expenses are with the trustee and considered permitted party-in-interest transactions. Investment management fees are netted against net appreciation (depreciation) in fair value of investments for the Plan.

7. Tax Status

The Plan adopted a Prototype Non-Standardized Profit Sharing Plan, an Automatic Data Processing prototype plan. In accordance with Revenue Procedure 2005-16, the Company has chosen to rely on the advisory opinion letter dated July 8, 2014. Once qualified, the Plan is required to operate in conformity with the Internal Revenue Code to maintain its qualification. The Plan has been amended since receiving the advisory opinion letter. The Plan Administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

8. Subsequent Events

The Plan has evaluated events occurring between December 31, 2024 and October 10, 2025, the date the financial statements were available to be issued.
