## Independent Auditor's Report

Trustees and Plan Participants  
Arizona OB/GYN Affiliates PC 401(k) Retirement Plan

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of Arizona OB/GYN Affiliates PC 401(k) Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### **Opinion**

December 31, 2024 and 2023

### 1) Summary of Significant Plan Provisions

The following description of Arizona OB/GYN Affiliates PC 401(k) Retirement Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

#### General

The Plan is a defined contribution plan covering all employees of Arizona OBGYN Affiliates PC (the “Employer”). Employees become eligible to participate in the Plan on the first day of each month after attaining age twenty one and completing three months of service. An employee must complete one year of service with 1,000 hours of service during a Plan year and be employed on the last working day of the year to receive nonelective employer contributions. Entry dates for employer contributions are semi-annually each January 1 or July 1 after meeting eligibility requirements. The Plan was established on October 1, 1980, was amended and restated effective July 1, 2022, and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Employer serves as the Plan administrator.

#### Contributions

Each year, participants may contribute pretax and after-tax Roth contributions up to the lesser of the federal statutory limits or 92% of pretax annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions subject to certain limitations under the Internal Revenue Code. Participants may also contribute amounts representing distributions from other qualified Plans (rollover).

The Employer makes a safe harbor nonelective contribution to the Plan annually. For the years ended December 31, 2024 and 2023, a 3% safe harbor nonelective contribution was made to non-highly compensated participants totaling \$589,334 and \$540,571, respectively.

The Employer may make a discretionary profit-sharing contribution to the Plan. For the years ended December 31, 2024 and 2023, there was a 9% discretionary profit-sharing contribution allocated to highly compensated participants that were shareholders, a 6% discretionary profit-sharing contribution allocated to shareholders that were not highly compensated, and a 3% discretionary profit-sharing contribution allocated to highly compensated participants that were not shareholders, totaling \$986,297 and \$1,078,528, respectively.

#### Participant Accounts

Each participant’s account is credited with the participant’s contributions, the Employer’s contributions, and allocations of Plan earnings (losses). Participant accounts are also charged with an allocation of certain administrative expenses paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

### Vesting of Accounts

Participants are immediately vested in their contributions, the Employer's safe harbor nonelective contributions, and related earnings thereon. Vesting in the Employer's discretionary profit-sharing contributions portion of their accounts plus earnings thereon is based on years of continuous service as follows:

### Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. The loans are secured by the balance in the participant's account. The maximum loan period is five years unless for the purchase of a principal residence. The loan interest rate, determined quarterly, is set at one percent above the prime rate, as defined. Principal and interest is paid through payroll deductions. Participants can have no more than two loans outstanding at one time.

### Payment of Benefits

Benefits are payable in the event a participant ceases to be an employee of the Employer. A participant may receive the value of the vested interest in their account as a lump-sum distribution or annual installments. Participants are also allowed to withdraw from their account in the event of undue financial hardship, as defined by the Plan.

### Mandatory Cash-Out

If the amount of benefits in a participant's account is \$5,000 or less (excluding rollover contributions) at the time of separation, the Plan will distribute benefits in a single lump sum payment, without consent of the participant. If the benefit exceeds \$1,000, such distributions are transferred to an individual retirement account.

### Investment Options

Upon enrollment in the Plan, a participant may direct all contributions into any of the investment options offered by the Plan. Participants may change their investment options each business day. If a participant does not make an investment election, their account will be invested in a default investment chosen by the trustee. Under certain circumstances, the Plan allows participants to direct employee and Employer contributions into self-directed brokerage accounts.

### Forfeitures

Forfeitures available for allocation under the Plan are applied to restore forfeited account balances of eligible rehired employees, to pay Plan administrative expenses, or to offset Employer contributions otherwise required for the Plan year. As of December 31, 2024 and 2023, the ending balance in the forfeited, nonvested participant accounts was \$19,088 and \$3,385, respectively. In 2024, \$16,572 of forfeitures were used to pay Plan administrative expenses. In 2023, \$15,448 forfeitures were used to pay Plan administrative expenses. In 2024 and 2023, no forfeitures were used to restore account balances of rehired employees, or to offset Employer contributions.

## 2) **Summary of Significant Accounting Policies**

### Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

### Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### Risks and Uncertainties

The Plan invests in a variety of investment funds. Investments in general are exposed to various risks, such as interest rate, credit, and overall volatility risk. Due to the level of risk associated with certain investments, it is reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect the participants' account balances and amounts reported in the statements of net assets available for benefits.

### Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. If a participant ceases to make loan repayments and the Plan administrator deems the loan to be in default in accordance with Plan provisions, the participant's loan balance is reduced and a benefit payment is recorded.

### Payment of Benefits

Benefits are recorded when paid.

### Administrative Expenses

The Plan permits, but does not require, the Employer to pay significant costs of Plan administration. For the years ended December 31, 2024 and 2023, the Employer paid a portion of the Plan's administrative expenses, which are not reflected in the accompanying statements of changes in net assets available for benefits. Investment related expenses are included in net appreciation (depreciation) of fair value of investments.

### Subsequent Events

Subsequent events were evaluated for recognition or disclosure in these financial statements through October 10, 2025, the date that the financial statements were available to be issued.

## 3) Investments and Fair Value Measurements

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the input to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Quoted prices in markets that are not considered to be active or financial instruments without quoted market prices, but for which all significant inputs are observable, either directly or indirectly.
- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for investments measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at the price. The mutual funds held by the Plan are deemed to be actively traded.

*Self-directed brokerage accounts:* The self-directed brokerage (SDB) option is an investment option in which participants can transfer assets to an independent brokerage account and invest in investment vehicles outside of the Plan's offering of mutual funds and money market investments. Assets are valued at the daily closing price as reported by the stocks and funds held.

### **4) Information Prepared and Certified by the Custodians (Unaudited)**

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.1030-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the following information was obtained or derived from information provided to the Plan administrator by Ascensus, LLC, the parent entity of Ascensus Trust Company, the current Trustee effective April 18, 2024, and Newport Trust Company, the former trustee through April 17, 2024, qualified institutions, and certified as complete and accurate:

- Investments reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment income reflected on the accompanying statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023.
- Investments reflected on the supplemental schedule of assets held at end of year.

Notes receivable from participants and interest income on notes receivable from participants are not certified.

### **5) Related-Party and Party-In-Interest Transactions**

Certain Plan investments are managed by the custodian, and therefore, these transactions qualify as party-in-interest transactions. Additionally, the Plan issues loans to participants, which are secured by the participant's account balances. These transactions qualify as party in interest transactions.

Certain administrative functions of the Plan are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. For the years ended December 31, 2024 and 2023, fees paid by the Plan for administrative expenses, such as third-party administrative fees, totaled \$99,427 and \$82,814, respectively.

### **6) Plan Termination**

Although it has not expressed any intention to do so, the Employer may terminate the Plan for any reason, subject to the provisions of ERISA. Unless the Employer was to transfer the trust fund to another trust or fund, account balances would be distributed to participants in cash or in purchased annuities. In the event of Plan termination, participants will become 100% vested in their accounts.

### 7) Tax Status

The Plan is operating as a tax exempt plan under a prototype document with a nonstandardized adoption agreement. The Internal Revenue Service (IRS) has determined and informed the Plan sponsor by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended and restated since the date of the advisory opinion letter, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require the Plan's administrator to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the Internal Revenue Service. Plan management does not believe that the Plan has taken any uncertain tax positions as of December 31, 2024. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

### 8) Delinquent Participant Contributions

As disclosed in the supplemental schedule of delinquent participant contributions, four payrolls during the year ended December 31, 2024, were not remitted to the Plan within the time frame specified by the Department of Labor's Regulation 20 CFR 2510.3-102, thus constituting nonexempt transactions between the Employer and the Plan. All delinquent 2024 participant contributions were remitted to the Plan no later than December 31, 2024.


