Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Stone Bank 401(k) Plan (Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Stone Bank 401(k) Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

NOTES TO FINANCIAL STATEMENTS
DECEMBER 31, 2024 AND 2023

Note 1) Description of plan:

A general description of the Stone Bank 401(k) Plan (Plan) is provided in the following paragraphs. Participants should refer to the plan agreement and summary plan description for a more complete description of the Plan's provisions.

General -

The Plan is a defined contribution plan covering all employees of Stone Bank (Employer). Employees who have attained the age of 18 are immediately eligible to participate in the Plan for all contribution types. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and subsequent amendments.

Contributions -

Each year, participants may contribute compensation, as defined by the Plan document, subject to certain Internal Revenue Code (IRC) limitations. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans.

The Plan is a safe harbor plan providing matching contributions under a basic matching contribution formula. The Company matches 100% up to the first 3% of each participant's salary and 50% on deferrals from 3% to 5% of each participant's salary. A non-elective safe harbor contribution was not made for 2024. Additional amounts may be contributed at the option of the Company's Board of Directors. No additional contributions were made for the year ended December 31, 2024. Contributions are subject to certain limitations.

Participants direct the investment of their contributions and employer matching contributions into various investment options offered by the Plan. The Plan currently offers several mutual funds as investment options for participants. Participants may change their elected investment options daily and salary deferral contributions effective as of any payroll date.

Participant accounts -

Each participant's account is credited with his or her salary deferral contribution plus an allocation of (a) the Employer's matching and discretionary contributions and (b) plan earnings less administrative expenses. Allocations of plan earnings are based on each participant's account balance. Allocations of contributions are based on each participant's compensation. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Administrative expenses -

The Plan is responsible for paying all Plan expenses unless the Employer determines to pay them. Administrative expenses consist primarily of fees charged by third-party service providers as well as loan processing fees. Investment-related expenses are included in net change in fair value of investments.

Vesting -

Participants are immediately vested in their salary deferral contributions, rollover contributions, qualified non-elective safe harbor contributions and elective safe harbor matching contributions made by the Employer plus actual earnings thereon. Vesting in any Employer discretionary profit-sharing contributions, and any earnings thereon is based on years of credited service. Under the Plan's cliff vesting schedule, a participant is 100% vested after three years of credited service, or upon termination of employment due to death, disability, or retirement.

Note 1) Description of plan: (continued)

Payment of benefits -

On termination of service due to death, disability, or other reasons, a participant may elect to receive an amount equal to the value of the participant's vested interest in the participant's account in a lump sum payment, or a partial lump sum payment. If a terminated participant's account balance is equal to or less than \$5,000, the account will be automatically distributed in a lump sum payment. In-service withdrawals are available to participants who have met certain hardship requirements, consistent with the provisions of the IRC. Benefits shall be paid as soon as administratively feasible following the date on which a distribution is requested or is otherwise payable.

Forfeited accounts -

Forfeitures can be used to reduce either the Employer's matching contributions or pay administrative expenses of the Plan. No forfeitures were utilized for the year ended December 31, 2024. Forfeited non-vested accounts available for future use amounted to \$9,946 and \$8,570 as of December 31, 2024 and 2023, respectively.

Notes receivable from participants -

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. A participant may not have more than two loans outstanding at any time. Loan terms do not exceed five years unless the loan is for the purchase of a principal residence. Loans are secured by the vested balance in the participant's account and bear interest rates from 5.25% to 10.50% at December 31, 2024. Principal and interest are paid ratably through payroll deductions.

Deemed distributions -

The Plan treats participant loans that are in default due to a missed payment and outstanding loan balances when a terminated employee takes a distribution, as deemed distributions. In accordance with Internal Revenue Service (IRS) regulations, a participant who repays a loan after a deemed distribution will receive credits pursuant to IRS requirements.

Plan termination -

Although it has not expressed any intent to do so, the Employer has the right under the provisions of the plan document to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Note 2) Summary of significant accounting policies:

Basis of accounting -

The financial statements of the Plan are prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States.

Estimates and assumptions -

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Note 2) Summary of significant accounting policies: (continued)

Valuation of investments and income recognition -

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 6 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income from notes receivable from participants is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net change in fair value of investments includes gains and losses on investments bought and sold, as well as held, during the year.

Notes receivable from participants -

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when it is earned. Related fees are recorded as administrative expenses and are recorded when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be a distribution under the terms of the plan document, the participant loan balance is reduced, and a benefit payment is recorded.

Payment of benefits -

Benefit payments to participants are recorded upon distribution.

Risks and uncertainties -

The Plan provides for various investment options. Such investments, in general, are exposed to various risks such as interest rate, market volatility, and credit risks. During 2024, net change in fair value of investments occurred due, in part, to investment performance. Due to the level of risk associated with these investments, it is at least reasonably possible that changes in fair value will occur in the near term and that such changes could materially affect the value of participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

Recent accounting pronouncements -

In March 2022, the Financial Accounting Standards Board (FASB) issued Accounting Standards Update (ASU) 2022-03, *Fair Value Measurement (Topic 820): Fair Value Measurement of Equity Securities Subject to Contractual Sale Restrictions*. ASU 2022-03 clarifies that contractual restrictions on the sale of an equity security should not be considered in measuring fair value and introduces new disclosure requirements for equity securities subject to such restrictions. This standard is effective for fiscal years beginning after December 15, 2024. The Plan does not hold equity securities subject to contractual sale restrictions; therefore, the adoption of this standard is not expected to have a material impact on the Plan's financial statements.

In March 2023, the FASB issued ASU 2023-02, *Investments - Equity Method and Joint Ventures (Topic 323): Accounting for Investments in Tax Credit Structures Using the Proportional Amortization Method*. This standard expands the use of the proportional amortization method to additional tax credit investments and is effective for fiscal years beginning after December 15, 2024. The Plan does not hold investments in tax credit structures; therefore, the adoption of this standard is not expected to have a material impact on the Plan's financial statements.

Note 3) Tax status:

The Plan, and trust established under the Plan to hold the Plan's assets, obtained its latest determination letter on March 31, 2014, in which the IRS stated that the Plan, as then designed, was in compliance with the applicable requirements of the IRC.

Although the Plan has been amended since receiving the determination letter, the plan administrator believes that the Plan and trust are designed and being operated in compliance with the applicable requirements of the IRC, and, therefore believes that the Plan is qualified, and the related trust is tax exempt.

Accounting principles generally accepted in the United States require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that, more-likely-than-not, would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that, as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken. The Plan is subject to routine audits by the IRS; however, there are currently no audits in process for any open tax periods. The plan administrator believes the Plan's annual return is no longer subject to income tax examinations for plan years prior to 2021.

Note 4) Party-in-interest transactions:

Party-in-interest transactions include relationships with fiduciaries, third-party service providers and the Employer, whose employees are covered by the Plan. Ascensus Trust Company (Ascensus) serves as the record keeper and custodian of the Plan and is by definition a party-in-interest. The Plan also holds notes receivable from participants. As a result, these notes receivable and all related transactions were with parties-in-interest. These transactions are exempt from being prohibited transactions under ERISA.

Note 5) Investments:

The plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the plan administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the investment information certified by Ascensus, except for comparing such information to information included in the Plan's financial statements and the applicable supplemental schedule.

All investment information disclosed in the accompanying financial statements and supplemental schedule of assets (held at end of year) was obtained or derived from investment information provided to the plan administrator and certified as complete and accurate by Ascensus.

There are no redemption restrictions or future commitments on the instruments that use net asset value as the practical expedient.

Note 6) Fair value measurements:

The Plan's investments are reported at fair value in the statement of net assets available for benefits. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability (an exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction between market participants on the measurement date.

Accounting Standards Codification 820, *Fair Value Measurement*, establishes a fair value hierarchy that requires the use of observable inputs and minimizes the use of unobservable inputs when measuring fair value.

Note 6) Fair value measurements: (continued)

The standard describes three levels of inputs that may be used to measure fair value, as follows:

- Level 1 Inputs - Valuations based on quoted prices for identical assets or liabilities in active markets.
- Level 2 Inputs - Valuations based on observable inputs other than quoted prices included in Level 1, such as quoted prices for similar assets or liabilities in active markets; quoted prices for similar assets or liabilities in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.
- Level 3 Inputs - Valuations based on unobservable inputs reflecting the plan administrator's own assumptions, consistent with reasonably available assumptions made by other market participants.

Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. The inputs used for valuing assets are not an indication of the risk associated with investing in those assets.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds -

The fair value of mutual funds, other than the money market mutual fund, is based on quoted prices of identical assets in active markets, which is categorized within Level 1 of the fair value hierarchy.

The fair value of the money market mutual fund is based on the fair value of the underlying investments. The underlying investments are valued based on quoted prices in active markets which are also categorized within Level 1 of the fair value hierarchy. The money market mutual fund's objective is to achieve a \$1 per share value, based on the underlying investments fair value.

The following methods and assumptions were used to estimate the fair value of financial instruments that are not disclosed above:

Cash and cash equivalents -

The carrying amounts of cash and cash equivalents reported in the statements of net assets available for benefits approximate estimated fair value.

Notes receivable from participants -

The notes receivable from participants are not actively traded and significant other observable inputs are not available. Thus, the fair value of the notes receivable from participants is equal to the unpaid principal balance plus any accrued but unpaid interest because the loans are secured by each respective participant's vested account balance.

Note 7) Reconciliation of financial statements to IRS Form 5500:

Net assets available for benefits at December 31, 2024 and 2023, as disclosed in IRS Form 5500 were \$7,690,585 and \$6,785,647, respectively, which is identical to that reported in the statements of net assets available for benefits.

Increase in net assets available for benefits for the year ended December 31, 2024, as disclosed in IRS Form 5500 was \$904,938. The amount is identical to that reported in the statement of changes in net assets available for benefits.

Contributions for the year ended December 31, 2024, as disclosed in IRS Form 5500 totaled \$1,006,644. The amount is identical to that reported in the statement of changes in net assets available for benefits.

Benefits paid to participants for the year ended December 31, 2024, as disclosed in IRS Form 5500 totaled \$1,258,020. The amount is identical to that reported in the statement of changes in net assets available for benefits.

Note 8) Controlled group:

Stone Bank became a member of a larger controlled group on April 12, 2023, as a result of the Bank's acquisition by MO/ARK Bancshares, Inc. The controlled group now includes Stone Bank, Alton Bank, First Community Bank of the Ozarks, and Table Rock Community Bank. In accordance with IRC controlled group regulations, all retirement plans maintained by these banks must be tested together for coverage, nondiscrimination, contribution limits, and vesting purposes. As a result, the group is in the process of consolidating its separate retirement plans into a single plan structure to ensure compliance with these requirements and to align with recent legislative changes under the SECURE Act and SECURE 2.0.

The recommended new plan structure, effective January 1, 2025, harmonizes eligibility, entry dates, compensation definitions, profit sharing, 401(k) features, matching, vesting, and automatic enrollment across the controlled group. Notably, all employees hired on or before December 31, 2024, will be 100% vested in their QACA Safe Harbor Matching Contribution Account and other applicable Employer Contribution Accounts, with new employees subject to a 2-year cliff vesting schedule. These changes are designed to meet the compliance deadlines for plan amendments required by the SECURE Act and SECURE 2.0, which for calendar-year plans must generally adopt by December 31, 2025.

The formation of the controlled group required that eligibility, contribution limits, and vesting service be aggregated across all members of the group, but did not otherwise affect the Plan's eligibility requirements, contribution limits, or vesting schedules for existing participants. The group has taken all necessary steps to ensure timely compliance with all applicable regulations and legislative requirements.

Note 9) Subsequent events:

The plan administrator has evaluated subsequent events through October 6, 2025, the date which the financial statements were available for release. The plan administrator is not aware of any subsequent events that would require recognition or disclosure in the financial statements.
