Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Kennebec Behavioral Health 403(b), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Kennebec Behavioral Health 403(b) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Kennebec Behavioral Health 403(b) and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Kennebec Behavioral Health 403(b)'s ability to continue as a going concern for one year after the date the financial statements are available to be issued.

NOTES TO FINANCIAL STATEMENTS

DECEMBER 31, 2024 AND 2023

NOTE 1: DESCRIPTION OF PLAN

The following description of the Kennebec Behavioral Health (“Organization”) 403(b) Plan (“Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan, pursuant to Internal Revenue Code section 403(b), covering all employees of the Organization beginning with their date of hire who are expected to work more than 20 hours per week (or 1,000 per year). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Organization is the plan sponsor and the plan administrator and as such is fully responsible for compliance with the provisions of the Plan and the provisions of benefits to Plan participants and beneficiaries.

Contributions

Each year, participants may contribute, on a pre-tax basis, up to a maximum dollar limit set by the Internal Revenue Service. Participants also have the option to elect to contribute after-tax Roth contributions. Participants who have attained age 50 or have at least 15 years of service (qualified organization) before the end of the Plan year are eligible to make catch-up contributions, as defined under the Internal Revenue Code. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan and may change their investment options at any time. The Plan includes an auto enrollment provision whereby newly eligible participants are automatically enrolled at a deferral rate of 5% unless they affirmatively elect not to participate in the Plan or elect another deferral rate. Participants auto enrolled have their contributions invested in the Vanguard Target Retirement Fund that is most appropriate for that participant.

Participants will be eligible for employer safe harbor matching contributions on the day after completion of one year of service. Upon meeting the matching requirements, eligible participants will receive a 100% match contribution on the first 5% deferred.

In addition, the plan sponsor may elect to contribute discretionary employer contributions. Participants are eligible to receive discretionary employer contributions if they have attained 18 years of age and completed one year of eligible service.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000, up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance excluding the portion of their account balance attributable to Roth contributions. The notes are secured by the balance in the participant's account and bear a reasonable rate of interest, 4.50% at December 31, 2024. Notes must be repaid within 5 years, except in the case of a loan used for the purchase of a principal residence which may be repaid within 15 years. Principal and interest are paid ratably through monthly payroll deductions.

Participant Accounts and Vesting

Each participant's account is credited with the participant's contribution, the employer's safe harbor matching contributions, and an allocation of the Plan's earnings and charged with an allocation of administrative expenses paid by the Plan. The Plan's earnings are allocated according to participants' relative account balances. Participants are vested immediately in their contributions plus actual earnings thereon. Participants are also immediately vested in employer safe harbor matching contributions received and earnings thereon. Vesting in the other employer discretionary and nonelective contributions portion of their account is based on years of continuous service. A participant is 100% vested after two years of credited service. The benefit to which a participant is entitled is the benefit that can be provided from the vested balance of the participant's account.

Payment of Benefits

Upon termination of employment, retirement, death or disability, as defined, participants with vested balances of at least \$1,000 may keep their balance in the Plan or elect to receive a lump sum payment, annual installments or apply their account balance, or a portion thereof, to an annuity contract. Participants with a vested balance not exceeding \$1,000 will receive a lump-sum amount equal to the vested value of their individual account balance.

In certain hardship situations, as described in the Plan agreement, participants may withdraw part of their account balances while actively employed but such withdrawals are limited to the amount dictated by the hardship. In addition, the Plan also allows in-service withdrawals after attaining age 59 1/2.

Forfeitures

Forfeitures may be used to reduce plan expenses. No forfeitures were used to pay expenses during 2024. At December 31, 2024 and 2023, the forfeited non-vested accounts totaled \$3,006 and \$650, respectively.

NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting and presented in conformity with accounting principles generally accepted in the United States of America. As such, contributions and income are recorded when earned, benefit payments are recorded when paid.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive contracts. Contract value is the relevant measure for the portion of net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the plan.

NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)**Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (“GAAP”) requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on an accrual basis. Related fees are charged directly to the borrowing participants account and included in administrative expenses when incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent participant notes, that the plan administrator considers to be in default, are reclassified as benefit payments based on the terms of the Plan document.

Investment Valuation and Income Recognition

Investments are reported at fair value (except for fully benefit-responsive investment contracts which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

Contributions

Contributions from plan participants, and the related employer matching contributions, are recorded in the year in which the employee contributions are withheld from compensation.

Plan Expenses

Certain administrative fees relating to the operation of the Plan’s investments are paid directly from Plan assets. Certain other administrative expenses are paid by the Organization. Expenses that are paid by the Organization are excluded from these financial statements. Fees related to administration of notes receivable from participants are charged directly to their accounts and are included in administrative expenses.

Certain fees incurred by the Plan for investment management services are included in net appreciation (depreciation) in fair value of investments, as they are paid through revenue sharing rather than a direct payment.

Subsequent Events

Events that occur after the statements of net assets available for benefits date, December 31, 2024, but before the financial statements were available to be issued must be evaluated for recognition or disclosure. Subsequent events that provide evidence about conditions that existed at the statements of net assets available for benefits date require disclosure in the accompanying financial statements. Subsequent events that provide evidence about conditions that existed after December 31, 2024 require disclosure in the accompanying notes. The plan administrator evaluated the activity of the Plan through October 14, 2025, the date the financial statements were available to be issued and concluded that, except as discussed in Note 11, no subsequent events have occurred that would require recognition in the financial statements or disclosure in the notes to the financial statements.

NOTE 3: INVESTMENTS

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and the ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by American United Life Insurance Company (AUL), the trustee of the Plan, and VOYA Retirement Insurance and Annuity Company, the custodian of certain plan assets.

NOTE 4: FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under Financial Accounting Standards Board Accounting Standards Codification (FASB ASC) 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Pooled Separate Accounts and Money Market Fund: The Plan's interests in these accounts are valued based on the net asset values reported by the trustee of the funds based on either quoted market prices in active markets or observable inputs or quotations from inactive markets. Accordingly, these assets are classified as Level 2 assets.

NOTE 5: GUARANTEED INVESTMENT CONTRACTS WITH INSURANCE COMPANIES

The Plan has entered into a fully benefit-responsive guaranteed investment contract with American United Life Insurance Company (AUL). AUL maintains the applicable contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

The Plan has also entered into a fully benefit-responsive guaranteed investment contract with VOYA. VOYA maintains the applicable contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed investment contracts are fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the investment contracts. The guaranteed investment contracts are presented on the face of the statement of net assets available for benefits at contract value. Contract value, as reported to the Plan by the insurance companies, represents contributions made under the contracts, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

The crediting interest rates are based on formulas agreed upon with the respective issuer. Such interest rates are reviewed on a quarterly basis for resetting. Interest income earned on the contracts for the year ended December 31, 2024 was \$11,302.

Certain events limit the Plan's ability to transact at contract value with the insurance companies. Such events include the following: (a) amendments to the Plan documents (including complete or partial Plan termination or merger with another Plan), (b) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. Furthermore, certain events would allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include (a) an uncured breach of the Plan's investment guidelines (b) a material amendment to the contract without the issuer's consent, (c) a violation of a material obligation under the contract, or (d) a material misrepresentation. The plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with Plan participants or the issuer are probable of occurring.

The guaranteed investment contracts do not permit the insurance companies to terminate the agreements prior to the scheduled maturity dates.

NOTE 6: RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain plan investments are managed by AUL, the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Administrative fees paid to AUL during the year ending December 31, 2024 totaled \$3,036.

NOTE 7: RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE 8: TAX STATUS

The Organization has adopted a pre-approved plan document that has received an opinion letter from the Internal Revenue Service dated March 31, 2017, stating that the form of the pre-approved plan document was in compliance with applicable requirements of the Internal Revenue Code (IRC). The plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore, believes that the Plan is qualified.

NOTE 9: PLAN TERMINATION

Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate or amend the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their employer contributions.

NOTE 10: SECURE 2.0 - SECURING A STRONG RETIREMENT ACT

In December 2022, Securing a Strong Retirement Act (SECURE 2.0) was signed into law. Secure 2.0 includes new retirement provisions with varying effective dates with the majority of changes becoming effective in 2024. The new provisions include changes in required minimum distributions (RMD), eligibility of part-time employees, and hardship distribution rules. SECURE 2.0 includes both required and optional provisions. Management will determine if any optional provisions should be elected into the Plan.

NOTE 11: SUBSEQUENT EVENT - CHANGE IN SERVICE PROVIDERS

Effective August 2025, American United Life Insurance Company (AUL) services to the Plan were terminated and Ascensus, LLC became the recordkeeper and custodian for the assets previously under management of AUL.
