Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of The Flippen Group Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of The Flippen Group Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

1. Plan description

The following description of the The Flippen Group Retirement Plan (“the Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering employees, who are age 21 or older and are not covered by a collective bargaining agreement. The Plan, which was established as of January 1, 2013, is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Each year, participants may contribute through deferral of their earned income, up to 100% of pretax annual compensation, as defined in the Plan. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan, unless they affirmatively elect not to participate, with a default deferral rate set at 3% of eligible compensation. In addition, all participants in the Plan who make no other election will have their deferral rate automatically increased 1% yearly, up to a maximum of 10%. The Plan currently offers mutual funds as investment options for participants. The employer may make a discretionary contribution to the Plan.

Participant accounts

Each participant's account is credited with the participant's contribution and allocations of Plan earnings and the employer's contribution. Allocations are based on participant earnings or account balances, as defined. Each participant is entitled to the benefit that can be provided from his or her vested account.

Vesting

Participants are immediately vested in all contributions plus actual earnings thereon. However, the participant's accrued benefits attributable to employer contributions and profit-sharing contributions shall vest based on years of service as defined by the Plan. Generally, participants are fully vested in employer contributions after five years of service. In addition, all participants who participated in the Plan prior to January 1, 2018 are vested 100% in all contributions.

Forfeited accounts

Forfeited accounts may be used to reduce future employer contributions or administrative expenses. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$4,910 and \$2,955, respectively. During the year ended December 31, 2024, \$6,471 of administrative expenses were paid with forfeited accounts.

1. Plan description - continued

Notes receivable from participants

Participants may borrow from their fund accounts up to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant's account and bear interest at rates which are commensurate with local prevailing rates as determined quarterly by the Plan administrator. Principal and interest is paid ratably through payroll deductions.

Payments of benefits

Plan benefits are available upon termination of employment, death, disability, or retirement. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution, if the vested interest is less than \$5,000. For vested interests greater than \$5,000, the participant may receive a lump sum amount equal to the value of the participant's vested interest in his or her account, or installments over a period of time, not to exceed the participant's life expectancy.

The Plan also allows for in service withdrawals in limited circumstances, as defined by the Plan.

Amounts allocated to the accounts of participants who have elected to withdraw from the plan but have not yet been paid as of December 31, 2024 totaled \$134,321.

Plan expenses

Certain expenses incurred with the administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statement of changes in net assets available for benefits. Participant loan fees or transaction expenses are deducted from loan or distribution proceeds, as applicable, or are charged directly to the participant's account. A portion of expenses incurred by the Plan have been paid for by the plan sponsor and are excluded from these financial statements.

2. Summary of significant accounting policies

Basis of accounting

The financial statements of the Plan are prepared using the accrual method of accounting.

Use of estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

2. Summary of significant accounting policies - continued

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

Investment valuation and income recognition

The Plan's investments are reported at fair value except for fully benefit-responsive investment contracts which are reported at contract value. Purchases and sales of securities are recorded on a trade-date basis. Interest income and capital gains are recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Contributions receivable and allowance for credit losses

Amounts due for employer contributions are stated at the amount management expects to collect from outstanding balances less an allowance for expected credit losses. The expected credit loss amount reflects management's best estimate of amounts that will not be collected. This assessment considers historical loss experience, current conditions, and other relevant and current reasonable and supportable forecasts.

At December 31, 2024 and 2023, there was no allowance for credit losses recorded as management concluded that expected losses would not have a significant impact on the financial statements of the Plan.

Payment of benefits

Benefit payments to participants are recorded upon distribution.

Date of management's review

Management has evaluated subsequent events through October 6, 2025, the date the financial statements were available to be issued.

Certain information related to investments are disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including the investments and fully benefit-responsive investment contracts held at December 31, 2024 and 2023, and net appreciation in fair value of investments and interest and dividends for the year ended December 31, 2024 was obtained by management and agreed to or derived from information certified as complete and accurate by Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company, the custodian of the Plan.

4. Investments

The Plan's investments are reported at fair value in the accompanying statement of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, and Level 3 have the lowest priority. The plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments.

When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. The three levels of the fair value hierarchy are described below.

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology that are observable, either directly or indirectly, such as quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; or other inputs that are observable or can be corroborated by observable market data for substantially the full terms of the assets or liabilities.

Level 3 - Inputs to the valuation methodology are unobservable.

The fair values of mutual funds are based on quoted market prices.

Pooled Separate Accounts are valued at net asset value of units held by the Plan. The net asset value, as provided by the issuer, is used as a practical expedient to estimate fair value. Redemptions at net asset value are processed daily without restrictions. There are no unfunded commitments related to pooled separate accounts.

5. Fully benefit-responsive investment contracts

The Plan has a fully benefit responsive guaranteed investment contract with Principal Life Insurance Company provided to the Plan as a general account product. The issuer is contractually obligated to pay the principal and specified interest rate that is guaranteed to the Plan.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: premature termination of the contract by the Plan, plant closings, layoffs, plan termination, bankruptcy, mergers, and early retirement incentives. The Plan Administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable of occurring. The insurance company may not terminate the contract at an amount less than contract value.

6. Plan termination

Although it has not expressed any intent to do so, the employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

7. Tax status

The Plan sponsor has adopted a non-standardized pre-approved profit sharing plan and is relying on the plan sponsor's IRS opinion letter for qualification. In the plan sponsor's opinion letter dated June 30, 2020, the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. Although the Plan has been amended since receiving the opinion letter, the Plan administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The plan administrator has analyzed the tax positions taken by the plan and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits of any tax periods in progress. The plan administrator believes it is no longer subject to income tax examination for years prior to 2021.

8. Plan administration

Certain administrative functions are performed by officers or employees of the employer. No such officer or employee receives compensation from the Plan.

9. Party-in-interest transactions

Certain plan investments are pooled separate accounts and guaranteed investment contracts with Principal Life Insurance Company. Principal Life Insurance Company is the custodian and recordkeeper of the Plan and, therefore, these transactions qualify as party-in-interest transactions. Plan assets also include notes receivable from participants. These transactions also qualify as party-in-interest transactions. Investment fees and expenses associated with Plan administration are paid to certain parties-in-interest. All of these transactions are exempt from the prohibited transactions rules under ERISA.

10. Delinquent participant contributions and loan payments

As of December 31, 2023, there were loan payments totaling \$1,032 from a prior year that were not segregated and remitted in a timely manner. Plan management fully corrected the late loan payments in 2024.
