Note 1 – Plan Description

The following description of the Kissito Healthcare 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering substantially all employees of McClintic Operations Holdco II LLC d/b/a Kissito Healthcare (the “Company”), who have completed 3 months of service and attained age 21. Employees are eligible for entry to the Plan on the first day of the month following completion of eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Effective November 1, 2024, the Plan’s assets were transferred to John Hancock Trust Company, LLC as the Plan’s new Trustee. On that date, the plan document was restated to exclude leased employees and residents of Puerto Rico from plan participation.

Contributions

Each year, participants may contribute any percentage or amount up to 90% of pretax annual compensation, as defined, up to the maximum allowed by law. The Plan allows Roth contributions. Participants who have attained age 50 are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans. The Company makes a safe harbor matching contribution of 100% up to 3% of compensation, and an additional 50% up to the next 2% of compensation for a maximum matching amount of 4%. Contributions are subject to certain limitations.

Participant Accounts

Each participant’s account is credited with the participant’s contributions, the Company’s matching contributions, allocations of Plan earnings and charged with an allocation of administrative fees. Allocations are based on participant account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Participants are immediately vested in their contributions and safe harbor contributions plus actual earnings thereon.

Notes from Participants

Participants may borrow from their accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Note terms range from one year to five years, or up to 30 years for the purchase of a primary residence. Notes are secured by the balance in the participant’s account and bear interest at a rate commensurate with market rates for similar notes as defined in the Plan. Participants are charged interest at the PRIME rate +1%. At December 31, 2024, interest rates ranged from 4.25% to 9.50%. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits

Upon attainment of normal retirement at age 65, termination of employment, or in the case of death or disability, a participant or their beneficiary will receive the vested portion of the amount credited to the participant's account. In-service withdrawals at age 59½ and hardship withdrawals are also permitted, subject to provisions described in the Plan document. The participant may elect to receive a lump-sum distribution or periodic payments as defined in the Plan provisions.

Administrative Costs

Plan fees and administrative expenses are paid by the Plan and Company on a discretionary basis.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$2,944 and \$2,832, respectively. Forfeitures may be used to reduce employer contributions or pay Plan expenses. During 2024, no forfeitures were utilized to reduce employer contributions or pay Plan expenses.

Note 2 – Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting.

Estimates

The preparation of financial statements in conformity with generally accepted accounting principles in the United States of America requires Plan management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Valuation of Investments and Revenue Recognition

The Plan's investments are recorded at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for a full discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near-term and such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Notes from Participants

Notes from participants are reported at their unpaid principal balances plus any accrued but unpaid interest.

Benefit Payments

Benefits are recorded when paid.

Note 3 – Fair Value Measurements

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with those of other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consists of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs consist of unobservable inputs and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs are used only when Level 1 or Level 2 inputs are not available.

The following table sets forth by level, within the fair value hierarchy, the Plan's assets at fair value as of December 31, 2024 and 2023. Classification within the fair value hierarchy table is based on the lowest level of any input that is significant to the fair value measurement.

Level 2 Fair Value Measurements

The fair value of the common collective fund is based on the market value of underlying investments. The common collective fund contains synthetic guaranteed investment contracts and certain wrapper contracts comprised of both underlying investments and contractual components. This fund invests in securities that have observable Level 2 pricing inputs, including quoted prices for similar assets in active or non-active markets. Level 2 inputs may also include insignificant adjustments to market observable inputs.

While the underlying asset values are quoted prices, the net asset value (NAV) of a unit in this fund is not publicly quoted. Units can be issued and redeemed on any business day at the NAV. All earnings and losses are reflected in the computation of the NAV and are realized by the participant upon withdrawal.

Note 4 – Investment Contracts

At December 31, 2023, the Plan had investments in the Invesco Stable Asset Fund. Included in the Fund were synthetic guaranteed investment contracts and certain wrapper contracts. These contracts were considered to be benefit-responsive and were required to be stated at fair value. The Fund invested 100% of its assets in ADPZ units of Invesco Stable Value Trust. The average yield for the fund for 2023 was approximately 2.75%. The yield earned by the fund with an adjustment to reflect the actual interest rate credited to participants at December 31, 2023 was 4.03%. The percentage of contributions allocated to the fund was determined by the participants.

At December 31, 2024, the Plan has investments in the Invesco Stable Value Trust. Included in the Fund are synthetic guaranteed investment contracts and certain wrapper contracts. These contracts are considered to be benefit-responsive and are required to be stated at fair value. The average yield for the fund for 2024 was approximately 4.98%. The yield earned by the fund with an adjustment to reflect the actual interest rate credited to participants at December 31, 2024 was 3.30%. The percentage of contributions allocated to the fund is determined by the participants.

Note 5 – Related Party Transactions

Certain administrative functions are performed by employees of the Company. No such employee receives compensation from the Plan.

Fees paid to the Trustees by the Plan for administrative services for the year ended December 31, 2024 were \$18,561.

Note 6 – Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Note 7 – Tax Status

Effective November 1, 2024, the Plan is adopted under a non-standardized pre-approved plan sponsored by John Hancock Retirement Plan Services, LLC. The Internal Revenue Service (IRS) has determined and informed the Company by a letter dated June 30, 2020, that the Plan is designed in accordance with applicable sections of the *Internal Revenue Code (IRC)*. The Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the *IRC*.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

Effective January 1, 2025, PRN employees were excluded from plan participation, however, the SECURE 2.0 Act requires employers to allow long-term and part-time workers to participate in the Plan. The SECURE Act provision provides that the Plan must have a dual eligibility requirement under which an employee must complete either 1 year of service (with the 1,000-hour rule) or 2 consecutive years of service (where the employee completes at least 500 hours of service), effective for plan years beginning after December 31, 2024. The Plan will be amended to incorporate this requirement.
