NOTE 1 - DESCRIPTION OF PLAN

The Dakota Specialty Enterprises Retirement Plan (the Plan) includes the employees of Dakota Specialty Milling, Inc., Dakota Blenders, LLC, and Roman Meal Company (the Companies).

The following description of the Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan, also known as a salary reduction or 401(k) plan. All employees of the Companies are considered eligible to participate in the Plan except for the following classes of employees: (1) any employee covered by a collective bargaining agreement; (2) leased employees; (3) any employee of affiliated employers which do not adopt this Plan; and (4) employees classified as independent contractors. There are no age or service requirements to become eligible to participate in the Plan. Employees are eligible to enter the Plan as a participant on their employment commencement date. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Each year, employees may contribute the maximum allowed under Internal Revenue Code Section 402(g). The Companies may elect to make a discretionary matching contribution and profit sharing contribution for each Plan year. For the year ended December 31, 2024, the Companies made a matching contribution to each eligible participant's account equal to 100% of the participant's contribution. The maximum contribution amount eligible to be matched is 5% of eligible compensation.

The Plan provides for an auto-enrollment arrangement whereby all new employees are automatically enrolled in the Plan, unless they affirmatively elect not to participate, with a default deferral rate set at 3% of eligible compensation for years prior to January 1, 2022 and 5% for employees who become eligible to make contributions on or after January 1, 2022. The Plan will also automatically increase this percentage annually by 1% of the participant's compensation up to a maximum of 5%, unless the participant elects a deferral percentage at the time they first participate in the plan.

The Companies may make a discretionary profit sharing contribution to the Plan. Any profit sharing contributions would be allocated to all employees eligible to participate in the Plan. The Companies approved profit sharing contributions of \$96,697 and \$261,779 to the Plan for the years ended December 31, 2024 and 2023, respectively.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of the Companies' contributions and Plan earnings. Allocations are based on participant earnings or account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investment of their account balances into various investment options offered by the Plan. Automatically enrolled participants have their contributions invested in a target date fund closest to the year the participant will turn 65 years old unless the participant chooses a different fund.

Vesting

Participants are immediately vested in their salary deferral contributions. Vesting in the Companies' matching and profit sharing contribution portion of their accounts and any earnings thereon is based on their years of service, determined as follows:

Payment of Benefits

A participant's account is payable to the participant, or the participant's beneficiaries, in full according to the terms of the Plan upon death, permanent disability or termination of employment after the normal retirement age of 65 years old. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. For vested interests of \$1,000 or less, the account will be distributed in a lump sum as soon as administratively practicable after date of termination.

Effective January 1, 2024, the Plan was amended to permit hardship withdrawals and related provisions, including a limit of two hardship withdrawals per year, a \$500 minimum withdrawal amount, and primary beneficiary hardship withdrawals.

Forfeitures

Forfeitures are used to reduce the employer's discretionary contributions or plan expenses. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$11,247 and \$12,416, respectively. During 2024, \$142,242 was used to reduce employer contributions.

Other Income

In 2018, the Plan entered a revenue-sharing agreement with T. Rowe Price. Under the terms of the agreement, T. Rowe Price will provide the Plan with an administrative budget each year, which shall be established as an account in the trust in accordance with directions provided by the Plan Sponsor. The administrative budget may be used to pay certain administrative expenses of the Plan, as defined in Section 402(a)(2) of ERISA. Any amounts credited to the administrative budget and not used in the year so credited shall be allocated as determined by the Plan Sponsor. During 2024, there was an allocation of the administrative budget to participant accounts in the amount of \$26,519.

NOTE 2 - SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value, except for fully-benefit-responsive investment contracts, which are to be reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's 401(k) Advisory Committee determines the Plan's valuation policies utilizing information provided by the investment advisers and custodians. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service are recorded as a liability, with a corresponding decrease to contributions if paid before March 15 of the following year or an increase to distributions if paid after March 15 of the following year. The Plan distributed the 2024 excess contributions, in the amount of \$5,337, prior to March 15, 2025. The Plan distributed the 2023 excess contributions, in the amount of \$14,675, on March 11, 2024.

Payment of Benefits

Benefits are recorded when paid.

Plan Administration Costs

Expenses not paid by the Plan sponsor are paid by the Plan, and may be charged directly to the account of the participant on whose sole behalf the expense is incurred.

Evaluation of Subsequent Events

Management has reviewed subsequent events through October 3, 2025, which is the date that the financial statements were available to be issued.

NOTE 3 - FAIR VALUE MEASUREMENTS

The Fair Value Measurements Topic 820 of the FASB Accounting Standards Codification (ASC) establishes a fair value hierarchy for reporting that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority; Level 2 inputs consist of observable units other than quoted prices for identical assets; and Level 3 inputs have the lowest priority. The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds

The investments in mutual funds are valued utilizing a market approach wherein the Plan uses the quoted prices in the active market for identical assets. All of these investments are traded in active markets.

NOTE 4 - COMMON COLLECTIVE TRUST FUND

The Plan is invested in the T. Rowe Price Stable Value Common Trust Fund which is a stable value fund composed primarily of synthetic guaranteed investment contracts. Stable value funds seek to provide income while preventing price fluctuations. They invest in a diversified portfolio of bonds and enter into wrap contracts with financial companies to guarantee against fluctuations in their share prices. The account is credited with contributions and earnings on the underlying investments and charged for participant withdrawals and administrative expenses. These investments meet the fully benefit-responsive investment contract criteria and therefore are reported at contract value on the Statement of Net Assets Available for Benefits.

Contract value, as reported to the Plan by the Trustee, represents contributions, plus earnings, less participant withdrawals and administrative expenses. Benefit-responsive investment contracts are designed to permit participant withdrawals in accordance with the Plan to occur at contract value. However, withdrawals that result from certain actions initiated by the Plan Sponsor, such as bankruptcy filings, Plan or fund terminations, and certain layoffs or early retirement programs, may be paid at market value, which could be less than contract value depending on the performance of the assets underlying the Fund's wrap contracts.

In addition to certain contract termination provisions discussed below, the contracts provide for withdrawals associated with certain events which are not in the ordinary course of Plan operations, and in some cases that the issuer determines will have a material adverse effect on the issuer's financial interest, will be paid with a market value adjustment to the contract value amount of such withdrawal as defined in such contracts. While each contract issuer specifies the events which may trigger such a market value adjustment, such events typically include all or some of the following: (1) amendments to the Plan documents or Plan's administration, including reduction or elimination of employer matching contributions; (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions; (3) complete or partial termination of the Plan or its merger with another plan; (4) the failure of the Plan or its trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA; (5) unless made in accordance with the withdrawal provisions of the Plan, the withdrawal from the contract resulting from an event at the direction of the Plan Sponsor; (6) any change in law, regulation, ruling, administrative or judicial position or accounting requirement, in any case applicable to the Plan or Fund, and (7) the delivery of any communication to Plan participants designed to influence a participant not to invest in the Fund.

At this time, the Plan Sponsor does not believe that the occurrence of any such events that would limit the Plan's ability to transact at contract value with participants is probable.

NOTE 5 - INFORMATION CERTIFIED BY T. ROWE PRICE TRUST COMPANY

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments, and dividends for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by T. Rowe Price Trust Company, the trustee of the Plan.

NOTE 6 - PLAN TERMINATION

Although they have not expressed any intent to do so, the Companies have the right under the Plan agreement to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts. Any unallocated assets of the Plan shall be allocated to participant accounts and distributed in accordance with the Plan provisions.

NOTE 7 - TAX STATUS

The Plan obtained its latest opinion letter on August 19, 2020, based on a Volume Submitter plan, in which the Internal Revenue Service stated that the Plan, as designed, was in compliance with the applicable requirements of the Internal Revenue Code. Although the Plan has been amended since receiving the opinion letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service or Department of Labor. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Sponsor has filed its Form 5500 return timely with the Department of Labor. The Plan administrator believes it is no longer subject to income tax examinations for tax years prior to 2021.

NOTE 8 - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

The Plan currently offers various investment options issued by T. Rowe Price Trust Company, who serves as the trustee, as defined by the Plan, for the years ended December 31, 2024 and 2023. Therefore, these transactions are recognized as party-in-interest transactions. In addition, the Plan paid certain expenses to various service providers. These expenses are exempt party-in-interest transactions under ERISA.

NOTE 9 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
