December 31, 2024 and 2023

Note 1 - Plan Description

The following description of Orthopedic Care Partners 401(k) and Profit Sharing Plan (the "Plan") provides only general information. Participants and all others should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan established on January 1, 2005. The Plan is available to all employees of Orthopedic Care Partners; Joint Health LLC d/b/a Motion Orthopedic; The Orthopedic Institute, P.A.; Tucson Orthopedic Institute, P.C.; Wentzville Surgery Center LLC; Lawrence G. Robinson, M.D. PA; and Rosenberg, Cooley, Metcalf, L.C. (collectively, the "Company") except those covered by collective bargaining agreements and nonresident aliens. An employee becomes eligible upon the first day of the calendar month following the completion of one month of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Company administers the Plan. John Hancock Trust Company LLC (John Hancock) serves as the custodian, recordkeeper, and manager of plan assets. John Hancock offers plan participants a variety of investment options through mutual funds. Individual accounts are invested in the various investment options at the direction of the participants.

Contributions

Participants may make before-tax and after-tax (Roth) contributions up to 100 percent of their annual eligible compensation subject to limitations established by the Internal Revenue Service (IRS), which is adjusted annually by the secretary of the Treasury for inflation. This maximum percentage may be reduced by the plan administrator in certain circumstances. The Plan permits rollover contributions. Employee contributions to the Plan are made through regular payroll deductions.

The Plan includes a safe harbor match contribution provision. Under the provision, the Company contributes 100 percent of the first 4 percent of participants' eligible compensation elective deferrals on a pay-period basis. Participants must have completed one year of service to be eligible for the employer matching contributions. The Company has the right to designate all or a portion of the matching contributions as qualified.

The Company may also make discretionary profit-sharing contributions to the Plan. Discretionary profit-sharing contributions are allocated to each participant eligible to share in such allocations after the end of the plan year. Such contributions are allocated in an amount designated by the Company to each eligible participant in a manner determined by the Company. Participants must have completed one year of service to be eligible for the discretionary profit-sharing contributions. In addition, a participant must be either employed on the last day of the plan year or have worked 500 hours in the plan year to receive profit-sharing contributions. The Company may designate all or a portion of any profit-sharing contributions as qualified nonelective contributions and allocate them to non-highly compensated employees. For the plan year ended December 31, 2024, the Company made \$3,622,439 of discretionary profit-sharing contributions and \$3,979,128 of matching contributions, net of forfeitures.

Participant Accounts

Each participant's account is credited or debited with the participant's contributions and withdrawals, as applicable, and an allocation of the Company's contributions, plan earnings or losses, forfeitures, and plan expenses. Allocations are based upon plan earnings or losses and account balances, as defined by the Plan. The benefit to which a participant is entitled is the vested portion of the participant's account.

Vesting

Participants are 100 percent vested in their voluntary contributions, employer safe harbor matching contributions, allocated earnings or losses thereon, and any qualified matching contributions.

A participant's account becomes 100 percent vested upon death, attaining normal retirement age (the age of 65 or, if later, the fifth anniversary date of the first day of the plan year during which the participant entered the Plan) while an employee, retirement due to disability, or termination of the Plan.

Participant Notes Receivable

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balances. Participants may have a maximum of two loans outstanding at any given time. The loans are secured by the balances in the participants' accounts and bear interest at rates that range from 3.25 percent to 9.50 percent, which are commensurate with local prevailing rates determined quarterly by the plan administrator at loan origination, and mature at various dates through December 2029. Loans have a maximum term of five years, unless such loan is for the purchase of the participant's primary residence, which may be repaid over a longer period permitted by the plan administrator. Principal and interest are paid ratably through payroll deductions. Upon termination of a participant from employment, the participant's loan shall continue to be payable in accordance with the provisions of the participant's loan or be due in full.

Benefit Payments

Upon death, disability, retirement, or termination of service, a participant or his or her beneficiary may elect a lump-sum distribution equal to the participant's vested account balance.

The Plan allows in-service distributions and partial distributions to participants age 45 or older who have not terminated employment with the plan sponsor. The Plan also provides for hardship withdrawals for defined hardship events. Furthermore, the Plan allows for terminated participant vested account balances of \$1,000 or less to be automatically distributed and balances of \$1,000 to \$5,000 to be automatically rolled out of the Plan into an IRA in the name of the participant. The Plan allows for in-service distributions and partial distributions once participants have attained age 59½.

Forfeitures

If, at the time of termination of employment, the participant is not 100 percent vested, the nonvested portion (forfeitures) of the participant's account shall be placed in a separate account. Forfeitures can be used to pay plan expenses, reduce employer contributions, or allocated to participants in the same manner as the employer's contributions.

Administration

The Company provides, at no cost to the Plan, certain administrative, accounting, and legal services to the Plan and also pays the cost of certain outside services for the Plan.

Note 1 - Plan Description (Continued)

Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA. If the Plan is terminated for any reason, all participants become 100 percent vested, and the plan administrator is to distribute each participant's interest to the participant or the participant's beneficiary.

Party-in-interest Transactions

The Plan provides for notes receivables to participants, which are party-in-interest transactions that are exempt from the prohibited transaction rules.

Note 2 - Summary of Significant Accounting Policies

Investment Valuation and Income Recognition

Investments held by the Plan are stated at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for further discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date.

Participant Notes Receivable

Participant notes receivable are recorded at their unpaid principal balances plus any accrued interest. Participant notes receivable are written off when deemed uncollectible.

Benefit Payments

Benefits are recorded when paid.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

Subsequent Events

The financial statements and related disclosures include evaluation of events up through and including October 8, 2025, which is the date the financial statements were available to be issued.

Note 3 - Certified Information

John Hancock holds the Plan's investments and participant notes receivable and executes all related transactions. The investment and participant notes receivable balances and related income and losses included in the accompanying financial statements and supplemental schedule of assets held at end of year are based solely on information certified by the custodian.

Note 4 - Tax Status

The Plan uses a preapproved plan. The preapproved plan has received a favorable opinion letter from the IRS indicating that the Plan, as designed, is qualified for federal income tax-exempt status. The Plan has not individually sought its own determination letter.

Note 5 - Fair Value Measurements

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset. These Level 3 fair value measurements are based primarily on management's own estimates using pricing models, discounted cash flow methodologies, or similar techniques taking into account the characteristics of the asset.

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan's assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.

The Plan measures investments at fair value on a recurring basis. The fair value of mutual funds is based primarily on Level 1 inputs as of December 31, 2024 and 2023.

Note 6 - Plan Merger

Effective July 1, 2024, the Rosenberg, Cooley, Metcalf, L.C. Retirement Plan merged with the Plan. Accordingly, all assets, participant notes receivable, and related account balances totaling approximately \$9.2 million were transferred into the Plan in 2024. During 2024, the Plan completed an additional merger, resulting in the transfer of approximately \$650,000 in total assets, including participant notes receivable and related account balances.
