INDEPENDENT AUDITOR'S REPORT

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Greenleaf Corporation Savings and Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.



1. Description of the Plan

The following description of the Plan provides only general information. Participants should refer to the Summary Plan Description for a more complete description of the Plan's provisions.

General

The Plan is a single employer defined contribution 401(k) plan covering all eligible employees of Greenleaf Corporation (the Plan Sponsor). Employees must be employed twelve months and have completed 1,000 hours of service as of the last day of the year to be eligible to participate in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Contributions

The Plan allows for participant contributions, made on a tax-deferred basis under Section 401(k) of the Internal Revenue Code of an amount equal to a dollar amount or percentage of the participant's compensation, not to exceed the limits imposed by Section 401(k) of the Internal Revenue Code (IRC). The Plan also allows participants to make Roth after-tax contributions. Participants may also make a rollover contribution from other qualified plans. The Plan Sponsor can make matching contributions as well as discretionary lump-sum contributions, as determined by the Board of Directors. No discretionary contributions were recorded for the years ended December 31, 2024 and 2023. The Plan Sponsor matched 60% of each employee's contributions up to 3% of the employee's compensation for 2024 and 2023.

Investment of Participant Contributions

All participant contributions and Plan Sponsor matching and discretionary lump-sum contributions are deposited into the Cash Management Trust Fund until they are transferred to the investment accounts based on each participant's direction. As a result, the Cash Management Trust Fund is considered in these financial statements as a nonparticipant-directed investment. This fund is not an investment option and is used as a holding fund for unallocated Plan Sponsor and participant contributions. At December 31, 2024 and 2023, no contributions were held in the Cash Management Trust Fund. Income, expenses, gains and losses of the Plan are allocated to each participant's account based on the relationship of each participant's account to the total of all participants' accounts. Participant and Plan Sponsor matching contributions are allocated to participant accounts based on fund allocation percentages selected by each participant. Additional discretionary lump-sum contributions made by the Plan Sponsor are allocated to participants' accounts based on participant compensation.

Vesting

Participant and Plan Sponsor matching contributions are immediately 100% vested to the participant. Additional discretionary profit sharing contributions are subject to a vesting schedule of 20% after two years of service, which increases 20% each year thereafter with full vesting after six years of service.

Notes Receivable from Participants

Participants may borrow from their account a minimum of \$1,000 to a maximum equal to the lesser of (a) \$50,000, minus the highest outstanding loan balance in the last 12 months, or (b) one-half of the vested value of the participant's account. The eligible portion of the participant's account must be invested in mutual funds and may not include Roth deferrals. Participants cannot have no more than two loans outstanding at any time. Each loan is secured by the participant's account and bears interest at a rate based on the prime rate on the date of the loan.

1. Description of the Plan (continued)

Payment of Benefits

Upon termination of service, a participant is entitled to the vested portion of his or her account. Participants are also able to take in-service withdrawals prior to termination of service, provided the participant has attained age 59 1/2. Under certain circumstances, the Plan permits participants to take hardship withdrawals. Distributions are required to be paid upon the participant's election, in a single payment, no later than sixty days after the end of the plan year in which the benefit becomes payable. Benefits are recorded when paid.

Administrative Expenses

The Plan is responsible for payment of administrative expenses not paid by the Plan Sponsor. These expenses are not material to the Plan's financial position and results from operations. For years ended December 31, 2024 and 2023, the Plan paid advisory, recordkeeping, and certain fund management fees out of a separate account within the Plan, characterizing these fees as administrative fees.

Forfeitures

Forfeitures are created when participants terminate employment before becoming entitled to their full benefits under the Plan. Based on the discretion of the Plan Sponsor, these forfeited amounts can be used to reduce the Plan Sponsor's contributions to the Plan or pay Plan expenses. The forfeiture amount used to reduce employer contributions during the years ended December 31, 2024 and 2023 totaled \$2,067 and \$4,776, respectively. The unallocated forfeiture balance totaled \$2,114 and \$411 at December 31, 2024 and 2023, respectively.

Plan Termination

Although it has not expressed intent to do so, the Plan Sponsor has the right to terminate the Plan, subject to provisions of ERISA. Should such a termination occur, each participant would be fully vested in their interest in the Plan, and the value of each participant's account will be paid as directed by the Plan Sponsor.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Investment Valuation and Income Recognition

The Plan's investments are held by Ascensus Trust Company, the trustee of the Plan as of and for the years ended December 31, 2024 and 2023. Financial information relating to the assets is included in the accompanying financial statements based on information provided by Ascensus as agent for the Trustee.

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Investments in common/collective trust funds are reported at Net Asset Value ("NAV"). The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. This practical expedient is not used when it is determined to be probable that the Plan will sell the investments for an amount different from the reported NAV. See Note 4 for discussion of fair value and NAV measurements.

2. Summary of Significant Accounting Policies (continued)

Investment Valuation and Income Recognition (continued)

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Use of Estimates

The preparation of the financial statements in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect amounts reported in the financial statements and related disclosures. Actual results could differ from those estimates.

Subsequent Events

The Plan has evaluated subsequent events through October 9, 2025, the date the financial statements were available to be issued.

Effective January 1, 2025, the Plan Sponsor amended certain Plan provisions. The eligibility service requirement was changed from one year of service to one month of service in respect to employee pre-tax elective deferrals, Roth elective deferrals, and employer profit sharing contributions. The service requirement for employer matching contributions was modified from one year of service to four consecutive months of eligible service. Entry dates for Plan enrollment have been changed from quarterly to monthly. The Plan will also utilize automatic elective deferral enrollment starting at 3%, with no automatic escalation. The Plan has established automatic force out distributions for terminated participants in accordance with Section 401(a)(31).

3. Information Prepared and Certified by Trustee

The investment assets of the Plan were held by Ascensus Trust Company, the trustee of the Plan, as of and for the years ended December 31, 2024 and 2023. The summary of financial data has been certified by Ascensus as agent for the trustee, as of and for the years ended December 31, 2024 and 2023. The Plan Administrator elected the method of compliance permitted under ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting Disclosures under ERISA. The financial information certified by the agent of the trustee has been adjusted to reflect minor timing differences related to U.S. GAAP basis financial statement presentation.

4. Fair Value Measurements

Investments are recorded at estimated fair value, in accordance with the Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) Fair Value Measurements and Disclosures topic. This topic establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under the FASB ASC Fair Value Measurements and Disclosures topic are described as follows:

4. Fair Value Measurements (continued)

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs to the valuation methodology include:
- Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability;
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.
- If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds – registered investment companies: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common/collective trust: The Invesco Stable Value Trust Fund (The Fund) is a collective trust fund that is valued at the NAV of the units of the collective trust fund held by the Plan at the year-end times the respective unit value. The NAV, as provided by the trustee, is used as practical expedient to estimate fair value. The NAV of the collective trust fund is based upon significant observable inputs, although it is not based upon quoted market prices in an active market. The collective trust fund's investment objective is to seek the preservation of capital and to provide a competitive level of income over time that is consistent with the preservation of capital. To achieve its investment objective, the collective trust fund invests in assets (typically contracts issued by insurance companies and banks, synthetic investment contracts and short-term investments) and enters into "wrapper" contracts issued by third-parties and invests in cash equivalents represented by shares in a money market fund.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date. The following tables set forth by level, within the fair value hierarchy, the Plan's investments at fair value as of December 31, 2024 and 2023:

5. Related Party Transaction

Certain Plan investments are held in a contribution account managed by Ascensus Trust Company. Ascensus Trust Company is the trustee as defined by the Plan, and therefore, these transactions qualify as party-in-interest transactions.

6. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

7. Tax Status

The Plan has received an opinion letter from the Internal Revenue Service dated June 30, 2020 stating that the written form of the plan document is qualified under Section 401(a) of the IRC, and that any employer adopting this form of the Plan will be considered to have a plan qualified under Section 401(a) of the Code. The Plan has been amended since receiving the opinion letter. Plan management believes the Plan is operating in compliance with the IRC. Therefore, the related trust is exempt from taxation.

During 2023 and in 2022, the Plan Sponsor failed to remit various participant elective deferral contributions and loan repayments to the plan in a timely manner as required by the Department of Labor (DOL). These delinquent contributions and loan repayments totaled \$65,142 and \$151,037. The Plan Sponsor is in the process of remitting lost earnings to participants resulting from these untimely remitted deferrals and loan repayments. The lost earnings calculation is in the process of being finalized by the Plan's recordkeeper. The correction of this failure is intended to be corrected under the Internal Revenue Service (IRS) Employee Plans Compliance Resolution System (EPCRS) Self-Correction Program (SCP). The Plan's Administrator believes the necessary steps are in place to properly correct the error and maintain the Plan's qualified status to operate in compliance with the IRC.

Management has evaluated the Plan's tax positions related to the uncertainty in income taxes and concluded that the Plan had maintained its tax-exempt status and had taken no uncertain tax positions that require adjustment to the financial statements. Therefore, no provision or liability for income taxes has been included in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Sponsor believes it is no longer subject to income tax examinations for years prior to 2021.
