### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audits*

We have performed audits of the financial statements of the PJTC Holdings, Inc. 401(k) Savings and Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for plan benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for plan benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the investment information is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### *Opinion*

In our opinion, based on our audits and the procedures performed as described in the Auditor's Responsibilities for the Audits of the Financial Statements section of our report:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP); and
- The certified investment information in the accompanying financial statements agrees to, or is derived from, in all material respects, the information prepared and certified by a qualified institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).



### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audits of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. ### 1. Description of the Plan

The following description of the PJTC Holdings, Inc. 401(k) Savings and Profit-Sharing Plan (the Plan) provides only general information. Participants should refer to the plan document for complete information and description of the Plan's provisions.

#### *General*

The Plan is a defined contribution savings and profit sharing plan covering all of the qualifying employees of PJTC Holdings, Inc. and participating employers (collectively, the Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

#### *Contributions*

Each year, participants may contribute up to 100% of eligible compensation, as defined by the plan document, up to the maximum limits of the Internal Revenue Code (IRC). Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participant contributions to the Plan are recorded in the period that payroll deductions are made from participants. In addition, the Company may make discretionary matching contributions equal to a uniform percentage of participant salary deferrals. The Company matched 100% of the first 1% and 50% of the next 4% of a participant's contributions for the year ended December 31, 2024. Contributions are subject to certain limitations.

#### *Contributions - Profit Sharing*

The Company may contribute, at the discretion of the Board of Directors, up to 15% of eligible pre-tax annual compensation. Contributions are subject to certain limitations. The 2024 profit sharing contribution receivable of \$10,250,238 was made in August 2025.

#### *Investment Options*

Participants self-direct the investment of their accounts, choosing from various mutual funds, a collective investment fund, and self-directed brokerage accounts.

#### *Participant Accounts*

Each participant's account is credited with the participant's contributions, investment earnings, and allocations of (a) the Company's discretionary matching and profit sharing contributions and (b) charged with an allocation of administrative expenses. With the exception of profit sharing contributions, allocations are based on account balances. Profit sharing allocation is based upon eligible compensation. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### *Vesting*

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's discretionary matching and profit sharing contributions is based on years of

continuous service. The discretionary matching contributions vest 20% each year of credited service and become fully vested after five years. The profit sharing contributions become 20% vested after two years of credited service and vest 20% each year thereafter before becoming fully vested after six years. In the event of an active participant's death prior to normal retirement age, the vesting percentage is 100%.

### ***Notes Receivable from Participants***

Participants may borrow from their fund accounts up to a maximum of \$50,000 or 50% of their account balance, whichever is less. Borrowings are secured by the balance in the participant's account and bear interest at the prevailing rate at the time of the loan. Principal and interest is paid through payroll deductions, with the loan amortized, from one to five years or greater for the purchase of a primary residence.

### ***Payment of Benefits***

Upon termination of service due to death, disability or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested account interest, installment payments, or partial payments.

Upon termination of service, former participants in the Lindy Company Profit Sharing Plan, which was merged into the Plan effective April 1, 1998, unless otherwise elected, will receive either a life or a joint and survivor annuity, depending on marital status, based on the existing balance at the time of merger.

A participant may request a withdrawal from their account based upon financial hardship or at age 59 1/2, as defined by IRC regulations.

### ***Forfeitures***

Forfeited non-vested accounts totaled approximately \$161,000 and \$148,000 at December 31, 2024 and 2023, respectively. These accounts will be used to reduce plan expenses or future employer contributions. In 2024, employer contributions were reduced by approximately \$243,640 from forfeited non-vested accounts.

### ***Plan Termination***

Although it has not expressed any intent to do so, the Company has the right to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their Company contributions.

## **2. Summary of Significant Accounting Policies**

### ***Basis of Accounting***

The financial statements of the Plan are prepared on the accrual basis of accounting.

### *Use of Estimates*

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires Plan management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### *Investment Valuation and Income Recognition*

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (Note 3). Plan management determines the valuation policies utilizing information provided by Ascensus Trust Company and Newport Trust Company for the year ended December 31, 2024 and 2023, respectively.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### **Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for plan benefits.

### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable are reclassified as distributions based upon the terms of the plan document.

### **Investment Management Fees and Operating Expenses**

Investment management fees and operating expenses charged to the Plan for investments in the various funds are deducted from income earned on a daily basis and are reflected as a component of net appreciation in the fair value of investments.

### **Administrative Expenses**

Administrative expenses are paid by the Company or the Plan, as provided by the plan document.

### **Payment of Benefits**

Benefits are recorded when paid.

### Subsequent Events

The Plan evaluated subsequent events for recognition or disclosure through October 9, 2025, the date the financial statements were available to be issued.

### 3. Investments

Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The framework that the authoritative guidance establishes for measuring fair value includes a hierarchy used to classify the inputs used in measuring fair value. The hierarchy prioritizes the inputs used in determining valuations into three levels. The level in the fair value hierarchy within which the fair value measurements fall is determined on the lowest level input that is significant to the fair value measurement.

The levels of the fair value hierarchy are as follows:

*Level 1* - This level consists of inputs that are unadjusted quoted prices in active markets that are accessible to the Plan for identical assets. These generally provide the most reliable evidence and are used to measure fair value whenever available.

*Level 2* - This level consists of inputs other than Level 1 inputs, that are observable either directly or indirectly for substantially the full term of the asset through corroboration with observable market data. Level 2 inputs include quoted market prices in active markets for similar assets or liabilities, quoted market prices in inactive markets for identical or similar assets, and other observable inputs.

*Level 3* - This level consists of inputs that are unobservable inputs. Examples of valuation methodologies that would result in Level 3 classification include option pricing models, discounted cash flows, and similar techniques.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds are public investment vehicles valued using the net asset value (NAV) provided by the administrator of the fund on the last day of the Plan's year end using a quoted price in an active market and are classified within Level 1 of the fair value hierarchy.

Self-directed brokerage accounts consist of cash and cash equivalents, equities, and mutual funds. Cash and cash equivalents are valued at cost plus accrued interest, which approximates fair value. Equities are valued at the closing price reported on the active market on which the individual securities are traded. Mutual funds are valued at the daily NAV as reported by the fund. The mutual funds held by the Plan are deemed to be actively traded.

The Plan holds an interest in the T. Rowe Price Stable Value Fund (the Stable Value Fund), which is a common collective trust fund that primarily invests in fully benefit-responsive investment contracts. The fund is valued at the NAV provided by the trustee on the last day of the Plan's year end. NAV is used as a practical expedient to estimate fair value. Redemption is permitted daily with a required 12 month notice period that is only applicable to the Plan, with no other restrictions.

There are no unfunded commitments. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. The objective of the Stable Value Fund is to maximize current income while maintaining the stability of principal. Participant-directed redemptions have no restrictions.

## 4. Certification of Investment Information

Certain information disclosed in the accompanying financial statements and ERISA-required supplemental schedule related to investments and notes receivable from participants held as of December 31, 2024 and December 31, 2023; and net appreciation in fair value of investments, interest and dividends; and interest income and notes receivable from participants was obtained by management and agreed or derived from information certified as complete and accurate by qualified institutions, Newport Trust Company, LLC as of December 31, 2023 and from January 1, 2024 to November 13, 2024, and Ascensus, LLC, as an authorized representative of Ascensus Trust Company and Newport Trust Company, LLC, as of December 31, 2024 and from November 13, 2024 through December 2024.

## 5. Related Party and Party-in-interest Transactions

Certain Plan investments are in funds and accounts that are managed by Ascensus Trust Company or their subsidiaries and affiliates. Participant loan and distribution processing fees are paid to Ascensus by participants. The Plan also issues loans to participants which are secured by the vested balance of the participants' accounts. As described in Note 1, the Plan paid certain expenses related

to plan operations and investment activity to various service providers. These transactions are party-in-interest transactions, which are exempt from prohibited transaction rules.

### **6. Tax Status**

The Company adopted the pre-approved plan document with Newport Group Inc. Newport Group Inc obtained a letter dated June 30, 2020, in which the Internal Revenue Service (IRS) stated that the plan, as then designed, was in compliance with the applicable requirements of the IRC The Plan has been amended since receiving the determination letter. However, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions: however, there are currently no audits for any tax periods in progress.
