## 1. Description of the Plan

The following description of the Woodmeister Master Builders 401(k) Profit Sharing Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

### *General*

The Plan, which was adopted on April 1, 1985 and amended from time to time thereafter, is a defined contribution plan covering all full-time employees of Woodmeister Master Builders, Inc. (the “Company”) and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

On December 29, 2022, President Biden signed into law the Consolidated Appropriations Act of 2023, which includes the package of retirement provisions referred to as “SECURE 2.0”). These provisions continue the themes and reforms that began with the 2019 SECURE Act, focusing on getting more participants into the retirement system, finding ways for them to accumulate more assets, and then ensuring they get connected with those assets when retirement comes. Many of the provisions of the SECURE 2.0 are effective on January 1, 2023, and beyond and will require significant changes to plan administration and recordkeeping.

### *Eligibility*

Substantially all employees of the Company who have reached the age of eighteen are eligible to participate in the Plan on the first day of the month following the date on which an employee meets the eligibility requirements, which is completion of three months of service.

### *Participant Contributions*

Each year, participants may elect to contribute, up to the maximum amount of eligible compensation allowed, to the Plan on a pre or post tax basis, up to 100% of eligible compensation. Participants may also rollover amounts representing distributions from other eligible retirement plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan, unless they affirmatively elect not to participate, with a default deferral rate set at 5% of eligible compensation. The Plan also includes annual automatic deferral increases of 1% (not to exceed 10% of compensation) for each active participant enrolled through automatic enrollment. Contributions are automatically invested in a designated balanced fund until changed by the participant.

### *Employer Contributions*

The Plan allows for employer matching contributions for all eligible Plan participants. The Plan also provides for the employer to make a discretionary profit-sharing contribution on an annual basis. For the years ended December 31, 2024 and 2023, there were no discretionary contributions.

## 1. Description of the Plan (Continued)

### *Participant Accounts*

Individual accounts are maintained for each Plan participant. Each participant's account is credited with the participant's contribution, and an allocation of the Company's discretionary contributions, if any, Plan earnings and charged with an allocation of any administrative expenses paid by the Plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### *Vesting*

Participants are immediately vested in their contributions plus actual earnings thereon. Participants vest 20% per year after the second year in the Company's matching and profit-sharing contributions. The participants are 100% vested in the Company's matching and profit sharing contributions after six years.

### *Investment Elections*

Participants direct the investment of their contributions, any Company matching contributions and any profit-sharing contributions into investment options offered by the Plan. Participants have the ability to change investment allocations at any time.

### *Notes Receivable from Participants*

The Plan allows participants to borrow amounts from \$1,000 up to a maximum of \$50,000 or 50% of their vested account balance, whichever is less. The loans are collateralized by the vested balance in the participant's account and bear interest at rates commensurate with local prevailing rates at the time funds are borrowed. Principal and interest is paid ratably through payroll deductions. The Plan allows a maximum of one loan outstanding per participant.

### *Benefit Payments and Plan Withdrawals*

Upon termination of employment, retirement, disability, or death, the participant or his or her beneficiary, in the event of death, is entitled to receive a distribution of the participant's entire vested balance. Participants who have attained age 59 1/2 may withdraw any portion of the vested balance in their account to the extent the balance is not required to secure the outstanding balance of a loan to the participant. Participants may request a withdrawal from their vested Company matching contributions for certain financial hardships that result from extraordinary medical expenses, educational expenses, expenses to purchase a principal residence, or costs to prevent eviction from or foreclosure on a principal residence. The Plan Administrator determines the existence of a hardship.

### *Forfeited Accounts*

Forfeitures represent the non-vested portion of terminated participants' account balances. Forfeitures occur in the Plan year that participants receive distributions of their

### *Forfeited Accounts (Continued)*

entire vested accounts or after five consecutive breaks (years) in vesting service. Forfeitures are retained in the Plan and can be used to reduce future administrative expenses payable under the Plan or reduce the contributions of the Company. At December 31, 2024 and 2023, unallocated forfeitures totaled \$19,268 and \$14,556, respectively. Also, in 2024 and 2023, \$13,500 and \$9,500 of Plan administrative fees were paid from the forfeiture account, respectively.

## 2. Summary of Significant Accounting Policies

### *Basis of Accounting*

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

### *Use of Estimates*

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### *Investment Valuation and Income Recognition*

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### *Net Change in Fair Value of Investments*

The Plan presents in the Statement of Net Assets Available for Benefits the net change in the fair value of investments, which consists of the realized gains or losses and the net unrealized increase on those investments.

### *Concentration of Credit Risk*

Financial instruments that potentially subject the Plan to concentrations of credit risk are part of the holdings in Plan's investments. Management believes that the Trustee maintains the Plan's investments with high credit quality institutions and attempts to limit the credit exposure to any particular investment.

### *Notes Receivable from Participants*

Notes receivable from participants are measured at their unpaid balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

### *Fair Value Measurements*

The Plan performs fair value measurements in accordance with accounting principles generally accepted in the United States of America. Please refer to Note 3 for fair value measurement disclosures associated with the Plan's investments.

### *Payments of Benefits*

The Plan records benefit payments to withdrawing participants when paid. Under the rules for preparation of Form 5500, the Plan's Form 5500 will reflect an accrual for the amount to be paid to participants who withdrew from the Plan prior to year-end, and who had requested a distribution which was approved but not yet paid at period end, if any. There were no unpaid distributions at December 31, 2024 or 2023.

### *Expenses*

Certain expenses of maintaining the Plan are paid by the Company and are therefore excluded from these financial statements. Investment-related expenses are included in net appreciation in fair value of investments. Fees for the administration of notes receivable from participants are included in administrative expenses and charged directly to the participant's account.

### *Subsequent Events*

The Plan Administrator has evaluated subsequent events through August 8, 2025, the date which the financial statements were available to be issued.

## 3. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurement) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 – Unadjusted quoted prices in active markets that are accessible at the measurement date for identical assets or liabilities

Level 2 – Quoted prices in markets that are not considered to be active or financial instruments for which all significant inputs are observable, either directly or indirectly.

Level 3 – Prices or valuations that require inputs that are both significant to the fair value measurement and unobservable.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended funds that are registered with the SEC. These funds are required to publish their daily net asset value and transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The following tables present by level, within the fair value hierarchy, the Plan investment assets at fair value, as of December 31, 2024 and 2023, respectively.

The Plan's policy is to recognize transfers between levels 1 and 2 and into and out of Level 3 as of the date of the event or change in circumstances that caused the transfer. For the years ended December 31, 2024 and 2023, there were no transfers between Levels 1 and 2 and no transfers into or out of Level 3.

### 4. Information Prepared and Certified by the Trustee (Unaudited)

The Plan's investments were held in trust and administered by Fidelity Management Trust Company (the trustee of the Plan). All investment information presented in the accompanying financial statements and supplemental schedules, including investments held and net appreciation in fair value of investments and interest and dividends, was obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by the Trustee.

### 5. Administrative Expenses

### 6. Plan Termination

Although it is the Company's intention that the Plan will be continued indefinitely, the Company may terminate the Plan at any time subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

### 7. Party-In-Interest

Certain plan investments are shares of mutual funds managed by affiliates of Fidelity Management Trust Company, the trustee, at December 31, 2024 and 2023. The Plan also issues loans to participants, which are secured by the balances in the participants accounts. Certain employees and officers of the Company, who are also participants in the Plan, perform administrative services to the Plan at no cost to the Plan. The accounting fees were \$13,500 for 2024 and 2023, and were paid or will be paid by the Plan through the forfeiture account and charged to the participants if necessary. Therefore, these transactions qualify as party-in-interest transactions.

## 8. Risks and Uncertainties

The Plan utilizes various investment instruments, including mutual funds. Investment securities, in general, are exposed to various risks, such as interest rate, credit and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and those changes could materially affect the amounts reported in the financial statements.

## 9. Tax Status of the Plan

The Company has adopted a prototype plan document and is relying on the prototype sponsor's advisory letter from the Internal Revenue Service dated June 30, 2020. The letter states that the prototype and related trust are designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). Although the prototype plan has been amended since receiving the advisory letter, the prototype sponsor and the plan administrator believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more-likely-than-not would not be sustained upon examination by the applicable taxing authorities. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2022.
