Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the Financial Statements

We have performed audits of the financial statements of Delta Industries, Inc. 401(k) Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

NOTES TO FINANCIAL STATEMENTS

Note 1. Description of the Plan

The following description of the Delta Industries, Inc. 401(k) Profit Sharing Plan (the "Plan") is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a safe harbor defined contribution profit sharing plan covering hourly and salary employees of Delta Industries, Inc. (the "Company"), who have completed one year of service, have been credited with at least 1,000 hours of service and are 21 years of age or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Contributions

The Plan permits eligible employees, through a salary deferral election, to make annual contributions of up to 50 percent of eligible compensation, subject to the limitations set forth in the Internal Revenue Code (the "Code"). Employees are automatically enrolled in the Plan on the first day of the first month following the date on which the employee meets the requirements for eligibility at 5 percent unless they opt out of the Plan. Participants may also transfer to the Plan certain vested account balances from other qualified plans, subject to regulatory requirements. Participants who have attained age 50 before the end of the Plan year are also eligible to make catch-up contributions. The Company makes matching contributions equal to 100 percent of each participant's elective contributions up to 3 percent of a participant's eligible compensation and 50 percent of each participant's salary deferral amounts from 3 percent to 5 percent of participant's eligible compensation. The Company may elect to contribute a discretionary amount to each participant's account. Such discretionary contributions are allocated to eligible participants by applying a uniform percentage to their eligible compensation. Eligible participants with eligible compensation exceeding the Social Security base are allocated an additional amount equal to the product of the uniform percentage and the excess eligible compensation over the Social Security base. The Company made discretionary profit-sharing contributions totaling \$150,000 for the year ended December 31, 2024. Participants direct the investments of their contributions into various investment options offered by the Plan.

Participant Accounts

Each participant's account is credited with the participant's contributions and Company's matching contributions, as well as allocations of the Company's discretionary profit-sharing contributions, Plan earnings and losses and is charged with an allocation of administrative expenses to the extent such expenses are paid by the Plan. Allocations are based on participant earnings or account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their voluntary contributions and Company matching contributions, plus earnings or losses thereon. Regardless of the years of employment, participants' Company contributions accounts become fully vested in the event of death, disability, or the attainment of age 65.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of (a) \$50,000 (reduced by any outstanding loan balance) or (b) 50 percent of their vested account balances (reduced by any outstanding loan balance). All loans are collateralized by the participants' account balances and are repayable over a period from one to five years (except for loans for the purchase of a principal residence) through payroll withholdings, unless the participant is paying the loan in full. The notes bear interest at rates that range from 4.25 percent to 9.50 percent for the year ended December 31, 2024. Loan interest rates are set at rates commensurate to rates available for bank loans of comparable risk with similar terms.

Payment of Benefits

Benefits are payable on termination, retirement, death, or disability. Benefits may be paid either by a lump-sum amount equal to the value of the participant's vested interest, monthly installments over a period of time ranging from 5 to 15 years, as elected by the participant or rolled over into a qualified plan subject to regulatory requirements. After attaining age 59½, a participant may elect to receive in-service distributions for all or a portion of his or her vested balance. Hardship distributions are also available from participants' elective deferral accounts, subject to regulatory requirements.

Forfeitures

Forfeitures, which result from participants withdrawing from the Plan prior to fully vesting in Company discretionary contributions, are used to pay Plan expenses and to offset future Company matching contributions. Forfeited amounts applied to reduce matching contributions or Plan expenses totaled \$17,128 for the year ended December 31, 2024. There were no unallocated forfeitures as of December 31, 2024 or 2023.

Note 2. Summary of Significant Accounting Policies

Basis of Presentation

The accompanying financial statements of the Plan have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Realized and unrealized gains and losses in the Plan's investments are included in net appreciation in fair value of investments in the statement of changes in net assets available for benefits.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Administrative expenses of the Plan, to the extent that the Company does not pay such expenses, are paid by the Plan. Expenses that relate to a specific participant may be allocated to such participant.

Note 3. Information Certified and Provided by Principal Life Insurance Company

Information related to investments disclosed in the accompanying financial statements and supplemental schedule, including notes receivable from participants held at December 31, 2024 and 2023 and net appreciation in fair value of investments for the year ended December 31, 2024, was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Principal Life Insurance Company ("Principal"), the custodian of the Plan.

NOTES TO FINANCIAL STATEMENTS

Note 4. Fair Value Measurements

The Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") Topic 820, *Fair Value Measurement*, provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under Topic 820 are described as follows:

- Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 – Inputs to the valuation methodology include:
 - quoted prices for similar assets or liabilities in active markets;
 - quoted prices for identical or similar assets or liabilities in inactive markets;
 - inputs other than quoted prices that are observable for the asset or liability;
 - inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Pooled separate accounts: Pooled separate accounts held by the Plan are invested in domestic and international stocks, mutual funds or fixed securities. These are primarily valued at net asset value ("NAV") per share based on quoted market prices of underlying investments (Level 2).

Collective investment trust: The collective investment trust includes the Principal Stable Value Signature Fund ("Fund") (Level 2). The Fund invests in conventional, synthetic and separate account investment contracts issued by life insurance companies, banks and other financial institutions. The Fund is valued at NAV, as reported by investment managers of the Fund and are supported by unit prices of actual purchases and sales occurring as of or close to the financial statement date resulting in a readily determinable fair value. Participant transactions and redemptions (purchases and sales) may occur daily. Withdrawals, other than for benefit payments and participant transfers to noncompeting options, require twelve months advance written notice. As of December 31, 2024 and 2023, there were no unfunded commitments.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5. Related Party Transactions and Party-In-Interest Transactions

Certain Plan investments are shares or units of a collective investment trust and pooled separate accounts managed by Principal. The Plan paid Principal \$103,557 for the year ended December 31, 2024 for certain administrative expenses. Principal is the custodian as defined by the Plan; therefore, these transactions qualify as party-in-interest transactions.

Note 6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan agreement to terminate the Plan at any time subject to the provisions of ERISA. If terminated, participants would become 100 percent vested in the Company discretionary contribution portions of their accounts and the net assets of the Plan would be set aside for the participants' vested benefits.

Note 7. Income Tax Status

On June 30, 2020, the Internal Revenue Service stated that the customized pre-approved Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code ("Code"). The customized pre-approved Plan has been amended since receiving the opinion letter. The Plan administrator believes that the Plan is designed and being operated in compliance with applicable requirements of the Code.

Note 8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 9. Subsequent Events

The Plan has evaluated subsequent events through October 13, 2025, the date these financial statements were available to be issued.
