## INDEPENDENT AUDITORS' REPORT

To the Trustees

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the financial statements of Virginia Emergency Medicine Associates, Ltd. Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Virginia Emergency Medicine Associates, Ltd. Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audits of the Financial Statements section:

- The amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

## **Basis for Opinion**

## NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024 AND 2023

### 1. DESCRIPTION OF PLAN

The following description of the Virginia Emergency Medicine Associates, Ltd. Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution plan covering all eligible employees of Virginia Emergency Medicine Associates, Ltd. (the Company). Virginia Emergency Medicine Associates, Ltd. is a member of a controlled group, and therefore the Plan also covers employees of Emergency Physicians, PLLC and Fair Oaks Hospitalist Physicians, PLLC. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan was established on July 1, 1988. The Plan was subsequently amended on May 1, 2008, amended and restated on January 1, 2015, amended on April 29, 2015, and amended and restated on January 1, 2021.

Virginia Emergency Medicine Associates, Ltd. has the responsibility for remittance of participant and employer contributions, appointing a committee to administer the Plan, and determining funds available for investment under the Plan. Virginia Emergency Medicine Associates, Ltd. pays for a portion of the administrative expenses for the Plan.

#### **Eligibility Requirements**

All employees are eligible to participate in the Plan except for nonresident aliens receiving no earned income, employees covered by a collective bargaining agreement, leased employees and independent contractors. There is no minimum age or service requirement to participate; employees become eligible on their date of hire.

#### **Contributions**

Each year, participants may elect to contribute a percentage or amount of pre-tax annual compensation, as defined in the Plan. Participants may also make Roth (after-tax) elective deferrals. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions and employer contributions into various investment options offered by the Plan. The Plan currently offers pooled separate accounts, self-directed brokerage accounts and a fully benefit-responsive investment contract as investment options for participants.

The Company may elect to make profit sharing contributions for participants who have completed at least 1,000 hours of service during the year and were employed at year end. Effective January 1, 2015, the Company will also make safe harbor contributions in an amount not less than 3 percent of participants' compensation. There are no eligibility conditions for the safe harbor contributions. The employer may make additional Qualified Nonelective Contributions for the benefit of such non-key participants determined at the discretion of the employer. The Company contributed a discretionary profit sharing contribution to the Plan of \$644,680 and \$614,776 for 2024 and 2023, respectively. Contributions are subject to certain limitations.

#### **Participant Accounts**

Each participant's account is credited with the participant's contribution and allocations of the Company's contribution and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings or individual account balances, or specific participant transactions, as defined in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### **Vesting**

Participants are immediately vested in their contribution, Qualified Nonelective Contribution, and the employer safe harbor contribution plus the actual earnings thereon. Employees are 100 percent vested in the Company's profit-sharing contribution after 1 year of service.

An employee is also 100 percent vested if termination is due to normal retirement, disability or death.

#### **Notes Receivable from Participants**

Participants may borrow up to the lesser of \$50,000 minus the difference between the highest outstanding balance of loans during the prior 12-month period and the outstanding balance of loans from the Plan on the date the loan is made, or 50 percent of the participant's vested account balance.

Loans must be repaid within 5 years. The maturity dates range through October 2027. The loans are secured by the vested balance in the participant's account and bear interest at rates that range from 4.25 percent to 9.50 percent. Principal and interest is paid ratably through payroll deductions. Participants are allowed one loan at a time and the minimum loan amount is \$1,000.

#### **Payment of Benefits**

On termination of service due to death, disability or retirement, a participant will receive the value of the participant's vested interest in his or her account as a lump sum amount. The Plan must pay out as a lump sum any account balance of \$5,000 or less. An account must be fully vested for a participant to receive an in-service withdrawal. Upon attainment of age 59½, a distribution may be made from the salary deferral account provided the participant has not separated from service. Upon attainment of normal retirement age, distributions may be made from pre-tax salary deferral accounts.

#### **Hardship Distributions**

Hardship distributions are permitted from salary deferrals, profit sharing contribution, rollover contribution, and transfer accounts, for accounts that are fully vested.

#### **Forfeited Accounts**

Forfeited balances resulting from the termination of nonvested participants may be applied to restore the balances of employees that have been previously forfeited or used to reduce the Company's future contributions. There was a balance in the forfeiture account of \$1,634 and \$2,433 at December 31, 2024 and 2023, respectively.

For the years ended December 31, 2024 and 2023, approximately \$3,000 and \$-0- of forfeitures were used to offset employer contributions, respectively.

### 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

#### **Basis of Accounting**

The financial statements of the Plan are prepared using the accrual method of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the plan.

#### **Financial Statement Estimates**

The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

#### **Investment Valuation and Income Recognition**

Investments are reported at fair value, except for fully benefit-responsive investment contracts which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing information provided by the investment advisers and custodian. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

As permitted by U.S. generally accepted accounting principles, the Plan uses net asset value (NAV) as a practical expedient to determine the fair value of certain investments, and these investments have not been classified in the fair value hierarchy.

#### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

#### **Payment of Benefits**

Benefits are recorded when paid.

#### **Income Taxes**

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Department of Labor (DOL) or Internal Revenue Service. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses, including certain fees paid through revenue sharing arrangements, are included in net appreciation in fair value of investments.

#### Subsequent Events

The Plan has evaluated subsequent events through October 7, 2025, the date which the financial statements were available to be issued.

### 3. CERTIFIED FINANCIAL INFORMATION

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements as of December 31, 2024 and 2023, the ERISA-required supplemental schedule of Form 5500 - Schedule H, Line 4i - Schedule of Assets (Held at End of Year) as of December 31, 2024, and net appreciation in fair value of investments, interest and dividends and interest income on notes receivable from participants for the years ended December 31, 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Voya Retirement Insurance and Annuity Company, the custodian of the Plan.

### 4. FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) Topic 820, *Fair Value Measurements and Disclosures*, provides a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. Fair value focuses on the price that would be received to sell the asset or paid to transfer the liability regardless of whether an observable liquid market price existed (an exit price). The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

Level 1 – inputs to the valuation methodology are based upon unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in markets that are not active, inputs other than quoted prices that are observable for the asset or liability, and market-corroborated inputs. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – inputs to the valuation methodology are unobservable and significant to the fair value measurement. Level 3 assets and liabilities measured at fair value are based on one or more of three valuation techniques (market, cost, or income approach). The market approach evaluates prices and other relevant information generated by market transactions involving identical or comparable assets or liabilities. The cost approach evaluates the amount that would be required to replace the service capacity of an asset (i.e., replacement cost). The income approach uses techniques that convert future amounts to a single present amount based on market expectations (including present value techniques, option-pricing models, and lattice models).

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for the Plan's assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Self-directed accounts (SDAs):* SDAs include common stocks, mutual funds and corporate bonds. Common stocks traded in active markets on national securities exchanges are valued at the closing price on the last business day of each period presented. Mutual funds in registered investment companies are valued at the NAV of shares held by the Plan at year end. Corporate bonds are valued at the closing price reported on the active market on which the individual securities are traded.

*Pooled separate accounts:* Valued daily at the NAV of the underlying investments at year end. NAV is used as a practical expedient to estimate fair value.

The methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### 5. FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT

The Plan participates in an annuity contract with Voya Retirement Insurance and Annuity Company, which includes a fixed fund offering called the Fixed Account. The Fixed Account is an obligation of Voya Retirement Insurance and Annuity Company's general account, which supports all of the Company's insurance and annuity commitments. The Fixed Account is a traditional investment contract meeting the fully benefit-responsive investment contract criteria and, therefore, is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under the contract, plus interest at a specified rate determined annually by Voya Retirement Insurance and Annuity Company.

Contributions to this account are invested in the general funds of, and are guaranteed by, Voya Retirement Insurance and Annuity Company. There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rates are based on a number of factors, including mortality and expense risks, interest rate guarantees, the investment income earned on invested assets and the amortization of any capital gains and/or losses realized on the sale of invested assets. Certain events, such as the premature termination of a contract, certain transfers from the Fixed Account, or the termination or merger of the Plan, could limit the Plan's ability to transact at contract value with the issuer. The Plan administrator believes that it is not probable that the occurrence of such events would also limit the Plan's ability to transact at contract value with the Plan participants.

Interest is credited daily to amounts held in the Fixed Account at a guaranteed annual rate of no less than 1 percent. Voya Retirement Insurance and Annuity Company guarantees the interest rate for the Fixed Account.

### 7. RELATED PARTY TRANSACTIONS

Voya Retirement Insurance and Annuity Company (Voya) is the Plan's custodian (see Note 3). Plan assets include investments in pooled separate accounts and a fixed account, which are managed by Voya. As Voya is the Plan's custodian, transactions with the custodian qualify as party-in-interest transactions under ERISA. Effective May 10, 2013, Voya provides certain administrative services to the Plan pursuant to an EASE Account between the Plan Sponsor and Voya. Amounts credited to the account maintained by Voya are available to pay reasonable expenses of administering the Plan. Revenue received by Voya that exceeds the amount owed under the agreement is remitted to the Plan's trust on a quarterly basis. Such amounts may be applied to pay Plan administrative expenses or may be allocated to participant accounts. Voya allocates an amount equal to the balance of the account no later than two weeks prior to the end of the Plan year. The unused account balance is allocated to participants with a balance in the Plan on the date of the allocation using a pro rata method. The amount of excess revenue sharing was \$27,750 and \$24,284 for the years ended December 31, 2024 and 2023, respectively. The Plan made direct payments to the third party administrator and to the custodian, which are shown as administrative expenses on the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023. The Plan Sponsor pays directly any other fees related to the Plan's operations.

### 8. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their employer contributions.

### 9. TAX STATUS

The pre-approved plan received an opinion letter dated June 30, 2020, in which the Internal Revenue Service stated that the form of plan stated in that letter is acceptable for use by employers for the benefit of their employees under Internal Revenue Code (IRC) Section 401. The Plan has been amended and restated since receiving the opinion letter. The Plan administrator believes that the Plan is designed and currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related Trust is tax-exempt.

### 10. RISKS AND UNCERTAINTIES

The Plan invests in a combination of investment securities that are exposed to various risks, such as interest rate, market and credit. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statements of changes in net assets available for benefits.
