For information included in the supplementary information that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplementary information, we evaluated whether the supplementary information, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

1. Plan Description

The following brief description of the LandCare 401(k) Retirement Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan was established to provide retirement benefits for the employees of LandCare USA, LLC (the Company) effective May 12, 2011. The Plan was established as a spin-off from the ServiceMaster Profit Sharing and Retirement Plan, when all current and former employees became vested participants. The Plan was amended to grant employees acquired from Palmer's Property Maintenance, LLC, effective June 30, 2018, and Exquisite Grounds & Enhancements, LLC effective February 1, 2020, and Woodland Environment, Inc., Rosborough Partners, Inc., and Pacific Landscapes, Inc., effective October 1, 2020, with service credit for vesting.

Employees, excluding union employees, are eligible to make pre-tax salary deferral contributions. Participants may also receive Qualified Automatic Contribution Arrangement (QACA) safe harbor matching contributions after attaining age 18 and completing 90 days of service, except for leased employees, and non-resident aliens, as defined by the Plan. Eligible employees become participants on the first day of the month following the date the eligibility requirements are satisfied.

Contributions

Each year, participants may make voluntary pre-tax salary deferral contributions between 1% and 75% of annual eligible compensation, in increments of one percentage point, up to the maximum dollar limits allowable by law. Participants may also contribute amounts representing distributions from other qualified plans. Participants are automatically enrolled with an initial 3% salary deferral contribution through a QACA once the eligibility requirements have been met. At any time, a participant can elect not to contribute or may increase or decrease his or her deferral rate to any rate allowed under Plan provisions. On the first day of the Plan year following the completion of 11 months of service, the employee's deferral rate will be increased by one percentage point until it reaches a total of 10% of their eligible compensation. All participants who are eligible to make deferral contributions and who are projected to attain age 50 before the close of the calendar year are eligible to make catch-up contributions. Contributions are subject to certain limitations.

The Company makes QACA safe harbor matching contributions to the Plan equal to 100% of the first 1% of contributions made by each participant, and 50% of contributions greater than 1% up to 6% of each participant's contribution with a maximum of 3.5% of the participant's eligible compensation.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Company QACA safe harbor matching contributions, (b) plan earnings or losses, and (c) an allocation of administrative expenses. The Company's QACA safe harbor matching contributions are allocated among participants based upon each participant's elected salary deferral. Plan earnings or losses are allocated on the basis of actual results of the investments selected by each participant. Investments are maintained in individual member accounts managed by Vanguard Fiduciary Trust Company (Vanguard).

Vesting

Participants are vested immediately in their contributions plus earnings (losses) thereon. Vesting in the Company's QACA safe harbor matching contributions are based on years of service and are 100% vested after two years of service.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant's account and bear interest at rates that are commensurate with the local prevailing rates at the time of issuance. Principal and interest are paid through payroll deductions.

Payment of Benefits

Upon retirement, termination, disability, death, normal retirement at age 65, or attainment of age 59.5 (for certain in-service distributions), the participant or beneficiary, may elect to receive a lump sum amount equal to the value of the vested funds allocated to the participant's account, or in the case of retirement, periodic installments, as defined by the Plan. Upon termination of employment, the Plan requires that distribution payments between \$1,000 and \$5,000 be directly rolled over to an individual retirement designated by the plan administrator in the event the participant does not elect otherwise. Distributions under \$1,000 will be paid out to the participant in the event the participant does not elect a payout option. Participants may also receive in-service and hardship distributions, as permitted in the Plan document. Benefits are recorded when paid.

Forfeitures

Upon a participant's termination of employment before normal retirement, disability or death, the portion of the Company's contributions not then vested shall be forfeited. Forfeitures may be applied to reduce Company contributions or pay administrative expenses. As of December 31, 2024 and 2023, forfeited non-vested accounts totaled \$27,374 and \$37,984, respectively. During 2024 and 2023, the Company utilized forfeitures of \$364,314 and \$254,455, respectively, to reduce Company contributions.

2. Summary of Significant Accounting Policies

A summary of the significant accounting policies consistently applied in the preparation of the accompanying financial statements is set forth below.

Basis of Presentation

The accompanying financial statements have been prepared on the accrual basis and in conformity with accounting principles generally accepted in the United States of America.

Presentation of Participant-Directed Funds

The Plan's presentation of participant-directed investments is in accordance with the Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 962, *Plan Accounting – Defined Contribution Pension Plans*.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Company determines the Plan's valuation policies utilizing information provided by the investment advisors and custodians. See Note 4 for further discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes are reclassified as distributions based upon the terms of the Plan document.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Other

Administrative expenses included in the accompanying financial statements represent advisory, record keeping fees, distribution fees, and participant loan origination fees associated with note receivables from participants. The Company provides certain administrative and accounting services to the Plan at no cost. Audit and legal fees paid directly by the Company are excluded from these financial statements. Certain other investment-related expenses are included in net appreciation in fair value of investments.

Subsequent Events

Subsequent events are events or transactions that occur after the statement of net assets available for benefits date, but before the financial statements are available to be issued and may require potential recognition or disclosure in the financial statements. Management has considered such events or transactions through October 3, 2025, noting no items requiring disclosure.

3. Information Certified by Vanguard

The plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the plan administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the following information certified by Vanguard, except for comparing such information certified by the custodian to information included in the Plan's financial statements and supplementary information.

4. Fair Value Measurements

FASB ASC 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily Net Asset Value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective Trusts: Valued at the NAV of the underlying investments. FASB ASC 820, Fair Value Measurement, allows NAV per share to serve as a practical expedient to estimate the fair value as long as certain requirements are met. It is in the Plan's assessment that this fund meets those requirements, since the participants have the ability to redeem fund at NAV as of the measurement date on a daily basis. There are no unfunded commitments at December 2024 and 2023.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Tax Status

The Plan is qualified as a profit sharing plan under Section 401(a) of the Internal Revenue Code and is exempt from federal income taxation under Section 501(a) of the Internal Revenue Code.

The plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authority. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts. Distributions to participants of the account balances would be made as soon as practicable after the termination date.

7. Related Party Transactions

Certain Plan investments are mutual funds and a collective trust managed by Vanguard. Vanguard is the custodian of the Plan and, therefore, these transactions qualify as party-in-interest transactions.
