### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the accompanying financial statements of Word of Life Defined Contribution Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Word of Life Defined Contribution Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. ### 1. DESCRIPTION OF THE PLAN:

The following description of the Word of Life Defined Contribution Retirement Plan (Plan) provides only general information. Participants should refer to the Summary Plan Description for a more complete description of the Plan's provisions.

#### GENERAL

The Plan is a defined contribution plan covering all employees of Word of Life Fellowship, Inc. (Employer). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Finance Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Employer's Board of Trustees.

#### ELIGIBILITY

Employees who are age 21 or older, have one year of service, as defined in the Plan document, and are covered by the Word of Life pay grade and step classification program or are eligible for Employer-provided health and welfare benefits are eligible to participate. Any Plan participant who loses eligibility in the Employer-provided health and welfare benefits or the Word of Life pay grade and step classification program but remains employed, will retain the option to continue making salary deferral contributions.

Effective January 1, 2024, long-term part-time (LTPT) employees --defined as those working at least 500 hours per year for three consecutive years --must be offered the opportunity to participate in the Plan. The Plan is required to apply dual eligibility: employees must be allowed to participate once they have either (1) completed one year of service under the 1,000-hour rule or (2) completed three consecutive years of at least 500 hours of service.

#### CONTRIBUTIONS

The Plan allows employees to contribute to the Plan with 401(k) salary deferrals. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan.

Effective January 1, 2023, the Employer provides a matching contribution of 50 percent of the employee contribution, up to 6 percent of compensation.

### 1. DESCRIPTION OF THE PLAN, continued:

#### CONTRIBUTIONS, continued

For a Plan year, the Employer may make an additional discretionary contribution to the Plan, on behalf of the eligible Plan participants. Participants will be eligible to receive an allocation of Employer contributions if they complete at least 1,000 hours of service during the Plan year. Participants shall also share in the allocation if they retire, die, or become disabled during the Plan year regardless of the hours of service credited during that year. The Plan creates a separate Employee classification for each individual eligible to participate in the Plan and the discretionary contribution is determined separately for each Employee classification.. The Employer will notify each participant of the contribution to be allocated to his account. The contribution will be allocated as of the last day of the Plan year. No additional discretionary contributions were made to the Plan during the years ended December 31, 2024 and 2023.

Contributions are subject to certain Internal Revenue Service (IRS) limitations.

#### PARTICIPANT ACCOUNTS

Each participant's account is credited with the participant's contribution and allocations of (a) the Employer's contribution and, (b) the Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### VESTING

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the Employer's contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. A participant is 100% vested after three years of credited service, permanent disability or death.

#### PAYMENT OF BENEFITS

On termination of service due to death, disability, retirement, or severance of employment, a participant may elect to receive a lump sum amount equal to the value of the participant's vested interest in his or her account.

For participants dying before retirement, the spouse or beneficiary will be entitled to 100% of the participant's account balance. If the participant is not married at the time of death, or the spouse has consented to a valid waiver of any rights to the death benefit, the death benefit will be paid to any beneficiary that the participant may choose.

For participants dying after retirement but before the entire benefit has been distributed, the remaining portion of the benefit will be distributed at least as rapidly as under the method of distribution being used as of the date of the participant's death.

1. DESCRIPTION OF THE PLAN, continued:

### FORFEITED ACCOUNTS

Upon termination of employment, participants forfeit their nonvested balances. The Employer may elect to use all or any portion of forfeitures to reduce Employer contributions to the Plan. As of December 31, 2024 and 2023, forfeited non-vested accounts totaled \$60 and \$52, respectively, and are included as cash held in forfeiture account. For the years ended December 31, 2024 and 2023, \$2,918 and \$0 forfeitures, respectively, were used to reduce Employer contributions to the Plan.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES:

### BASIS OF ACCOUNTING

The financial statements of the Plan have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America. The significant accounting policies adopted by the Plan are described below.

### USE OF ESTIMATES

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

### INVESTMENT VALUATION AND INCOME RECOGNITION

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Purchases of accumulation units in the custodian's investment portfolio are recorded on the date of contribution. Interest income is recorded on an accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### PAYMENT OF BENEFITS

Benefits are recorded when paid.

### ADMINISTRATIVE EXPENSES

Some fees paid for the administration of the Plan and for the activities of the investment advisor are charged to the participants and deducted from the participants' accounts. The Plan sponsor pays any remaining administrative expenses.

3. INFORMATION CERTIFIED BY THE QUALIFIED INSTITUTION:

The Plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments and interest and dividends for the year ended December 31, 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by John Hancock Life Insurance Company of New York (John Hancock) (the trustee of the Plan).

4. FAIR VALUE MEASUREMENTS:

The *Fair Value Measurements and Disclosure* topic of the Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs are only used when Level 1 or Level 2 inputs are not available.

4. FAIR VALUE MEASUREMENTS, continued:

Fair values for pooled separate accounts are determined by reference to quoted market prices and other relevant information generated by market transactions. Non-benefit responsive guaranteed interest contracts equal the accumulated cash contributions and interest credited to the Plan's contracts, less any withdrawals. Crediting rates are a combination of a monthly "new money" rate applied to regular ongoing contributions made to the account that month and an annually established composite rate. The new money rate applied to contributions received during a reporting period may vary from the composite rate applied to account balances at the end of the prior reporting period.

5. TAX STATUS:

On June 30, 2020, the IRS stated that the volume submitter basic plan document adopted by the Plan, as then designed, qualifies under Internal Revenue Code (IRC) Section 401(a). The Plan has not received a determination letter specific to the Plan itself and it is not required to do so. Although the Plan has been amended since receiving the opinion letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the Internal Revenue Code.

6. PLAN TERMINATION:

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of the Plan's termination, participants would become 100% vested in their employer contributions.

7. RISKS AND UNCERTAINTIES:

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

8. PARTIES-IN-INTEREST TRANSACTIONS:

The Plan investments are funds managed by John Hancock, trustee of the Plan. John Hancock provides services to the Plan and, therefore, all transactions qualify as party-in-interest transactions. Recordkeeping fees of \$44,824 and \$41,552 were paid to John Hancock by the Plan for the years ended December 31, 2024 and 2023, respectively. In addition, \$25,803 and \$20,056 of direct fees were paid to other parties-in-interest for advisory services for the years ended December 31, 2024 and 2023, respectively. Indirect fees are included in net appreciation of fair value of investments.

9. SUBSEQUENT EVENTS:

Subsequent events have been evaluated through October 8, 2025, which represents the date the financial statements were available to be issued. Subsequent events after that date have not been evaluated.
