Note 1 - **Description of Plan:**

The following description of the D. A. Collins Construction Co., Inc. (Company) 401(k) Plan (Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

- (a) **General.** The Plan is a defined contribution plan, which includes a qualified deferred arrangement as described in section 401(k) of the Internal Revenue Code. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The plan is for the benefit of all full-time employees of the Company classified as salaried, hourly clerical or hourly laboratory technician and who have attained the age of 21.
- (b) **Effective date.** The plan became effective on January 1, 1993 and was amended and restated effective as of January 1, 2003 to allow the sponsor to provide a discretionary profit-sharing contribution.
- (c) **Contributions – Employer.** Each year, the Company may contribute an amount by resolution of the Board of Directors. The Company may contribute a discretionary contribution (matching) based on a participant's salary deferred contribution. There were no matching contributions for the years ended December 31, 2024 and 2023. Additional discretionary amounts may be contributed for certain classes of employees at the option of the Company's board of directors. Discretionary contributions amounted to \$397,868 and \$368,096 for the years ended December 31, 2024 and 2023, respectively.
- (d) **Contributions – Employees.** Each year, participants may contribute the lesser of \$23,000 or 100% of annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.
- (e) **Participant's Accounts.** Each participant's account is credited with the participant's salary reduction contribution, the Company's matching and discretionary contributions, plan earnings, charged with an allocation of administrative expenses and realized and unrealized security gains and losses. The benefit to which a participant is entitled is that which can be provided from the participant's account.

Note 1 -

Description of Plan (Continued):

(f) **Vesting.** Participants are immediately vested in their salary reduction and employer discretionary contributions plus actual earnings thereon. Vesting in the employer matching contribution portion of their accounts plus actual earnings thereon is based on continuous service. A participant is 100% vested after six years of credited service.

(g) **Investment Options.** The Plan provides for participant-directed investment programs as it allows participants to choose among various investment alternatives. The available alternatives are comprised of:

The Investment Company of America – seeks to provide long-term growth of capital and income, placing greater emphasis on future dividends than on current income, by principally investing in common stocks.

The Growth Fund of America – seeks to provide long-term growth of capital through a diversified portfolio of common stocks.

American Balanced Fund – seeks to provide conservation of capital, current income, and long-term growth of capital and income by investing in common and preferred stocks, bonds and other fixed-income securities.

EuroPacific Growth Fund – seeks to provide long-term growth of capital by investing in companies based outside the United States.

U. S. Government Securities Fund – seeks to provide a high level of current income and preservation of capital through U. S. Government obligations.

The Bond Fund of America – seeks to provide as high a level of current income as is consistent with preservation of capital.

Fundamental Investors – seeks to provide long-term growth of capital and income primarily through investment in common stock.

Capital Income Builder – seeks to provide above-average current income, a growing stream of income and, secondarily, growth of capital.

American High-Income Trust – seeks to provide a high level of current income, with capital appreciation as a secondary goal.

Capital World Growth and Income Fund – seeks to provide long-term growth of capital with current income by investing in established, growing global companies, including the United States.

American Funds Money Market Fund – seeks to provide a way to earn income on cash reserves while preserving capital and maintaining liquidity.

Target Date Retirement Funds – depending on the proximity to its target date the fund will seek to achieve the following objectives to verifying degrees: growth, income and conservation of capital.

- (h) **Participant Notes Receivable.** Participants may borrow from their accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% (fifty percent) of their vested account balance, whichever is less. Loan terms range up to five years. Terms of loans for the purpose of purchasing a principal residence are determined by the Plan Administrator. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined by the plan administrator. The interest rate for the participant loans range between 4.07% and 7.54%. Principal and interest is paid ratably through payroll deduction.
- (i) **Payment of Benefits.** The Trust shall make or begin distribution of the benefits payable on a participant's (a) retirement after attaining his retirement date, or (b) sustaining total and permanent disability, or (c) death, based upon the balance in such participant's account as of the valuation date coinciding with or immediately preceding the date on which such participant retires, dies or becomes disabled. If a participant terminates his service before retirement date, payment will be made in accord with the plan document based upon the elections available.
- (j) **Forfeitures.** When certain terminations of participation in the Plan occur, the nonvested portion of the participant's account, as defined by the Plan, represents a forfeiture. Forfeitures are utilized to reduce the sponsor contributions for the plan year.

Note 2 - **Summary of Accounting Policies:**

- (a) **Basis of Accounting.** The financial statements of the Plan are prepared under the accrual method of accounting.
- (b) **Investment Valuation and Income Recognition.** Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See note 4 for discussion of fair value measurements.
- Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the plan's gains and losses on investments bought and sold as well as held during the year.
- (c) **Participant Notes Receivable.** Notes receivable from participants are measured at their unpaid principal balance. Delinquent notes receivable from participants are recorded as a distribution based upon the terms of the plan document.
- (d) **Payment of Benefits.** Benefits are recorded when paid.
- (e) **Use of Estimates.** Management uses estimates and assumptions in preparing these financial statements in accordance with accounting principals generally accepted in the United States of America. These estimates and assumptions affect the reported amounts of assets and liabilities, and changes therein, the disclosure of contingent assets and liabilities, and the reported revenues and expenses. Actual results could differ from those estimates.
- (f) **Subsequent Events.** The Plan evaluated its December 31, 2024 financial statements for subsequent events through October 7, 2025, which is the date the financial statements were available to be issued, and noted no events occurring subsequent to December 31, 2024 and through the date of our evaluation requiring accrual or disclosure in these financial statements.

Note 3 - **Investments:**

During 2024 and 2023, the Plan's investments (including gains and losses on investments bought and sold, as well as held during the year) appreciated in value by \$2,479,476 and \$3,164,665 respectively.

Note 4 - **Fair Value Measurements:**

FASB ASC 820, Fair Value Measurement and Disclosures, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by the observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Note 4 - **Fair Value Measurements (Continued):**

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Self-directed accounts: Accounts consist of mutual funds; valued at the quoted net asset value (NAV) of shares held by the plan at year end.

The preceding methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Plan's investments are reported at fair value in the accompanying statement of financial position.

Note 8 - **Risk and Uncertainties:**

The Plan maintains various investments. Investment securities are exposed to various risks, such as interest rate risk, financial market risk and credit risk. Due to the level of the risk associated with investment securities, it is at least reasonably possible that changes in the values of the investment securities will occur in the near term and that such changes could materially affect the investment account balances and the amounts reported in the Plan's financial statements as of December 31, 2024.

Note 9 - **Plan Termination:**

Although it has not expressed any intent to do so, the company has the right under the plan to discontinue its contributions at any time and to terminate the plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100 percent vested in the company contribution portion of their account.
