INDEPENDENT AUDITORS' REPORT

To the Trustees
Mutual Materials Company Savings Plan
Bellevue, Washington

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Mutual Materials Company Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Mutual Materials Company Savings Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note D to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Mutual Materials Company Savings Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Mutual Material Company Savings Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that,

individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of Mutual Material Company Savings Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Mutual Material Company Saving Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter—Supplemental Schedules Required by ERISA

The supplemental schedules of Schedule H, Line 4i – Schedule of Assets (Held at End of Year) as of December 31, 2024 and Schedule H, Line 4a - Schedule of Delinquent Participant Contributions for the year ended December 31, 2024 are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial

statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTE A.-- DESCRIPTION OF PLAN

The following description of Mutual Materials Company Savings Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Plan is a 401(k) defined contribution plan originally established by the Company effective January 1, 1984, covering substantially all employees of Mutual Materials Company (the "Company") and as of January 1, 2018 participating employer, Kanta Products. Effective January 1, 2023 Kanta Products is no longer operating as a separate entity. Employees of the participating employer shall continue to participate in the Plan. Eligible employees are those who have completed at least 500 hours of service during a 6-consecutive-month period and have reached age 18 excluding non-resident aliens, residents of Puerto Rico, certain contract individuals and Teamsters Local Unions 117, 58 and 162. The entry date is the first day of the quarter following the completion of eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). Effective January 1, 2022, the Plan was amended and restated for the Cycle 3 restatement period. Effective August 1, 2023 hardship distributions were expanded to allow distributions from the participant's rollover account and earnings of elective deferrals. Effective December 1, 2023 the Plan was amended to remove the safe-harbor matching contribution and implement a non-safe-harbor matching contribution with fully discretionary formula. The Plan was amended June 4, 2024 to allow participant loans effective October 1, 2024. See Note K.

Contributions: The Plan is a contributory plan which allows for Company safe harbor matching contributions (through November 30, 2023), discretionary non-elective contributions and participant elective deferrals. Effective December 1, 2023 the Company suspended the safe-harbor matching contributions and added a discretionary employer match. Participants may contribute on a pre-tax or Roth basis up to the maximum amount allowed by law. Eligible participants are automatically enrolled in the Plan with a deferral amount of 3% of their eligible compensation. Participants may also contribute amounts representing distributions from other qualified retirement plans. Participants attaining age 50 prior to the end of the calendar year may make "catch-up contributions" in addition to regular salary deferrals. The Company discretionary matching contribution is equal to 100% of elective deferrals up to 4% of eligible compensation. Contributions are subject to certain limitations. The Company made discretionary matching contributions from July 1, 2024 to December 31, 2024.

Participant Accounts: Each participant's account is credited with the participant's contribution, allocation of any Company contributions, Plan earnings (losses) and charged with certain administrative expenses. Allocations are based on participant compensation, account balances, or specific participant transactions, as applicable as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the vested portion of the participant's account.

Vesting: Participants are immediately vested in their elective deferrals, safe harbor matching contributions, and rollover contributions plus actual earnings thereon. Vesting in employer discretionary contributions made prior to the implementation of the safe-harbor match is based on a four year vesting schedule, at a rate of 25% per year, in which the participant is 100% vested after four years of service. Effective December 1, 2023, participants are immediately are immediately vesting in employer matching contributions.

Notes Receivable from Participants: Effective October 1, 2024, Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are issued by the Plan and secured by the balances in the participant's account. A participant may have one loan outstanding at a time unless one loan is a principal residence loan with a repayment period greater than five years. All loans must be repaid within a period of five years, unless the loan is used to purchase a principal residence, in which case, the loan must be repaid within ten years. Under the terms of the Plan agreement, plan loans are to bear a rate of interest based on rates available for similar loans from commercial lending institutions. Principal and interest are paid through payroll deductions.

Retirement: The normal retirement date is the first day of the month following the date a participant attains age 65. Early retirement may be taken on the first day of the month after reaching age 55 provided the participant has separated from service with the employer. Benefits must begin April 1 following the calendar year in which the participant attains age 70-1/2, regardless of whether or not employment has been terminated.

Payment of Benefits: Upon termination of service including due to death, disability or retirement, if a participant's account exceeds \$5,000, (\$7,000 effective January 1, 2024) the participant may elect to receive a lump sum amount equal to the value of the vested interest in his or her account, installments over a period of not more than assumed life expectancy, or partial withdrawals of at least \$1,000. If, on termination of service, a participant has a vested interest in his account which is \$5,000 or less, (\$7,000 effective January 1, 2024) without other election, he shall receive a lump sum equal to the value of his account without consent. In service distributions at age 59 1/2, qualified reservist and hardship distributions are allowed in accordance with the provisions of the Plan.

Forfeitures: Forfeitures are the non-vested portion of a participant's account that are lost upon termination of employment. Forfeitures are retained in the Plan and will be first used to pay Plan administrative expenses, with any remaining amount used to reduce Company contributions. The balance of unused non-vested account balances forfeited into the Plan at December 31, 2024 and 2023, was \$618 and \$0, respectively. For the year ended December 31, 2024, the Plan used \$90 to reduce employer contributions from forfeited non-vested accounts.

Investment Options: Participants direct their contributions and account balances in investment options with The Standard Insurance Company. The Plan Sponsor periodically reviews the investment fund options available to participants and changes them as warranted. Participants may change their investments at any time.

Plan Expenses: Expenses of maintaining the Plan may be paid by the Company or the Plan. Certain Plan administration expenses are paid for directly by the Company and are excluded from these financial statements. Investment related expenses including 12(b)1 revenue sharing fees are deducted from fund earnings to arrive at net appreciation (depreciation) in fair value of investments. Administrative expenses may be paid with 12(b)1 revenue sharing fees. Certain fees such as for distributions are charged directly to the participant's account and are included in administrative expenses.

NOTE B.-- SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting: The financial statements of the Plan are prepared on the accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Use of Estimates: The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires Plan management to make estimates and assumptions that affect the financial statements and accompanying disclosures. Accordingly, actual results could differ from those estimates.

Investment Valuation and Income Recognition: The Plan's investments are reported at fair value, (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note E for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes dividends and the Plan's gains and losses on investments bought and sold, as well as held during the year.

Notes Receivable from Participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and expensed when they are incurred. Delinquent notes receivable from participants are recorded as benefit payments based upon the terms of the Plan document. No allowance for credit losses has been recorded as of December 31, 2024.

Payment of Benefits: Benefits are recorded when paid.

NOTE C.-- INVESTMENT CONTRACT WITH INSURANCE COMPANY

The Plan has entered into a contract with Standard Insurance Company (“Standard”). Standard maintains the investments of the Plan in either pooled separate accounts or in a guaranteed interest contract.

The guaranteed interest contract is a fully benefit-responsive investment contract (FBRIC). As described in Note B, because the guaranteed interest contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed interest contract because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Standard, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The guaranteed interest contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Contract value of the Plan’s investments in the Standard Insurance Company account was \$5,786,328 and \$6,187,114 at December 31, 2024 and 2023, respectively.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer but may not be less than 3%. Such interest rates are reviewed on a monthly basis for resetting.

The Plan’s ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on third-party issuer’s ability to meet its financial obligations. The issuer’s ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events limit the ability of the Plan to transact at contract value with The Standard. Such events include termination of the contract, spin-offs, divestitures, layoffs, corporate relocation, partial or total plan termination, retirement incentive programs, and the liberalization of plan withdrawal or transfer rules. Upon occurrence of any of these events, a market value adjustment may apply. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with The Standard and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from the contract value.

Standard may terminate the contract with 30 days' advance written notice to the contract owner for reasonable cause, which includes the contract owner's failure to abide by state or Federal law, failure to render performance necessary to comply with the terms of the contract, failure to maintain assets of at least \$25,000, Plan disqualification, and failure to adopt the Plan in a reasonable period of time. Upon termination by Standard, a market value adjustment may apply.

NOTE D.-- CERTIFIED INFORMATION

Certain information related to investments disclosed in the accompanying financial statements and ERISA required supplemental schedules, including investments held at December 31, 2024 and 2023, and net appreciation (depreciation) in fair value of investments and interest on fully-benefit responsive investment for the year ended December 31, 2024 was obtained by management and agreed to or derived from information certified as complete and accurate by Standard Insurance Company (the custodian of the Plan).

Notes receivable from participants as of December 31, 2024 and related interest income on notes receivable from participants for the year ended December 31, 2024 are not certified.

NOTE E.-- FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3).

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Pooled Separate Accounts: The fair value of participation units in the pooled separate accounts is determined by Standard Insurance Company (The Standard) based on the valuation of the underlying investments at the end of the year. NAV per unit is used as a practical expedient for measuring fair value. Participant transactions (purchases and sales) may occur daily. Participants eligible to receive benefit payments may withdraw the value of their pooled separate accounts, in whole or in part, at any time without penalty.

There are no participant redemption restrictions for these investments. However, if the Company terminates the group annuity contract with The Standard, redemption restrictions may apply to the pooled separate accounts. Valuation is daily.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE G.-- PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right to terminate the Plan at any time by resolution of its Board of Directors subject to the provisions of ERISA. In the event of Plan termination, the respective accounts of the participants under the Plan shall become fully vested and non-forfeitable.

NOTE H.-- TAX STATUS

Effective January 1, 2022 the Plan was amended and restated and adopted a non-standardized pre-approved profit sharing/money purchase with CODA plan, which received a favorable opinion letter from the IRS on June 30, 2020, which stated that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code.

Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination.

The plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax period in progress.

NOTE I.-- RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

NOTE J.-- NONEXEMPT TRANSACTIONS

Late Remittances

As reported on the supplemental Schedule H, Line 4a - Schedule of Delinquent Participant Contributions, certain Plan contributions of \$259,751 were not remitted to the trust within the time frame specified by the Department of Labor's Regulation 29 CFR 2510.3-102, thus constituting nonexempt transactions between the Plan and the Company for the year ended December 31, 2024. The Company will make contributions to the affected participants' accounts for excise tax and to compensate for potential lost earnings resulting from the delay in contributions for the nonexempt transactions during 2025.

NOTE K.--SUBSEQUENT EVENTS

Effective January 1, 2025, the Plan adopted a provision to allow an increase in catch-up contributions. Participants aged 50 and over are allowed to contribute an additional \$7,500 beyond the standard limit. A "super" catch-up contribution of \$11,250 is available for participants aged 60 to 63 years old.

Effective January 1, 2025, the Plan adopted a provision to allow long-term part-time (LTPT) employees to participate in the Plan by making elective deferrals. The LTPT employees must have worked two consecutive years with 500-999 hours of service beginning in 2021. Employees must also be at least age 21 and have never worked more than 1,000 hours of service in a year. LTPT employees are not eligible to receive any Employer contributions.

Plan management has evaluated subsequent events through October 10, 2025, the date the financial statements were available to be issued.
