Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Boulder Community Health 403(b) Plan (the Plan), an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the "Auditor's Responsibilities for the Audit of the Financial Statements" section:

Note 1: Description of the Plan

The following description of Boulder Community Health 403(b) Plan (the Plan) provides only general information. Participants should refer to the Volume Submitter document and *Summary Plan Description*, which are available from the Plan Administrator, for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan sponsored by Boulder Community Health (the Hospital) for the benefit of all of its employees. An employee is eligible to become a participant in the Plan on the first day of employment. Upon the completion of 12 months of service, a participant is eligible to share in employer matching contributions, and upon the completion of one eligibility year of service, as defined, a participant is eligible to share in employer discretionary contributions, if any. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA).

Principal Trust Company (Principal) is the trustee of the Plan and serves as a plan record keeper, custodian and issuer of the Principal Fixed Income Guaranteed Option group annuity contract (see Note 6). Principal Life Insurance Company serves as the custodian and issuer of the Principal Pension Builder fund (see Note 3).

Contributions

The Plan permits employees through a salary deferral election to have the Hospital make annual contributions of up to 100% of eligible compensation. Employee rollover and catch-up contributions are also permitted. The Hospital makes matching contributions of 100% of employees' salary deferral amounts up to 3% of the participant's eligible compensation. Additionally, unless otherwise determined by the Hospital, discretionary contributions are made by the Hospital to plan participants based on a participant's years of service. A contribution percentage of 2% of the participant's eligible compensation is given to participants with less than six years of service and a contribution percentage of 3% of the participant's eligible compensation is given to participants with six or more years of service. For 2024 and 2023, the Hospital made discretionary contributions to the Plan following this schedule. Contributions are subject to certain limitations. Roth deferrals are also permitted.

A contract exchange represents the transfer of a participant's interest in a 403(b) contract with a vendor previously allowed by the Plan to the 403(b) contract in place with the current vendor. Effective January 1, 2012, Principal is the only vendor approved to receive contributions or contract exchanges. 403(b) contracts issued by certain unapproved vendors prior to January 1, 2005 are not approved to receive contributions or contract exchanges subsequent to December 31, 2004. These 403(b) contracts are not subject to the final 403(b) regulations and are thus excluded from the Plan.

The Hospital will make additional contributions to participants who are age 50 or older and have 15 or more years of continuous service as of September 30, 2017, in an amount equal to 4% of compensation for the payroll period for each person who is an active participant at any time during that period.

Participant Investment Account Options

Investment account options available include various mutual funds, a pension builder insurance contract, and a guaranteed investment contract. Each participant has the option of directing his or her contributions into any of the separate investment accounts or may choose a lifestyle investment strategy option (conservative, moderate, aggressive, etc.), whereby his or her contributions are allocated, accordingly, to the various separate investment accounts offered under the Plan. Participants may change their investment allocation daily; however, for certain investment accounts, in an effort to reduce market timing and excessive trading, certain restrictions may apply.

The Plan also includes an automatic deferral feature whereby a participant who was hired on or after January 1, 2014 is treated as electing to defer 6% of eligible compensation unless the participant made an affirmative election otherwise.

Participant Accounts

Each participant's account is credited with the participant's contributions, the Hospital's matching contribution and discretionary contribution, if any, and plan earnings. An individual participant's account is charged a fee for obtaining a participant loan, including ongoing maintenance of the loan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their voluntary contributions plus earnings thereon. Effective October 1, 2017, a participant is fully vested in employer contributions after three years of continuous service. For participants hired prior to October 1, 2017, matching contributions are 100% vested. The Hospital may elect to make a discretionary contribution to participants of the Plan based on years of continuous service. The non-vested balance is forfeited upon termination of service.

Participants are also immediately vested in matching and discretionary employer contributions for participants who experience an Outsourcing Event, on the date such an Outsourcing Event occurs. For this purpose, an "Outsourcing Event" means an event whereby the Hospital terminates the employment of multiple participants who will continue providing services to the Hospital as employees of a different employer.

Payment of Benefits

Upon termination of service, an employee may elect to receive either a full or partial distribution equal to the value of his or her account or may elect to maintain the account in the Plan and continue to share in investment gains and losses. The Plan permits involuntary cash-out distributions of \$5,000 or less, with distributions between \$1,000 and \$5,000 being rolled into an individual retirement account, and with distributions under \$1,000 being distributed in a lump sum.

Participants may withdraw amounts from their accounts subject to certain limitations imposed by the Plan.

Forfeited Accounts

At December 31, 2024 and 2023, unutilized remaining forfeited nonvested accounts totaled \$7,664 and \$542, respectively. These accounts will be used to reduce future employer contributions or pay plan expenses. In 2024 and 2023, employer contributions were reduced by \$563,875 and \$403,029, respectively, from forfeited nonvested accounts. Prior to October 1, 2017, participant and employer contributions were immediately fully vested.

Notes Receivable from Participants

The Plan Document includes provisions authorizing loans from the Plan to active eligible participants. Loans are made to any eligible participant. The minimum amount of a loan shall be \$1,000. The maximum amount of a participant's loan is determined by the available loan balance restricted to the lesser of \$50,000 or 50% of the participant's vested account balance. All loans are covered by demand notes and are repayable over a period not to exceed five years (except for loans for the purchase of a principal residence, which are repayable over a period not to exceed 10 years) through payroll withholdings unless the participant is paying the loan in full. Interest on the loans is based on local prevailing rates as determined by the Plan Administrator.

The Plan allows participants to continue repayment of outstanding plan loans after having a severance from employment.

Plan Termination

Although it has not expressed an intention to do so, the Hospital has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes in net assets available for benefits and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Quoted market prices, if available, are used to value investments. Mutual funds are valued at the net asset value (NAV) of the shares held by the Plan at year-end.

Fully benefit-responsive investment contracts are valued at contract value. Contract value represents contributions made under the contract, plus interest at the contract rate, less participant withdrawals and administration expenses.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought, sold and held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

Plan Tax Status

The Plan operates under a volume submitter agreement in connection with a volume submitter plan and trust document sponsored by Principal Life Insurance Company. This volume submitter plan document has obtained an advisory letter from the IRS stating that the volume submitter satisfies the requirements under Section 403(b) of the Internal Revenue Code (IRC). Although the Plan has been amended since the volume submitter plan document received the advisory letter, the Plan Administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and, therefore, the Plan is qualified.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Administrative Expenses

Administrative expenses may be paid by the Hospital or the Plan at the Hospital's discretion.

Note 3: Certification of Plan Trustee and Custodian

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company and Principal Life Insurance Company, the trustees of the Principal Pension Builder fund, both qualified institutions, have certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits and related disclosures as of December 31, 2024 and 2023.
- Net investment income and interest income from notes receivable from participants as shown in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023.
- Investment information included in the accompanying schedule of assets held at year-end as of December 31, 2024.

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such investment information to the related information included in the financial statements and ERISA-required supplemental schedule.

Note 4: Party-in-Interest Transactions

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association, or relatives of such persons.

The Plan's investment contract with Principal is held in the general account and is managed by Principal. During 2024 and 2023, the Plan invested in certain mutual funds managed by Principal.

The Plan is charged fees and expenses through expense ratios charged by the issuers of the Plan's various investment options. The investment expense ratios vary by fund and are reflected in the value of the investments held by the Plan. The investment expense ratios include, as applicable, management expenses, administration expenses, 12b-1 fees, record keeping and distribution fees, sub-transfer agency fees and shareholder servicing fees. A portion of these fees is paid by the various funds to Principal in 2024 and 2023 and the fees earned by Principal vary by fund. Additionally, a portion of these fees is paid by Principal to the Plan's investment advisor. During 2024 and 2023, fees withheld from individual participant accounts and paid to Principal totaled \$416,730 and \$348,613, respectively.

The Hospital pays certain of these expenses and accounting and auditing fees relating to the Plan and performs certain administrative functions at no cost to the Plan.

Note 5: Fair Value of Plan Assets

Fair value is the price that would be received to sell an asset in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. There is a hierarchy of three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets
- Level 3** Unobservable inputs that are supported by little or no market activity and that are significant to the fair value of the assets

Investments

Where quoted market prices are available in an active market, securities are classified within Level 1 of the valuation hierarchy. Level 1 securities include mutual funds. If quoted market prices are not available, then fair values are estimated by using pricing models, quoted prices of securities with similar characteristics or discounted cash flows. The Plan holds no Level 2 securities. In certain cases where Level 1 or Level 2 inputs are not available, securities are classified within Level 3 of the hierarchy. The Plan holds no Level 3 securities.

Note 6: Investment Contract with Principal

In 2012, the Plan entered into a fully benefit-responsive investment contract with Principal. Principal maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate guaranteed to the Plan.

As described in the basis of accounting disclosure, because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. Contract value, as reported to the Plan by Principal, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against the contract value for credit risk of the contract issuer or otherwise.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Hospital or other Hospital events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The plan administrator does not believe the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable.

The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

Note 7: Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.
