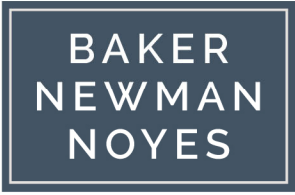

INDEPENDENT AUDITORS' REPORT

The Plan Administrator and Participants
NEPW Logistics Inc. 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the NEPW Logistics Inc. 401(k) Plan (the Plan), an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements (financial statements).

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the years then ended, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. 1. Description of Plan

The following brief description of the NEPW Logistics Inc. 401(k) Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all full-time employees of NEPW Logistics Inc. (the Company). The Plan uses a non-standardized pre-approved basic plan document sponsored by Downeast Pension Services, Inc. (Downeast). Employees are eligible to participate in the Plan after completion of 6 consecutive months from date of employment and 500 hours of service. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA).

The SECURE 2.0 ACT expanded eligibility for certain long-term part-time (LTPT) employees. Effective January 1, 2024, part-time employees who have completed at least 500 hours of service in the three most recent consecutive years (2021 – 2023) are eligible to participate in the plan. Effective January 1, 2025, the requirement is being reduced from three to the two most recent consecutive years (2023 – 2024).

Contributions

Participants may elect to contribute pre-tax dollars or post-tax Roth contributions up to the Internal Revenue Service maximum allowable amount. At the participant's option, contributions may be invested in any of the available investment options.

The Plan features an automatic enrollment provision. All employees who become eligible subsequent to September 1, 2019 are automatically enrolled in the Plan and 4% of eligible compensation is deferred, unless the participant specifically elects another amount or opts out of the Plan.

The Company provides a safe harbor matching contribution of 100% of the first 4% of compensation.

Rollover Accounts

Employees may rollover into the Plan assets distributed as vested interest upon their termination from a qualified defined benefit plan or a qualified defined contribution plan in which they were formerly participants on or before the sixtieth day after the day that they received the distributions.

Investment Options

Participants may elect to invest their contributions in any of the Plan's available investment options. The options consist of various mutual funds as well as a collective trust fund. Participants should refer to the prospectus of each investment for further information. Employer contributions are invested in the same manner as the corresponding employee contributions.

1. **Description of Plan (Continued)**

Benefits

The Plan provides benefits to participants upon death, disability, retirement or termination of employment. Benefits will be paid to the participant in a lump-sum payment or by transfer to another qualifying plan.

Participants are permitted to take in-service distributions upon attaining the age of 59 ½.

Participants are permitted to make hardship withdrawals from their accounts, provided they meet certain criteria and the withdrawals are approved by the Plan Administrator.

Vesting

Participants are immediately vested in their voluntary contributions and rollover accounts, as well as employer safe harbor contributions.

Participant Accounts

Each participant's account is credited with the participant's contributions, the Company's matching contributions, an allocation of Plan earnings and an allocation of administrative expenses. Plan earnings are allocated based upon participant account balances. Administrative expenses are allocated to participant accounts based on the participant's relative account balances.

Notes Receivable from Participants

Participants may also elect to borrow funds against their accounts. Loans made to a participant cannot exceed the lesser of (a) \$50,000 or (b) 50% of the participant's vested account balance. A participant may not request a loan of less than \$1,000 and may not have more than two outstanding loans at one time. No loan shall be for a term exceeding 5 years, unless the loan proceeds are used to acquire a primary residence. The loans are secured by the balance in the participant's account and bear an interest rate of prime plus 2% at the date the loan is issued.

Termination of the Plan

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

2. **Summary of Significant Accounting Policies**

Basis of Presentation

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting.

2. Summary of Significant Accounting Policies (Continued)

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of net assets available for benefits at the date of the financial statements and the reported amounts of changes in net assets available for benefits during the reporting period. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value, including the collective fund as of December 31, 2024 (see note 5 for further fair value information). As of December 31, 2023, investment in the collective fund was stated at fair value based on net asset value (NAV). NAV had been determined based on the unit value of the trust. Unit value was determined by dividing the fund's net assets based on the fair value of the underlying investments by its units outstanding at each valuation date. Certain employer-initiated events may have reduced the reported value of the investment in the collective trust. These events included discontinued operations, layoffs, Plan termination, bankruptcy or reorganization, merger, early retirement incentive programs, tax disqualification of the Plan or other events. Such events are not expected to be probable to occur.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Risks and Uncertainties

The Plan provides for various investment options which in turn invest in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Contributions

Contributions from participants are recorded in the period in which payroll deductions are made. Employer matching contributions are recorded in the same period as the corresponding participant contributions.

Notes Receivable from Participants

Notes receivable are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are classified as distributions based upon the terms of the Plan's loan policy. As of December 31, 2024, the interest rate on outstanding participant loans ranged from 5.25% to 10.50%. Principal and interest is paid ratably through payroll deductions.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Administrative expenses are charged against the accounts of the participants to the extent they are not paid by the Company.

Subsequent Events

Events occurring after the statement of net assets available for benefits date are evaluated by management to determine whether such events should be recognized or disclosed in the financial statements. Management has evaluated subsequent events through September 12, 2025, which is the date the financial statements were available to be issued.

3. **Tax Status**

The Plan is a non-standardized pre-approved plan sponsored by Downeast for which the IRS has issued a favorable opinion letter, dated June 30, 2020. The Plan has been amended subsequent to the date of the opinion letter and the Plan Administrator believes the Plan is designed and being operated in compliance with the applicable requirements of the Internal Revenue Code (the Code).

U.S. GAAP require plan management to evaluate tax positions taken by a plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that, more likely than not, would not be sustained upon examination by the IRS. The Plan Administrator has evaluated the Plan's tax positions and concluded that the Plan had maintained its tax-exempt status and had taken no material uncertain tax positions that require adjustment to the financial statements. Therefore, no provision or liability for income taxes has been included in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations by the U.S. federal, state or local tax authorities for years before 2021.

4. **Related Party Transactions**

The Plan is responsible for administrative fees to the extent they are not paid by the Plan Sponsor. Administrative fees consist of amounts paid to the third-party administrator for various administrative services. These transactions qualify as party-in-interest transactions. Various Plan investments are in Vanguard Mutual Funds, which qualify as party-in-interest, as Vanguard serves as Plan recordkeeper. Vanguard has retained Ascensus Inc., to provide these services on their behalf. Additionally, fees paid by the Plan for investment management services are paid indirectly by Plan participants as a reduction of the return earned on each fund. Notes receivable from participants also qualify as party-in-interest transactions.

5. **Investments, Information Certified by Trustee and Fair Value Measurements**

Information Certified by Trustee

The Plan Administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the United States Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the information certified by Ascensus Inc., as agent for Ascensus Trust Company, custodian of the Plan (the Custodian), as of and for the years ended December 31, 2024 and 2023, except for comparing such information certified by the custodian to information included in the Plan's financial statements and supplemental schedule.

The Plan Administrator has determined that the custodian meets the requirements of a qualified institution as defined by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. The Plan Administrator has obtained certifications from the custodian stating that the information provided to the Plan Administrator by the custodian is complete and accurate. The Plan's investments, related income and investment transactions, including net appreciation in fair value of investments, notes receivable from participants and the interest associated with the notes receivable were certified by the Plan's custodian.

Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023, with the exception of the collective trust fund no longer being valued at the net asset value per share practical expedient.

Mutual funds: Valued at the closing price reported in the active market in which the security is traded.

Collective trust fund: As of December 31, 2024, the collective trust fund was valued at the closing price reported in the active market in which the security is traded. As of December 31, 2023, the units of the collective trust fund were valued using the net asset value practical expedient as determined by the issuer based on the current fair values of the underlying assets of the fund.

In accordance with Accounting Standards Update 2015-07, certain investments that are measured at fair value using the net asset value per share (or its equivalent) practical expedient have not been classified in the fair value hierarchy. Therefore, there was no hierarchy required for the collective trust fund held by the Plan totaling \$705,690 at December 31, 2023.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
