**NOTE A | DESCRIPTION OF THE PLAN**

The following description of the Christopher Rural Health Planning Corporation Retirement Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

*1. General*

Christopher Rural Health Planning Corporation (the Corporation, Employer or Plan Sponsor) established the Christopher Rural Health Planning Corporation Retirement Plan effective as of July 1, 2008. The plan is a defined contribution plan covering all eligible employees of the Corporation. Employees become eligible for the plan upon being hired. The plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

*2. Contributions*

Each year, participants may elect to defer a portion of their pre-tax annual compensation as defined by the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the allocation of their contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 2 percent of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. The Corporation may elect to match 2% of covered compensation not to exceed \$5,000 annually for eligible participants. The Corporation's matching contributions are discretionary.

*3. Participant Accounts*

Each participant's account is credited with the participant's contributions and the Corporation's contribution, as well as Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**NOTE A | DESCRIPTION OF THE PLAN**

4. *Vesting*

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Corporation's discretionary contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. A participant is 50% vested after 2 years but less than 3 years and 100% vested after three years of credited service.

5. *Notes Receivable from Participants*

Participants may borrow from their accounts up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear an interest rate which is commensurate with local prevailing rates as determined quarterly by the plan administrator. Principal and interest is paid ratably through monthly payroll deductions.

6. *Payment of Benefits*

Normal retirement age is 65. Upon termination of service, a participant can elect to receive either a lump-sum or installments equal to the value of the participant's vested interest in his or her account.

7. *Forfeited Accounts*

The balance of non-vested forfeitures as of December 31, 2024 and 2023 were \$33,833 and \$88,563, respectively. These accounts are used to pay administrative expenses and offset employer contributions. In 2024, the Plan redeemed \$126,399 of forfeitures which was used to reduce employer contributions.

8. *Plan Termination*

Although it has not expressed an intention to do so, the Corporation has the right under the Plan to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, employees become fully vested in their accounts.

**NOTE B | SUMMARY OF ACCOUNTING POLICIES**

A summary of the significant accounting policies consistently applied in the preparation of the accompanying financial statements follows.

*1. Basis of Accounting*

The financial statements of the Plan are prepared on the accrual basis of accounting.

*2. Use of Estimates*

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

*3. Valuation of Investments and Income Recognition*

Investments are reported at fair value (except for the fully-benefit responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

*4. Tax Status*

The Company adopted a non-standardized pre-approved plan document that has received an opinion letter from the Internal Revenue Service dated March 31, 2017, stating the pre-approved plan document was in compliance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan Administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE B | SUMMARY OF ACCOUNTING POLICIES**

*5. Payment of Benefits*

Benefit payments to participants are recognized when paid.

*6. Notes Receivable from Participants*

Notes to participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes to participants are recorded as distributions based upon the terms of the plan document.

*7. Administrative Expenses*

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Corporation. Expenses that are paid by the Corporation are excluded from these financial statements.

*8. Subsequent Events*

Management has evaluated all events and transactions that occurred after December 31, 2024, through October 8, 2025, the issue date of these financial statements.

**NOTE C | RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits. As of the date of this report, the current economic environment has increased the degree of uncertainty.

**NOTE D | FAIR VALUE MEASUREMENTS**

The Plan follows the fair value measurement guidance for financial assets and financial liabilities. The guidance defines fair value, establishes a framework for measuring value and expands disclosure about fair value measurements. In addition, the guidance permits an entity to measure eligible financial instruments and other items at fair value. The plan has not made any fair value elections.

**NOTE D | FAIR VALUE MEASUREMENTS**

Fair value is defined to be the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. A three-level hierarchy has been established for fair value measurements based upon the inputs to the valuation of an asset or liability as follows:

- Level 1 Quoted prices in active markets for identical assets or liabilities
- Level 2 Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities
- Level 3 Unobservable inputs supported by little or no market activity and that are significant to the fair value of the assets or liabilities

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies for assets measured at fair value. There have been no changes in methodologies and significant assumptions used at December 31, 2024 and 2023.

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**NOTE E | GROUP ANNUITY CONTRACT WITH GREAT-WEST LIFE & ANNUITY INSURANCE COMPANY**

The Plan entered into a traditional fully benefit-responsive guaranteed investment contract with Great-West Life & Annuity Insurance Company (Great-West) totaling \$0 for 2024 and \$152,130 for 2023. Great-West maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 1 percent. The crediting rate is reviewed on an annual basis for resetting. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the plan. Contract value, as reported to the Plan by Great-West, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan’s ability to receive amounts due is dependent on the issuer’s ability to meet its financial obligations. The issuer’s ability to meet its contractual obligations may be affected by future economic and regulatory developments.

**NOTE E | GROUP ANNUITY CONTRACT WITH GREAT-WEST LIFE & ANNUITY INSURANCE COMPANY**

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan’s prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan’s investment guidelines, (2) a breach of material obligation under contract, (3) a material misrepresentation, (4) a material amendment to the agreement without the consent of the issuer.
